"Swiss-born Prof. Fritz Zwicky of the California Institute of Technology, said apparently unexplained deaths could be due to people being hit by fast meteors or heavy nucleons in cosmic rays. He added that some faint traces have been found, indicating that the victims were struck by such forces."

PART ONE

Fifteen percent of the U.S. population have now seen some form of unidentified flying object or aerial anomaly (AA), according to the recent nationwide poll conducted by Specialized Research. This statistic has now been tested in several different ways and has proven to be stable and valid. It means that approximately 30,000,000 people have now seen an AA. However, other independent polls have placed the figure somewhat lower, perhaps because only SR included the under-21 age group in its poll.

Since the summer of 1968, Specialized Research has been conducting a poll of 250 Ufologists, testing opinions and attitudes on a wide variety of related subjects. As part of the polling process, control groups (CG) of 250 non-UFO-oriented people were also polled and asked questions identical to, or similar to, those asked the Ufologists. College class groups and audiences at non-UFO lectures in several major cities comprised the CG. Overall, these CGs are very close in education and age to the general field of UFO researchers. Opinions were recorded on Geniac cards anonymously, punched, and sorted mechanically. It was found that each block of 75 cards correlated favorably (almost exactly) with each other block so we feel that 250 participants provide an adequate sampling for our purposes.

Obviously our CG represents a slightly above-average group of well-educated metropolitan liberals (Table 1). The UFO-group was evenly divided politically, with 50% claiming to be liberal and 50% claiming to be conservative. The CG was 85% liberal and 12% conservative.

In future articles we will summarize and compare the CG responses with those from the UFO group. The CG were asked a block of questions which were not included in the main UFO-group poll. Ufologists weren't asked if they had ever seen a UFO, or if they believed the objects might be some secret government project. These questions were asked by the 1966 Gallup Poll and the poll conducted for the UFO project at Colorado University (1968). They were asked of our CG only.

* Part of the sampling used by the Colorado Poll was derived from the files of NICAP, APRO and the USAF so, naturally, those people had already reported sightings.

Responses varied in each poll. Larger samplings were used by both Gallup and Colorado. (For a full summary of the Colorado poll see the Condon Report, Chapter 7, pages 209-239.)

People over age-30 were decidedly disinterested in UFOs. Those under 30 were much more interested and opinionated, and those under 21 displayed the highest interest of all.

One of the numerous surprises in the poll was that the magazine SCIENCE DIGEST was known to and occasionally read by 80% of the CG. The SCIENTIFIC AMERICAN was read by 30%. PLAYBOY was regularly read by 30%. TRUE and SAGA were read by a very small percentage. THE LOOK SPECIAL on UFOs (1966) was seen and read by about 30% of the CG participants.

Psychic Impressions

by R. Leo Sprinkle, Ph.D.

Some UFO reports present claims by persons that they have experienced "loss of time" during UFO sightings. In some cases, UFO observers claim to see UFO occupants and to experience "mental communication" with UFO occupants. Investigation of the personal characteristics of these persons might provide further information which may tend to support or reject these claims of "mental communication" and/or psychic impressions of UFO occupants.

Parapsychologists are aware that their findings (not their methods) are inconsistent with the main body of presently accepted scientific knowledge. The only alternate hypothesis to account for the results is that of fraud (Hansel, 1966). Of course, there are disagreements among authorities about the interpretations of findings, but the results provide sufficient evidence to indicate that unusual subconscious processes are in operation, along with normal psychological processes. The careful reader will be impressed by the scope and significance of results obtained in psychical research (Eisenbud, 1967; Murphy 1961; Rao, 1966; Rhine & Pratt, 1962). Two well-known journals in the U.S.A. are: Journal of American Society of Psychical Research, and Journal of Parapsychology.

It is recognized that the personal characteristics of persons would not prove or disprove their claims about hypnotic and psychic impressions of UFO phenomena. However, it was hypothesized that there might be differences between those persons who claim to experience dreams and other psychic impressions of UFO phenomena and those persons who claim to experience observations of UFOs and communication with UFO occupants.

The present investigation was conducted in an attempt to test this general hypothesis. Further, it was hoped that information could be obtained about vocational interests and personality characteristics of persons who experience psychic impressions of UFO phenomena. This information might shed light on the question of possible relationships between ESP processes and "mental communication" with UFO occupants. Also, it was

hoped that these described psychic impressions might provide information about an important question: what are the possible motives of the UFO occupants?

A questionnaire survey was conducted to obtain information from persons who were interested in describing their psychic impressions of the UFO phenomena. Sixty-three persons participated, including 56 USA citizens, 3 Canadian citizens, 2 English citizens, 1 Norwegian citizen, and a USA citizen living in Hong Kong. Cooperation in publicizing the survey was extended by the following persons and organizations: Mr. and Mrs. L. J. Lorenzen, Aerial Phenomena Research Organization (APRO); Mr. C. Bowen, Flying Saucer Review (FSR); Mrs. Laura Mundo, The Interplanetary Center, and Dr. J. B. Rhine, Foundation for Research on the Nature of Man (FRNM). The National Investigations Committee on Aerial Phenomena (NICAP) rejected the request that

notice of the survey be published. Data were tabulated and submitted to the Computer Center, University of Wyoming, for analysis.

There are several limitations to the study, including the following: the difficulties of obtaining reliable and valid information by a questionnaire survey; the questions about the generalization of results from a small sample of participants; and the influence of personal biases on the part of the investigator. The interpretation of results may be affected by the

ASPECTS OF NON-EVENTS

The contactee syndrome frequently produces a long range sequence of physical and emotional changes which closely parallel the well-known symptoms of chronic alcoholism. In many cases the percipient (UFO contactee) experiences one of two major reactions during the initial contact: 1.) Extreme fear, oftentimes bordering on hysteria. 2.) Complete euphoria.

Hysteria can create temporary paralysis and physiological reactions such as nausea, temporary stomach disorders, headaches, etc.

The euphoric reaction is exactly opposite. In these cases the percipient experiences an acute sense of well-being, or, at minimum, a total lack of volition and control. He or she enjoys the "contact" and looks forward to a recurrence of the same kind of event.

Following contact, one of two emotional responses frequently take place: 1.) Expansion of awareness and perception. 2.) Rapid deterioration of personality.

The euphoric-type experience can sometimes produce a combination of these responses. We have now closely investigated and studied approximately 200 involved percipients. In several cases we were able to isolate potential contactees before their main experiences began. They were kept under constant study through all the stages of initial "contact" and their reactions were carefully recorded and compared. The following information has been derived from those studies.

In the last 20 years scientists began placing a heavy emphasis on research to find a physical basis for schizophrenia. They argued that the schizophrenic is the victim of an "error" in the chemistry of his body, much as the diabetic is. They maintain the nervous or mental disorders are symptoms, but organically there is nothing wrong with the nerves or brains of schizophrenics.

In the early '50s, two leaders in this research, Dr. Abram Hoffer, Director of Psychiatric Research at the Saskatchewan Department of Public Health in Canada, and Dr. Humphry Osmond, Director of the Bureau of Research in Neurology and Psychiatry at the Neuro-Psychiatric Institute at Princeton, discovered that by using massive doses of certain vitamins, they could counteract the chemical "error" in the body that causes

schizophrenia.

Encouraged, they began to use vitamin treatment on other schizophrenics and found that after treating hundreds of patients, three out of every four had responded, with only a small amount that had to be rehospitalized.

SA today is an outgrowth of these experiments, launched at suggestion of Drs. Osmond and Hoffer. The Manhattan and Bronx chapters were started by Joseph R., a professor of Philosophical Psychology at a Bronx college, who is himself an alcoholic schizophrenic, helped through vitamin treatment.

Dr. Donald Kenefick, Director of Research and Professional Affairs at the National Association for Mental Health, 10 Columbus Circle, said:

"The biochemical approach is a growing hope, and at the American Psychiatric Association's convention last week I could see an increasing interest in it. But at the same time if it were 100% effective, it would be enthusiastically promoted by all psychiatrists.

The key word may be "caution," but the list of believers is starting to get more impressive. Dr. Walter C. Alvarez, Emeritus Consultant in Medicine at the Mayo Clinic notes, "What impresses me greatly is that already men are able to tell, after examining a lot of samples of blood or urine sent them by a physician, which are from schizophrenics and which are from normal people. That satisfies me that schizophrenia is associated with abnormal chemicals in the patient's body—chemicals which are injuring his brain, much as an overdose of alcohol would."

The handful of doctors now using vitamins to restore this balance report major success when the vitamins are used along with other, more conventional treatments. One Manhattan psychiatrist reports an 85% recovery among patients who had not responded to other types of treatment. "I've been treating schizophrenics for 30 years," says Dr. Alan Cott, 303 Lexington Ave., "but I've never had the success I'm getting with vitamins."

The "expansion" (1.) percipient gradually develops a higher I. Q. and heightened perceptions in all areas. ESP abilities are frequently enhanced. The unconscious mind seems to release all kinds of hidden data into the conscious mind, sometimes through dreams and sometimes through sudden flashes of acute perception. In a few cases it was noted that visual and auditory acuity was also noticeably affected. These percipients were able to see slightly above the normal visible spectrum and were able to hear sounds in the ultra-sonic range. These changes can occur very suddenly, even within 24 hours after initial contact.

The type 2 percipient may briefly enjoy heightened perceptions but this is usually followed by a slow deterioration of personality. Persons who were fundamentally honest before contact begin to suffer from confabulation. The UFO event dominates their life and they willingly engage in any lie or subterfuge necessary to substantiate their story. Since they are consumed by total belief, they can successfully pass lie detector tests. Specific sensory information is so deeply implanted in their mind that they are able to recite their UFO experiences word-for-word months, or even years, later.

The type 2 percipient (and some type 1's) may develop obsessive-compulsive characteristics and become completely preoccupied with the contact experience. Such individuals devote a large part of their time to spreading the "message" of the UFO occupants even though this may lead to the loss of their jobs and the

eventual disintegration of their family life. They become "space age messiahs" and willingly endure ridicule and hardship in order to advance the "cause".

These characteristics are also found in religious fanatics who, following a vision or profound religious experience, abandon their former way of life to dedicate themselves to "saving souls". The religious fanatic often develops contempt, even hatred, for those who are "unenlightened", and many vile crimes have been committed by fanatics who justified their actions by claiming that they were following orders issued by the "voice of God"; a classic symptom of paranoia.

On the other hand, the true UFO percipient usually ignores ridicule and scepticism, feeling that he knows the truth and that others will eventually learn it also. The UFO buff is, by way of contrast, an obsessive-compulsive personality with paranoid leanings. Unlike the UFO percipient, the buff openly combats scepticism and is an avid publicity-seeker. Very few percipients want or seek personal publicity.

UFO percipients usually suffer mental blackouts, amnesia, and disorientation in time and place. Additional UFO experiences can occur, sometimes on a daily basis, after initial contact. These events usually taper off within a few months, rarely lasting beyond a year. But they can recur again several years later.

I recently heard an old man of right-wing views—a friend of my grandparents'—assert that the current wave of assassinations in America is the work of a secret society called the Illuminati. He said that the Illuminati have existed throughout history, own the international banking cartels, have all been 32nd-degree Masons and were known to Ian Fleming, who portrayed them as SPECTRE in his James Bond books—for which the Illuminati did away with Mr. Fleming. At first, this all seemed like a paranoid delusion to me. Then I read in *The New Yorker* that Allan Chapman, one of Jim Garrison's investigators in the New Orleans probe of the John Kennedy assassination, believes that the Illuminati really exist. The next step in my galloping descent into credulity occurred when I mentioned this subject to a friend who is majoring in Middle Eastern affairs. He told me that the Illuminati were actually of Arabic origin and that their founder was the legendary "old man of the mountains," who used marijuana to work up a murderous frenzy and who fought against both the Crusaders and the orthodox Moslems, adding that their present ruler is the Aga Khan; but, he said, it is now merely a harmless religious order known as Ismailianism.

I then began to wonder seriously about all this. I mentioned it to a friend from Berkeley. He immediately told me that there is a group on campus that calls itself the Illuminati and boasts that it secretly controls international finance and the mass media. Now (if PLAYBOY isn't part of the Illuminati conspiracy), can you tell me: Are the Illuminati part of the Masons? Is Aga

Khan their leader? Do they really own all the banks and TV stations? And who have they killed lately?—R. S., Kansas City, Missouri.

First, your informants have confused three historical entities: the Ismailian sect of Islam, the Hashishim and the Illuminati. The Ismailian sect is almost as old as the Moslem religion and the Aga Khan is, indeed, its leader. In the past, however, its members were persecuted for heresy; and around 1090 its leader, Hassan i Sabbah, the "old man of the mountains," formed a secret inner society within the Ismailian community that became known as Hashishim. This inner group turned on regularly with a marijuana-based concoction (not to "work up a murderous frenzy," as you were told, but to experience religious visions from which they believed they drew their strength). The Hashishim are believed to have lost all fear of death and, for almost three centuries, they fought a successful

battle on two fronts, against both the Christian Crusaders and the orthodox Moslems. The Hashishim were finally crushed completely after the Mongol conquest in the 13th Century.

The Illuminati began in Germany in 1776. Based loosely on the Hashishim, they consisted of an outer circle of religious believers and an inner core of revolutionists, but with a new feature. Their secret teaching then was that all religions are false (including the outer religion of the Illuminati), that all men are equal and that monarchy should be overthrown. As part of their revolutionary conspiracy, the Illuminati attempted to infiltrate and take over the Masons; but they never succeeded. They were crushed by the Bavarian government in 1785.

Ian Fleming never told any of his friends that SPECTRE was based on a real organization. He died of natural causes, suffering a heart attack in the presence of his wife.

The belief that the Illuminati survive in the modern world and are responsible for most of our evils is about the fourth most common form of organized paranoia extant (its three more popular rivals are the Elders of Zion conspiracy, the Jesuit conspiracy and the notion that we have already been invaded by outer space, our governments being in the hands of Martians).

As for the Illuminati of Berkeley, this is a put-on by local anarchists.

Contact is preceded by a long sequence of preparatory events which are so subtle that they are seldom noticed by the potential percipient. In several cases we have traced these back as far as five years before the overt contact finally took place. In a few cases, these events began in childhood even though the percipient was not formally contacted until he or she reached adulthood.

The divorce rate among contactees is very high. Part of the contactee syndrome involves divorcing their present spouse and later remarrying a person presumably selected for them by the "entities". In a number of cases, both parties in the new marriage became convinced that they were actually "space

people" themselves. Outwardly, these people are perfectly normal in all other respects. Their UFO obsession rarely seems to require extensive psychiatric treatment. The UFO "entities" become a part of their everyday lives....a very secret part.

A majority of all UFO percipients are medically sound and not heavy drinkers. In fact, many are teetotalers. Yet chronic alcoholics suffer from many of these same symptoms. After several years of hard drinking there is a distinct deterioration of personality. The hallucinations of delirium tremens are followed by "Korsakoff's psychosis" which results in amnesia and disorientation of time and place. Confabulation becomes a prominent

symptom and fictitious episodes are related, to the extent that the severity of the amnesia may not be at first apparent. The patient becomes impulsive, untruthful and unreliable, and divorce often follows naturally.

The contactee syndrome could be based upon some still undefined form of schizophrenia. The unconscious mind is directly involved and the synapses (memory circuits) of the brain appear to be tampered with in some inexplicable fashion. The percipient's memory is sometimes overloaded with information to account for periods of time which elapsed during the contact experience. Thus, a percipient may have vivid total recall of a sequence of non-events which seemingly took several hours while the actual elapsed time was considerably shorter. Memory of these non-events can include detailed sensory information of smell, touch, etc. This is mental hyperbolism; over-programming of the percipient's mind.

These non-events are often allegorical and may be meant to convey hidden meanings to those capable of properly interpreting the data.

Two techniques are employed by the UFOs. Some percipients are forced to forget their experience by a block which cuts off the memory cells from the conscious mind. Then, as in the case of Betty and Barney Hill, the subconscious may feed

this hidden data upwards thru dreams and nightmares. The only way to circumvent the block is through the skilled use of hypnosis. However, information extracted through hypnosis can not be trusted.

Other percipients have the memory cells of the actual experience altered in some manner and false data replaces the true memory. This false data can take incredible forms. The monsters, flights to other planets, etc. may be remembered with absolute clarity and total conviction. These confabulations seem as real to the witness as his memory of what he had for breakfast that morning.

Fragments of the real experience can remain buried in the unconscious mind. Uninformed psychiatrists and researchers usually make the mistake of merely trying to obtain further confirmation of the remembered experience through hypnosis and they do not try to dig for a deeper, alternate sequence of events.

No contactee event can be accepted on the strength of the percipient's surface memory alone. Paradoxically, total recall of an event may indicate that the event never actually took place. The percipient is able to remember every minute detail because those details were carefully implanted in

Waking Suggestion

by William Burroughs

As I have indicated in *The Invisible Generation*—(published in *The Los Angeles Free Press* and also as a post script to *The Ticket That Exploded*)—a technique for producing events and directing thought on a mass scale is available to anyone with a portable tape recorder or a car to transport recorders. The basis for this technique is waking suggestion first used by doctor John Dent of London who also introduced the apo-morphine treatment for alcoholism and drug addiction.

Waking suggestion as practiced by doctor Dent: The patient is instructed to read aloud from a book while concentrating his attention on what he is reading as if reading to an imaginary person seated in front of him. The doctor stands behind him and repeats at the same voice level the patient is using certain suggestions previously agreed upon between doctor and patient:—('You will be able to sleep' 'You will not relapse into the use of alcohol' ETC)—The patient, since he is reading aloud and his attention is concentrated on what he is reading, does not hear the suggestions consciously and for this reason they take direct effect on his subconscious or reactive mind. *This is not subliminal suggestion.* Subliminal means below the level of conscious sight or hearing. Even if the subject were concentrating all his attention on the source of subliminal sounds or images he would not be able to see or hear anything. Waking suggestion consists of sounds or images which are not consciously registered *since the subjects attention is elsewhere.* If his attention were directed towards the source he would be able to see or hear it immediately. Waking suggestion not subliminal suggestion is the technique used in play back of pre-recorded tapes in the street, cocktail parties, bars, stations, air ports, parks, subways, political rallies, theatre intermissions ETC. People do not consciously hear the taped suggestions because their attention is directed towards something else: crossing street, catching train, listening for plane call, listening to speaker, looking at TV, talking to companions. The volume of the tape is adjusted to street sounds, speech level and so forth. A well constructed suggestion tape will have pre-recorded street sounds or whatever cut in according to location.

Any suggestion tape is made much more effective if it contains contradictory commands. Stop. Go. Wait here. Go there. Come in. Stay out. Be a man. Be a woman. Be white. Be black. Live. Die. Be a human animal. Be a superman. Yes. No. Do it now. Do it later. Be your real self. Be somebody else. Rebell. Submit RIGHT. WRONG. Make a splendid impression. Make an awful impression. Sit down. Stand up. Take your hat off. Put your hat on. Create Destroy. React. Ignore, Live now. Live in the past. Live in the future. Obey the law. Break the law. Be ambitious. Be modest. Accept. Reject. Do more. Do less. Plan ahead. Be spontaneous. Decide for yourself. Listen to others. Talk. SILENCE. Save money. Spend money. Speed up. Slow down. This way. That way. Right. Left. Present. Absent. Open. Closed. Up. Down. Entrance. Exit. IN. OUT.

These commands are constantly being imposed by the environment of modern life. If for example your suggestion tape contains the phrase . . . 'Look at that light in front of you . . . STOP . . . Stay here . . . GO . . . Be over there' . . . and is played back to people waiting at a stop light *they are forced to obey the suggestion you are making.* It's like giving some one a sleeping pill without his knowledge and then suggesting sleep. And any contradictory suggestion at the unconscious level produces a moment of disorientation during which your suggestions take effect. Furthermore contradictory suggestions are an integral function of human metabolism . . . 'Sweat. Stop sweating. Salivate. Stop salivating. Pour adreniline into the blood stream. Counter act adrenaline.' Since contradictory commands are enforced by the environment and by the human body suggestion tapes that contain such commands will have particular force. Insult tapes cut in with contradictory commands are especially effective. All tape recorder tricks are useful: speed up, slow down, overlay, running contradictory commands simultaneously, echo chambers for stations and air ports. Effects are obtained by persistence and exposure by getting as many operators in the street as possible. For wide coverage use a car cutting in your suggestions with popular tunes and street sounds. When playing back insult tapes the operator is well advised to move fast and stay out of his wake.

flannel suits lightly with tear gas. They hit the rush hour recorders on full blast... screams, police whistles, breaking glass, crunch of night sticks, tear gas flapping from their clothes.

Attack in subsequent confusion.

Retire to MOB. Learn Chinese.

Disrupt again. Attack. Disappear. Look away. Ignore. Forget.'

his memory banks. Witnesses of this type may clearly remember extended visits to the "caves of the Deros" or to the splendid cities of some distant planet when actually their bodies never left the spot where the contact occurred. This type of non-event is most common in Irish "fairy" lore, occult records, and religious "miracles".

We can not, of course, exclude the possibility that some percipients may have undergone a genuine physical experience, but our studies indicate that most, if not all, percipients suffered mind tampering rather than a real experience. This led to deterioration of personality, insanity, paranoid schizophrenia and other emotional aberrations.

Non-smokers, teetotalers and vegetarians seem to have a higher rate of contact. LSD users have a very high rate and can reveal all of these symptoms. Metabolic changes can occur after contact.

Doctors working with alcoholics and schizophrenics have discovered that vitamin deficiencies can disturb the oxidative metabolism of the brain. It is possible that a similar chemical imbalance is present in the brains of the UFO percipients.

The contactee syndrome has not been adequately studied by qualified medical researchers. There is no clinical precedent for these manifestations within psychiatry. Yet there seem to be many thousands of "silent contactees" in the U.S. alone. Some of these people have been living in a secret hell for years. We have outlined some of the major symptoms here. An intelligent, properly organized study of these people can give us important insights into the real nature of the overall phenomenon. The stories of the non-events can provide no basis for study. We must examine the people themselves in depth and systematically.

On July 24, 1952, a man who was fishing in the Serchio river, near Vico, Italy, at night, saw a disc hovering nearby for ten minutes. From it, he said, hung a hose-like object that plunged into the water. The disc itself measured an estimated 20 metres in diameter, had five "propeller"-like things in the rear and a dome on top. An orange glow could be seen through slits along the deck.

A man wearing a diving helmet looked at the witness through a window, who, before he could get away, received what he described as "an electric shock" as a ray of light hit him. His strength failed, and it was with difficulty that he looked up to observe the departure of the object in an easterly direction.

Six days later the witness was again fishing at the same spot when a tall, thin man, who spoke Italian with a foreign accent ("rather Scandinavian than American") approached him and asked if he had seen airplanes or flying saucers from this particular spot. The witness said no. The man offered him a long, golden-tipped cigarette. The witness began smoking it, and thought he was about to die as his head reeled. . . . The stranger took the cigarette away and threw it into the river, leaving the witness weak and helpless.

following personal attitudes: I believe the "spacecraft" hypothesis is the best hypothesis to account for the "Unknown" cases of UFO reports; I believe that UFO sightings include, on some occasions, the observation of UFO occupants; I believe that some UFO reports indicate the possibility that hypnotic and ESP phenomena are being used by UFO occupants to observe and communicate with UFO observers.

The results of the completed questionnaires are based upon the self-descriptions of the participants. Male participants claimed an average of 13.8 years of education, female participants claimed an average of 14.3 years of education, with a total claimed average of 14.0 years of education.

About three-fourths of the participants (26 males and 20 females) described themselves as having "some" ability for extra sensory perception (ESP). Only 17 participants (13 males and 4 females) described themselves as having "no" ESP abilities. About one-half of the participants (15 males and 16 females) described themselves as having a high interest in the study of ESP, including participation in scientific investigation or group demonstration of their ESP abilities; 32 participants (24 males and 8 females) described themselves as persons who are not interested in the study of ESP and have not participated in scientific investigations or group demonstrations of their ESP abilities. (CONTINUED OVERLEAF)

Two thirds of the participants (27 males and 15 females) claim to have seen a UFO, while 21 participants (12 males and 9 females) claim they have not seen a UFO. Approximately one-third of the participants (11 males and 12 females) claim to have experienced some kind of communication with UFO occupants, while 40 participants (28 males and 12 females) claim they have not experienced communication with UFO occupants. Of the 42 participants who claim to have seen a UFO, 14 participants (7 males and 7 females) claim to have experienced communication with UFO occupants. Of the 21 participants who claim they have not seen a UFO, 9 participants (4 males and 5 females) claim to have experienced communication with UFO occupants.

THOSE WHO CLAIM TO HAVE EXPERIENCED COMMUNICATION WITH UFO OCCUPANTS.

Most of the participants were willing to describe their impressions of possible motives of UFO occupants. Classification by the investigator indicates that the impressions of participants range between "Hostile", "Alien", "Curious", "Prevenient" and "Nurturant" motives. (If a participant did not specify his or her impression of the motives of UFO occupants, his or her response was classified in the category labeled "Curious".) Of the 40 participants who claim that they have not experienced communication with UFO occupants, 29 participants (23 males and 6 females) describe impressions which suggest a "Curious" motive on the part of the UFO occupants. Of the 23 participants who claim that they experienced communication with UFO occupants, 14 participants (8 males and 6 females) describe impressions which suggest a "Curious" motive on the part of UFO occupants.

MUGGED WHILE WATCHING

FOR UFO'S

THE NATIONAL PUTON PRESS

Harry Bottleworth believed in Unidentified Flying Objects and spent hours watching for them in the sky over his Berylmere, England, home.

But last May 30, Bottleworth was so busy staring into the sky that he didn't see or hear about 16 muggers creep up behind him.

And with his eyes turned to the sky, he was mugged, rolled and beaten within an inch of his life.

Bottleworth, 47, also believed in Santa Claus, Easter Bunny and Guy Fawkes Day as well as in UFO's and he was constantly kidded by his neighbors.

But he remained steadfast to his beliefs and in addition to hanging up his stockings, hunting for Easter baskets and blowing up his house once a year, he spent many hours in his backyard, perched on top of a garbage can and scanning the skies.

"That's what probably brought the muggers," said Constable Bertram G. Martreb. "They had probably staked him out as a victim and waited for him to come out that night.

"He was beaten and all they got for their trouble was an old Captain Midnight decoder button."

Bottleworth also got a \$5,689.98 hospital bill and his only comment was: "I wished I had believed in hospitalization."

Since our control groups were all from densely populated metropolitan areas where known sightings are rare we were puzzled that such a high percentage claimed to have seen UFOs. Spot checks and later tests revealed that most of these witnesses had seen their UFOs while on vacation or while traveling. A very small percentage (about 2.5%) had reported their first sighting to anyone. Those who had subsequent sightings (about 4%) had mentioned them only to their immediate families.

This poll confirmed our earlier conclusion that the majority of all sightings go unreported and unpublished. (See "The Statistical Problem" by J.A. Keel in Palmer's FLYING SAUCERS, Aug. '68.)

In this brief paper, it is not possible to present the statements offered by participants. This investigator can only describe his reaction: I believe the majority of participants are intelligent, well-educated, sincere persons who are interested in and puzzled by their observations and impressions; their observations and impressions indicate that they are participants in strange and mysterious happenings.

The results of this survey indicate that most of the participants believe that they have observed UFO phenomena. If further investigations were conducted and revealed similar findings, then many puzzling questions would face UFO investigators: How do UFO observers obtain these impressions of communication with UFO occupants? If hypnotic and ESP processes are involved, for what purposes are these phenomena used by UFO occupants?

DATA REDUCTION SYSTEM. We are trying to compile a complete index of 1969 UFO sightings using the DRS outlined in ANOMALY #1. If you are not familiar with this system please write for a copy. Response has been enthusiastic but the system must be utilized by everyone in the field if any results are to be obtained. Publishers of UFO journals are asked to add an index of known sightings in their area to each issue. We have already ascertained that January 9, 1969, was a national "flap" date. Ironically, this was the day the Condon Report was released to the press. The week of April 20 through 27, also seems to have been a major "flap" period. Interesting "meteor" events have also been occurring worldwide, and there was an outbreak of "mysterious gas attacks" on the weekend of April 12-13. Try to keep abreast of all unusual developments in your own immediate area.

On May 3, 1969, RAF Air Marshal Sir Victor Goddard gave a UFO talk at Caxton Hall, London (England is currently in the midst of a big UFO publicity flap). Among his main points: "That while it may be that some operators of UFO are normally the paraphysical denizens of a planet other than Earth, there is no logical need for this to be so. For, if the materiality of UFO is paraphysical (and consequently normally invisible) UFO could more plausibly be creations of an invisible world coincident with the space of our physical Earth planet, than creations in the paraphysical realms of any other physical planet in the solar system...But given that real UFO are paraphysical, capable of reflecting light like ghosts; and given also that (according to many observers) they remain visible as they change position at ultra-high speeds from one point to another, it follows that those that remain visible in transition do not dematerialize for that swift transition and, therefore, their mass must be of a diaphanous (very diffuse) nature, and their substance relatively aetheric...The astral world of illusion which (on psychical evidence) is greatly inhabited by illusion-prone spirits, is well-known for its multifarious imaginative activities and exhortations. Seemingly some of its denizens are eager to exemplify 'principalities and powers'. Others pronounce upon morality, spirituality, deity, etc. All of these astral exponents who invoke human consciousness may be sincere but many of their theses may be framed to propagate some special phantasm...or to indulge an inveterate and continuing technological urge towards materialistic progress, or simply to astonish and disturb the gullible 'for the devil of it'."

Sir Victor is of cabinet rank and was involved in the RAF's UFO investigations in the early 1950's.

USEFUL TERMINOLOGY

The medical and psychological effects of the UFO phenomena have been grossly neglected. In order that these effects may be isolated and interpreted it is necessary for a properly descriptive terminology to come into use. Each issue of ANOMALY will add to this new terminology.

actinic rays - Ultra-violet and infrared radiation.

actinism - Burns or changes in the skin after exposure to UFOs.

aretalogy - The study of ancient writings, especially biographical literature describing encounters with non-terrestrial beings and their influence upon man.

demonomania - Possession, or belief that the body has been possessed by a supernatural entity. The contactee syndrome is a variation of this.

demonopathy- Same as demonomania.

ephidrosis- Excessive perspiration. Frequently experienced by UFO percipients and low-level witnesses.

inductopyrexia - Fever or sensation of heat produced by exposure to electromagnetic induction.

klieg conjunctivitis- "Eyeburn". UFO symptoms are identical to those of actors exposed to klieg lights. Produces inflammation, itching and soreness of the eyes. A reaction to ultra-violet rays.

UFO akinesia- Immobility or temporary paralysis of the body while in the presence of a UFO or UFO-related entity, possibly caused by the sudden release of adenosine-tri-phosphate (ATP) into the system, or by electromagnetic influence upon the neurons. Since the mind seems to remain unaffected in most cases of UFO akinesia forms of hypnosis can be ruled out as the cause.

Window - A geographical location where UFO sightings have occurred repeatedly for several months or years. Windows are frequently situated on or near known magnetic faults. Paraphysical objects become temporarily visible when traversing such areas.
