

PLANS PROGRESS ON UFOHIO '81

By now most of you know that APRO has scheduled a conference dealing with "The Case For Aliens", to be held at Cleveland, Ohio, on the weekend of June 6th, 1981. As usually happens with any event of this kind, plans go through a sort of metamorphosis or maturation.

In that vein, we are now able to report more specifically on this planned event.

A sub-theme that has suggested itself is "A Search For Magic". This is a corollary suggested by Dr. Richard Henry to Arthur C. Clarke's statement that the actions of an advanced culture would be indistinguishable from magic.

After the customary introductory procedures, Dr. Robert Creegan will keynote the conference with a presentation dealing with "The Nature of Truth" and "A Search For Magic", followed by Dr. Van Arsdale who will present two models for UFO reality based on his research. Readers of the Bulletin will remember his diligent work in connection with "The Colorado Ranch Case".

After lunch William Moore, co-author of The Philadelphia Experiment and The Roswell Incident, will update us with new information concerning retrievals of crashed UFOs.

Double abductee, William James Herrmann, will discuss the personal impact of UFO abduction, the implications of reporting, and the danger of suppressing, UFO phenomena using his own case as an illustration.

Betty Hill will look back briefly on the twenty years since her initial experience, dealing with the apparently deliberate attempts of the scientific hierarchy to discredit her, and bringing us up to date on recent events, then taking a tentative look forward.

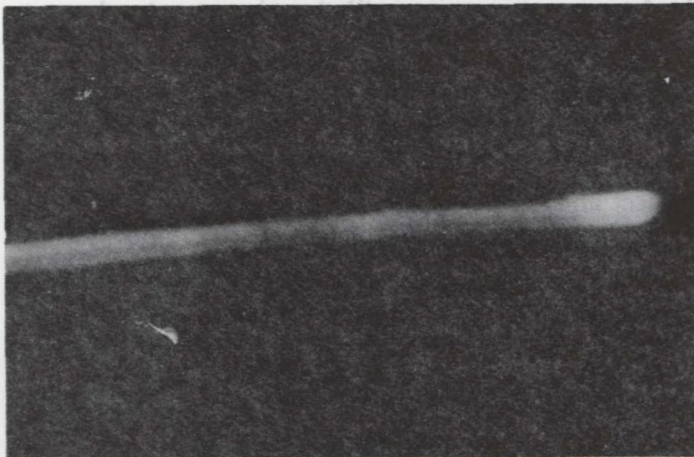
Dr. R. Leo Sprinkle's paper will be entitled "UFO Activity and Human Consciousness". Among other things he will deal with the fact that many UFO investigators have some contactee or abductee aspect in their respective backgrounds.

We will break at 5:00 PM. Saturday evening is left open so that each may choose the activity which pleases him. We predict a lot of "rap sessions".

Three workshops are planned for Sunday morning: Wayne Laporte will discuss the "Anatomy of a UFO Window"; this a reference to the area around Charlotte, N.C. where many sightings have occurred. Mr. Laporte also will exhibit several UFO case dioramas and models which he has built.

In the second workshop, Peter Jordan, lecturer and TV moderator, will discuss the many facets of the cattle mutilation mystery, particularly the aspect of "Alien versus Mundane" causes and their respective rationale.

SUPPORT APRO—RENEW NOW!

A very unusual photograph of an unidentified flying object has arrived at APRO Headquarters. The photographer is a successful businessman in Tegucigalpa, D.C., Honduras and has asked APRO to keep his identity confidential. Even if the object should be identified as something unusual but not a UFO in the usual sense of the word, it is quite a remarkable photograph.

Mr. R., as we shall call him, is an amateur astronomer in his spare time and is fortunate enough to have first-rate equipment with which to work.

On July 27, 1980, between 3:45 and 4:50 a.m. local time, Mr. R. was taking pictures of Venus with a Celestron 14 attached to a Canon F1 camera, using Kodak Ektachrome fast color film ASA 400 (transparency). He was testing speeds of 60 to 125.

From the transparency, using equipment made by Honeywell (Model 400A), a negative was made and amplified in a Durst Model 1000, lens 1:4/50.

Mr. R. provided APRO with the transparency, a 3½ X5 inch print and two 8X10 inch enlargements: one of the entire photograph showing both the object and Venus, and one of the object alone.

In the enlargement the object presents itself as an oval or disc-shaped image, having a "tail" or leaving a trail which extends to the edge of the film.

It is tempting to attempt some kind of explanation and because two obvious ones immediately come to mind I will mention the possibilities that the "UFO" is 1. a comet, or 2. a "green fireball" or bolide meteor. We'll discuss those possibilities, however briefly:

1. A comet generally presents a round or tear-drop profile with a characteristic cone-shaped "tail". The image of the object in this photo does not fit the generally accepted "profile" of a comet.

2. The term "green fireball," first introduced to the field of UFOlogy in the late 1940s, in the Southwest United States, was generally observed to be round, green and travelling at great speed on a straight course. APRO's files on such anomalies are not available to me at this writing (and I'm writing against a Bulletin deadline) as they are in stored files, but my memory of the controversy is vivid because of the "newness" of the phenomenon at the time, the sudden proliferation of "green fireball" sightings and the later sudden scarcity of same.

Some astronomers dubbed the fireballs as bolide meteors but those who couldn't accept that theory

argued that although they were fast, they were too slow to be meteors, and appeared to be flying parallel to the earth's surface, rather than arcing down as meteors do.

Mr. R. points out that he did not see the object because, not wanting to risk movement of camera or telescope by touching either, he was working with a camera timer. We have presented a photo showing Venus as the half-round bright object in the lower right corner of the photo and the object in question in the upper left corner, and an enlargement of that portion of the photo with the object, show more detail.

On the original transparency, (and in the prints) the object is a rather unusual shade of blue-green, with a blue trail which appears to be dissipating. We can assume that whatever it is, it was operating in the earth's atmosphere, thus the trail.

We would appreciate comments from readers, especially those with expertise in astronomy, mathematics, photography or physics.

It occurs to me that the time has arrived for organizations objectively studying the UFO phenomenon to abandon the use of the term "alleged" respecting sightings, contact and abductions. No doubt some reports will be due to inadequate comprehension of the objects sighted, or may even be hoaxes, but to use the term "alleged," with its "semantic burden" of skepticism and suspicion of the witness(es) is to give "aid and support to government and media (print and electronic) disparagement of the subject and thus help maintain the disreputable status they persist in assigning to the "alleged" phenomenon. By now, of course, there is no question of the reality, uniqueness and probable importance of the UFO. May I suggest, therefore, more appropriate - and positive - terms be used, such as "reported," "claimed," and such less ambivalent terms. It is time for the professionally operated UFO investigatory groups to stop being in the least apologetic in their approach to the subject. Whatever the source and principles behind the manifestation of the UFOs, there is surely no "reasonable doubt" as to their reality—even if their purpose here, motive power, and possible paranormal association are not yet clear. At any rate, on the few occasions when someone has asked my opinion of the UFOs I assert that the overwhelming evidence from reputable sources leaves no doubt as to their reality.

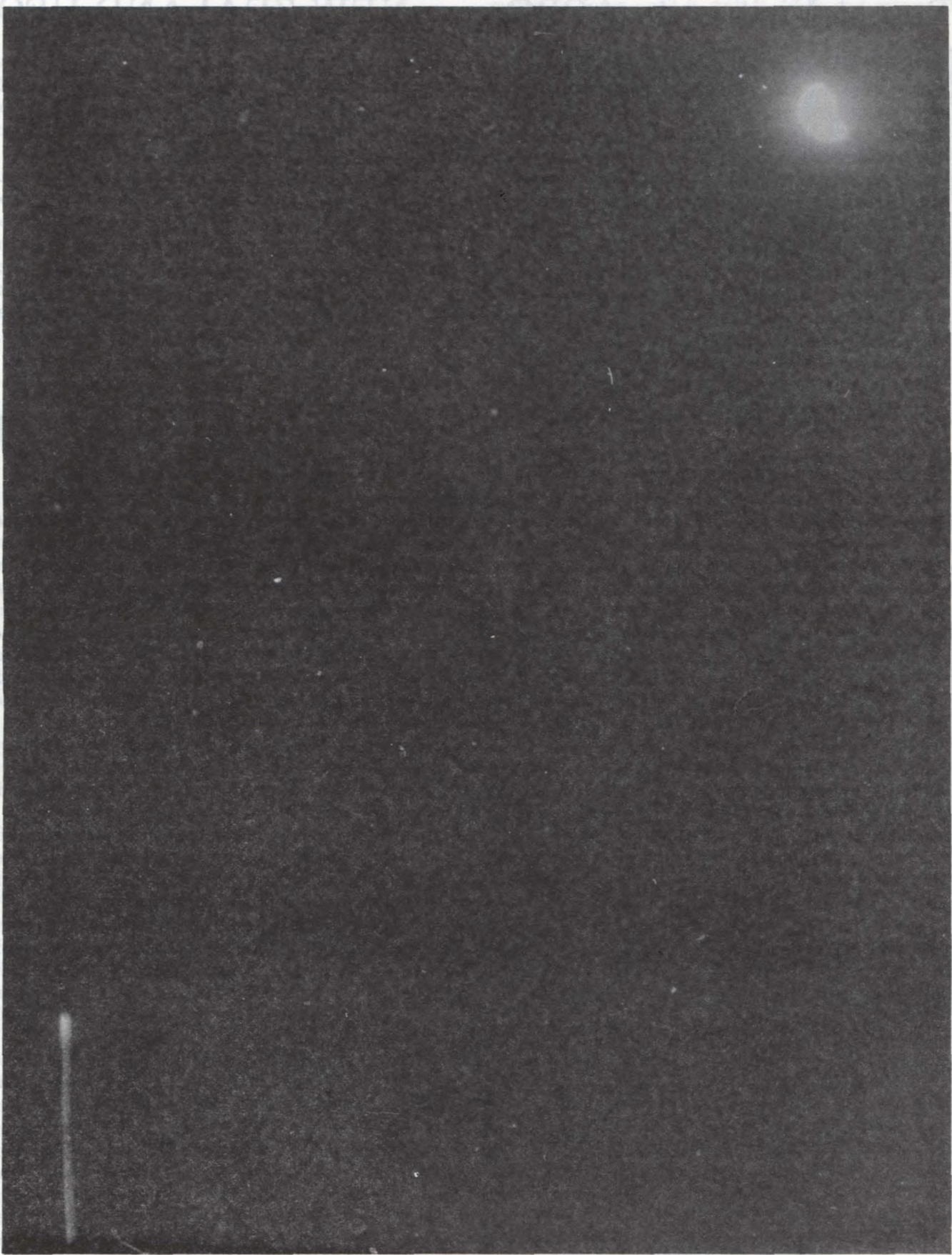
GENERAL MEMBERSHIP MEETING

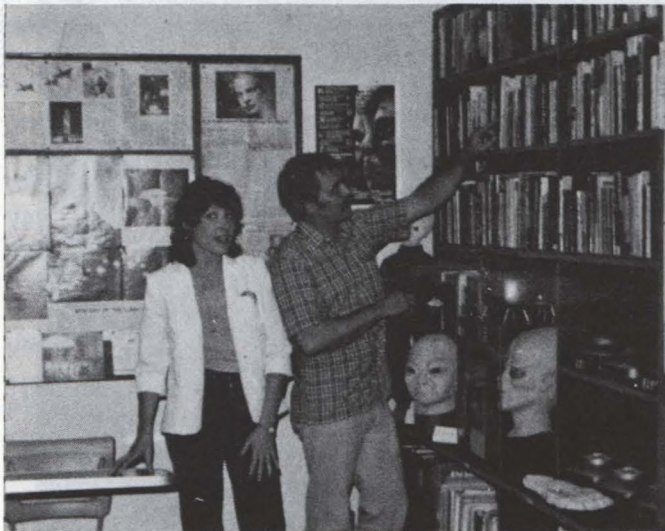

NEW ZEALAND UFO

Around 10:35 p.m. on July 27, 1980 a 16-year-old boy in Upper Hutt heard a noise which sounded like "someone getting into the chook house." He looked out the window and saw a peculiar green light in the sky.

Neighbors came out with their dog and all watched as three large lights moved swiftly from a south-easterly direction. The first light was accompanied by 12 smaller ones, the second by 5 and the last by 2. Then, with a crackling noise like a welding torch, a final greenish-blue light flashed across the sky at tremendous speed. The dog raced under the house and refused to come out until 2 p.m. the following day.

FISHERMEN WATCH UFO IN IOWA

The following information was contained in a letter from Mr. Douglas Slaiken of La Porte City, Iowa:

"Five of us, all from the Waterloo Iowa area, went on a four-day fishing trip to Star Lake (Detroit Lakes Region) five miles west of Dent, Minnesota.

"At approximately 1:45 on Monday morning, June 23, 1980, three of the five (Craig Crowley, Michael Pryor and myself) were sitting on the dock behind the cabin (facing directly south) discussing the previous three days of fishing.

"Being so close to the fourth of July, we thought when we first spotted the object that someone was getting a little hasty with the fireworks. We found out different.

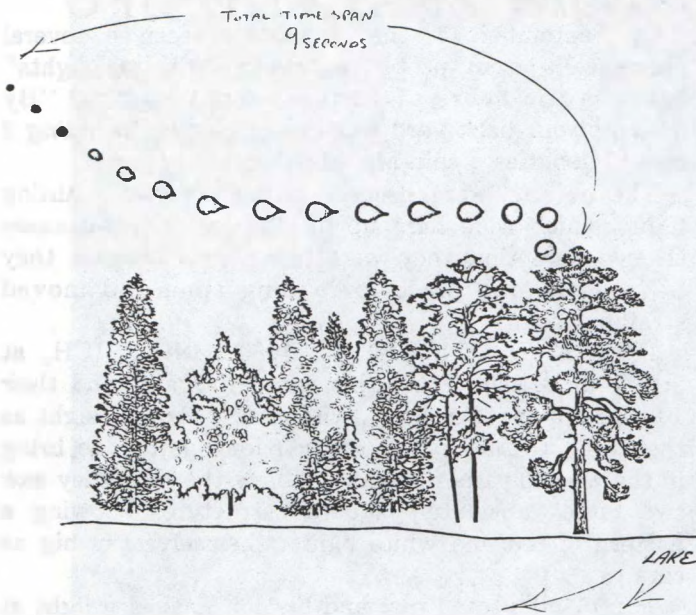
"As we faced south, looking across a distance of two miles of water, a tall row of trees ran along the far bank of the lake from our right to left. (See drawing).

"A green ball rose slowly straight up from the tops of the trees. The ball seemed to be brighter toward its center. Picking up speed just slightly, it moved to the left, running parallel with the tops of the trees. As it moved in what seemed to be an easterly direction, we all noticed a yellow light on its right side, forming a small tail of sorts, running behind it.

"The ball travelled parallel to the trees for approximately four seconds, and then headed upward at about a 40 degree angle, the ball decreased in size, just seemed to be heading in the opposite direction (as it was getting smaller and seemed to be moving now at a fantastic speed). We watched it decrease to nothing in size.

"Immediately after the sighting I asked the others what they'd seen and there were no discrepancies among the descriptions."

(Editor's note: although it is generally thought among researchers that UFOs are making themselves



“scarce” it appears that with concentration of the media on the Iran-Iraq war, the Iranian hostage situation and politics in general, UFOs are just not getting the exposure they normally would. The above report is representative of the material constantly flowing into APRO Headquarters.)

PRESS REPORTS

CALIFORNIA, AUGUST 19, 1980 - PARADISE, Mrs. Ann Whitson glanced outside her window about 11:30 and saw a bright light in the sky. She called her daughter and son-in-law who also watched the strange light.

It was described as a very bright light which drifted and floated and then shot off faster than a jet. When it took off above them, they saw a perfect triangle of lights with a dim flashing light in the center. The witnesses also heard a low-pitched sound unlike anything they've ever heard.

There were no other reports of the object with the sheriff's department or Paradise police, and Beale Air Force Base reported no unusual activity.

AUGUST 25-28, 1980 - APPLE VALLEY, Brian DuPont and Linda Lott watched a shiny ball of whiteness with flashing red borders about 3 hours before sunrise. They first noticed the object in Desert Knolls, then followed it to the Apple Valley dump.

The glow had no distinctive shape, but smaller red lights were discernible when the object moved closer. DuPont said the glow was very bright but dimmed when he flashed his car lights. It also brightened when observed from a distance but dimmed when approached. The couple observed the light for approxi-

mately 3 hours until it drifted away and retreated to the size of a star.

On August 28 at 4:48 a.m., Darla Henderson observed an unusual light through her kitchen window. She woke up her husband and they both watched it through binoculars for about 20 minutes. They said the light was bordered at its base by red lights and that it was moving toward the Apple Valley dump.

Margaret Thorngate said she saw an unidentified bright light at 11 p.m. on August 25th, the same night as the DuPont observation. She said the light hovered for a while then darted away.

PENNSYLVANIA, AUGUST 15, 1980 - MACUNGIE, at 3:50 a.m., Albert Trumbauer was making his rounds as a security guard at the Dallas and Mavis Forwarding Company when he saw what he thought was a plane. He could make out its lights moving slowly toward him at a low altitude from the east. When it was about a quarter of a mile away, it stopped in mid-air.

He said the object looked like a hamburger in a bun, or an upside down coffee cup sitting on a saucer. A red light blinked irregularly on the top and a strip of square green lights rotated on the lower part. The object glowed softly, like a halo, and made absolutely no sound. Trumbauer estimated it to be 60 to 70 feet long.

After watching the object for 30 minutes, he called the state police who said they had other reported sightings but could do nothing about it. He also called the airport and the newspaper, but got no answers. Being on duty alone, Trumbauer made no attempt to leave the property for a closer look at the object. Finally, after more than 2 hours, the object moved.

It moved around 6 a.m. and about every ten minutes the object would climb higher until it was finally out of sight at 6:30 a.m. Trumbauer said it looked silver in the daylight.

PENNSYLVANIA, AUGUST 25, 1980 - LANCASTER, Ed Resh stepped outside his house about 10 miles east of Lancaster at 3:30 a.m. and saw an “outstanding” object in the sky. He said it looked like a “roll of quarters” and had “a whole bunch of brilliant white lights.”

Resh said he watched the object hover about 1 or 2 miles off the ground at a distance of ten miles until he went to bed at 5:15 a.m.

SOUTH CAROLINA, SEPTEMBER 11 & 15, 1980 - ANDERSON, Jerry McAlister and his wife, Faye, were stunned in the early morning of September 11 to see an extremely large saucer-shaped object above their back yard. The object was described as 70 feet long, two stories high, and covered with windows and lights. It also made a shrieking noise and then a purring noise.

After hovering close to the ground for a short period of time, the object traveled upward where it was

SOME QUESTIONS

Some UFO sightings involve objects which seem to appear/disappear instantly. Some sightings involve objects which come and/or go "very fast," but either increase in size as they approach, or decrease in size as they depart, i.e. witness(es) can see the UFO(s) coming and/or going. At what speed does an object, even a "gigantic" object, need to move while being observed at a perpendicular viewing angle, so as to appear/disappear instantly to it's observer? For example you're looking at something; it simply disappears vs. first there is nothing; something instantaneously appears.

I wish to obtain the speed referred to above expressed as miles/kilometers per hour, and I am not concerned here with additional questions regarding inertia/energy required to stop/go instantaneously.

The following thought occurs: "Maybe this speed, if known, would increase awareness; but it is simply incalculable."

I am aware the cosmos (seemingly) is continually expanding, and the farther away a galaxy is, the faster it recedes. The most distant, perhaps, and hence the oldest known objects (quasars), also appear to be receding (redshifting) the fastest. Since quasars are believed to be closest to the "edge of the universe," what would be the implication(s)/connotation(s) if one gradually 1 or suddenly 2 disappears? Stated another way, isn't there a size/distance or magnitude/distance ratio which is calculable and which, once attained, will preclude human detection?

For example a 100 watt light bulb, illuminated and placed one mile away; a 100 watt light bulb, illuminated and placed 1,000 miles away; a 100 watt light bulb, illuminated and placed 1,000 light years away, etc. At what point does said 100 watt illuminated light bulb become undetectable by our most sophisticated means of detection?

visible for approximately 2 hours. Allegedly, the McAlisters have suffered conjunctivitis and indications of radiation burns since the sighting, and also successfully passed lie detector tests.

Around 4:20 a.m. the same day, Martha Lollis spotted a "big bright light". She watched the object through her window as it moved slowly across the sky. She could tell nothing about the features except that it was shaped like a big round saucer with a whitish bright light. Her daughter, Denise, also witnessed the

unusual light.

On September 15, the McAlisters received several phone calls from people watching "whirling lights" between the hours of 10 p.m. and 1:30 a.m. "By midnight our back yard was full of people, including 2 cars of deputies," said Mr. McAlister.

The objects were described only as two whirling lights which were high up in the sky. The witnesses seemed sure that they were not planes because they hovered in one place for a long time and moved straight up.

ENGLAND, AUGUST 20, 1980 - NORWICH, at 9:45 p.m., Leslie Frost, his wife, Margaret and their 10-year-old son, Anthony, witnessed a strange sight as they went to the bottom of their long garden to bring in the washing from the line. Above the field they saw two huge "absolutely square" structures showing a pattern of red and white lights, themselves as big as cars.

For 15 minutes, Frost and his son flashed a light at the craft. As the objects moved across the sky, almost silently, one suddenly stopped and glided toward them. A "terrific flash" was followed by a small triangular craft emerging from the larger one. This small craft circled for about 10 minutes, hovered briefly, flew off in the path of the other two and "they suddenly vanished as though they went into a curtain."

Mr. Frost, who is an engineer, said you could almost feel the solidness of the objects. He felt that it was impossible to put structures as big as that in the air.

SENEGAL, SEPTEMBER 20, 1980 - BARI-DIANE, two people were injured, huts and trees uprooted and roofs from nine other buildings scattered over several kilometers when an unidentified object flew over a village in central Senegal. The object was described as 30 meters long, 15 meters wide and was capped with a blue crown emitting white smoke and radiating intense heat.

It blew down 50 huts in the village and lifted a 200 liter water barrel off the ground, boiling the water.

UFO CONTACTEES: CAPTIVE COLLABORATORS OR COSMIC CITIZENS?°

This paper provides a tentative view about the significance of the UFO experience, with special emphasis upon the perceived characteristics and the alleged experiences of UFO abductees and contactees.

The paper summarizes a survey of more than 200 persons who claim to have experienced some kind of psychic impressions which are related to UFO encounters. A list of approximately 50 persons is presented, with a brief summary of their UFO experiences. These persons have participated in hypnotic time regression procedures in order to explore their "los of time" experience during their UFO sighting; these persons recall memories of apparent abduction and examination by alien beings, or UFLOK; many of them report unusual physiological, psychological, and psychic manifestations, along with a feeling of being monitored and/or receiving "mental messages" from UFOLK.

The hypothesis of "cosmic citizen" is suggested as the purpose of UFO contact, and recommendations are provided for further investigation of the significance of UFO communication.

INTRODUCTION

Experienced investigators, e.g., Jim and Coral Lorenzen, co-founders of APRO (see references) and J. Allen Hynek, Director of CUFOS, have pointed out that reports of Unidentified Flying Objects (UFOs) can be characterized as incredible stories told by credible people.

This paper is an attempt to summarize and evaluate the significance of some of these incredible stories told by credible people. There is, of course, a human tendency to "kill the messenger" who brings unwanted news. I hope that the messages given to UFO contactees can be explored and evaluated for their possible significance before these messages are discounted or dismissed.

However, the reader/listener should be aware of my bias. I claim to have observed unusual aerial phenomena: In Boulder, Colorado, in the Autumn of 1949, a fellow student and I observed a "daylight disc" moving overhead; during the summer of 1956, my wife, Marilyn, and I watched a "nocturnal light" or object as it apparently descended from the western sky, hovering and moving between us and the "Flatirons" (Rocky Mountain Foothills), and then disap-

pearing to the north of town. In Alamosa, Colorado, and in Casper, Wyoming, I have observed "nocturnal lights" in the presence of other observers, including astronomers, ranchers, and law enforcement officers. Thus, over the years, I have changed from a "scoffer", to a "skeptic", to a "believer" in the reality of UFO phenomena. The reader/listener should be aware of my bias in evaluating my work with other UFO observers and with UFO contactees.

UFO CONTACTEES

In 1962-63, I surveyed a sample of 259 persons who were fellow members of NICAP; their responses to a questionnaire were compared with a group of Graduate Students and Professors in Psychology (Sprinkle, 1969); their range of responses was similar to those of USA norm groups on the *Rokeach Dogmatism Scale*. I concluded that these respondents were no more "dogmatic" than a sample of average USA adults.

In 1965, as a consultant to APRO, I became interested in persons who claimed to have experienced psychic impressions of UFO phenomena. My 5 year plan (!) was to collect responses from 100 persons; interview those persons who claimed to experience many psychic phenomena; utilize hypnotic procedures for exploring their psychic abilities and their UFO experiences; then, ask them to predict the locations of UFO "flaps" so that investigators could travel to those locations and gather data! Participants in the survey were asked to complete a questionnaire with items on their educational and occupational background, ESP experiences, UFO sightings, and their impressions about the origin and purposes of UFO occupants, or UFOLK; also, they were asked to complete two psychological inventories: *Adjective Check List (ACL)* and *Strong Vocational Interest Blank (SVIB)*.

In 1976, tentative conclusions from the initial study of 83 participants were reported (Sprinkle, 1976). Now, in 1980, over 200 persons have participated in the survey; current participants are asked to complete the questionnaire, *Adjective Check List (ACL)*, *Minnesota Multiphasic Personality Inventory (MMPI)*, *Strong-Campbell Interest Inventory (SCII)*, and the *16 Personality Factors Test (16PF)*. In general, the patterns of scores for participants are similar to those of USA adults. The results do not support the "psychosis hypothesis": the hypothesis that UFO sightings are reported by persons who are experiencing neurotic or psychotic reactions.

However, these persons often express the fear of being considered "crazy" or being ridiculed by relatives, friends, or neighbors. These persons often express relief when they learn that other participants report UFO observations and related events, e.g., dreams, visions, physiological symptoms, poltergeist activity, apparitions, electromagnetic anomalies, and "mental messages" from entities who claim to come from outer space.

UFO ABDUCTEES

Since 1967, I have interviewed approximately 50

persons, using hypnotic time regression procedures, in order to assist the participants to explore their subconscious memories of a "loss of time", or temporary amnesia, during UFO experiences. These interviews are summarized as follows:

Hypnotic Sessions with UFO Abductees

(Case No. Participant [Year of Interview] Summary of UFO experiences)

1 NHC (1967) A factory worker described his impressions of an encounter with a strange being who tried, unsuccessfully, to invite NHC from his car into an UFO which hovered over Denver, Colorado.

2 CB (1968) A college student described an examination by UFOLK, during a "loss of time", while she and her boyfriend were parked in a wooded area near Laramie, Wyoming.

3 Herbert L. Shirmer (1968) A policeman recalled an encounter with UFOLK, during a 20 minute "loss of time", near Ashland, Nebraska (Sprinkle, 1976a).

4 E. Carl Higdon, Jr. (1974) An oil driller recalled a strange encounter with UFOLK, during a 2 hour "loss of time" experience while hunting elk south of Rawlins, Wyoming (Lorenzen & Lorenzen, 1977; Sprinkle, 1979).

5 Charles Hickson (1975) Charlie Hickson and Calvin Parker were fishing at a port in Pascagoula, Mississippi; they reported the experience of being abducted by 3 "robots" which floated them onto a hovering craft (Fisher, 1978).

6 Sandra Larson 7 Jackie Larson (1975) Mrs. Sandra Larson, her daughter, Jacki, and Jacki's boyfriend, experienced an hour "loss of time" while driving on a North Dakota highway. Their memories were of an abduction and examination (Clark, 1976).

8 RH 9 RH's friend (1976) Two college men reported impressions, or memories, of an encounter with strange beings while driving on a Utah highway.

10 Mona Stafford 11 Louise Smith 12 Elaine Thomas (1976) Three Kentucky women experienced an hour and 20 minutes "loss of time" while driving home from a restaurant; each described impressions of an abduction and examination by small beings with large eyes (Lorenzen & Lorenzen, 1977; Stringfield, 1977).

13 PS (1976) An Ohio woman recalled memories of an encounter with UFOLK shortly after an UFO sighting from the back porch of her home.

14 "Rachel Jones" (1977) Gayle P. Bever recalled impressions of an abduction and examination by alien beings; a small circular scar can be observed on her shoulder (*APRO Bulletin*, Nov. 1977, Vol. 26, No. 5).

15 Mary C. Sewall (1977) A Utah woman described memories of abduction by UFOLK and flight in a space craft when she was living in California.

16 LS (1977) A young California woman described her impressions of mental communications with entities claiming to be UFOLK.

17 LP 18 BK (1978) Two young women recalled impressions of being taken aboard a space craft and encounter UFOLK, while driving on a Colorado

country road.

19 Thomas Jankowski (1978) A Wyoming welder recalled memories of a strange face looking through his truck's windshield during a snowstorm; during a hypnotic regression session, he recalled memories of being on board a space craft and sitting at the "control panel."

20 BB (1978) A young college woman recalled a childhood incident of observing an UFO and experiencing "mental communication" with UFOLK.

21 JV (1978) A young businessman recalled impressions of abduction and examination by UFOLK during a drive with his partner on a Texas highway.

22 "Shannon Dempsey" (1978) A young Idaho mother recalled an UFO encounter and face-to-face meeting with UFOLK, while driving her son on an Idaho highway.

23 "Gloria Archer" (1978) Ann Canary, a Denver woman, recalled her impressions of UFO abduction and examination; the memories of the experience had haunted her for 12 years; now, she views herself as a "cosmic citizen."

24 JD (1978) A ranch foreman described his experiences of cattle mutilations, UFO sightings, ESP events, and face-to-face encounters with UFOLK (*APRO Bulletin*, July-Dec. 1979, and Jan. 1979).

25 JK (1978) A former military paramedic recalled impressions of a strange light; a "loss of time"; abduction of him and his buddy by UFOLK, while strolling on a beach in a Central American nation.

26 PLW (1978) A college student recalled an encounter with 7 foot tall beings, in cloaks, who approached his stalled car while he was on leave from the USAF and traveling in Wyoming. He was given "precognitive" impressions of California earthquakes and UFO landings.

27 SF (1978) A young male photographer recalled impressions of an abduction and examination of him and his partner., by UFOLK, while they were camping in Arizona.

28 Pat L. McGuire (1979) A Wyoming rancher, who had 2 cattle mutilations on his ranch, recalled a "loss of time" while hunting in the Teton Mountains; his experiences included a "mission" to dig a well; encounters with UFOLK; and vivid but strange impressions of the Israeli-Egyptian War of October 1973.

29 SAL 30 SL (1979) A husband and wife recalled an abduction by UFOLK while traveling on a New Mexico highway.

31 Barbara Freund (1979) A University of Wyoming Student recalled impressions, or memories, of abduction and examination by UFOLK on board a space craft, while meditating in her Laramie apartment.
