# **Our Pearl Harbor War Criminals**

WASHINGTON,-President Roosevelt polled BRITAIN WANTED TRUCE his Cabinet one month before Pearl Harbor on the question "whether the people would back us up in case we struck at Japan" to stop aggression in Southeast Asia. He got the unanimous opinion that they would.

This was disclosed in the diary of former Secretary of War Henry L. Stimson. Stimson sent excerpts to the Senate-House committee investigating Japan's December 7, 1941, attack. The committee, which had asked for them, made them public.

They disclosed also that the President and his so-called "war cabinet" agreed on November 28, 1941, that the United States would have to fight if Japan attacked the British or Dutch in the South Pacific.

THEY DISCUSSED WHETHER THE UNIT-ED STATES SHOULD ATTACK JAPAN WITHOUT FURTHER WORD. THIS WAS REJECTED.

It was decided instead that a warning message should be sent to Emperor Hirohito and the situation put before Congress. Mr. Roosevelt sent a message to Hirohito December 6, but there was no message to Congress until after Japan's attack.

#### OUR WAR CRIMINALS

The "war cabinet" was composed of Stimpson, Secretary of the Navy Knox, Secretary of State Hull, General George C. Marshall, Army Chief of Staff, and Admiral Harold R. Stark chief of naval operations.

Stimpson's record represented Mr. Roosevelt and his top advisers in November, 1941, as expecting war. The questions were the time, the place and how it would begin.

Stimpson said Mr. Roosevelt pointed out at a meeting, November 25 with his war cabinet, that "the Japanese are notorious for making an attack without warning, and the question was what should we do."

WASHINGTON,-Bernard Baruch told Congress that strikes and lockouts must be prevented for at least a year-by law if necessary-so production can reach the high levels needed to lick inflation.

#### HULL, FDR DELIBERATELY STARTED PEARL HARBOR WAR TO PLEASE CHURCHILL

WASHINGTON, D. C.,-Twelve days before Pearl Harbor, former War Secretary Stimson favored a diplomatic truce with Japan which might have prevented the attack on Pearl Harbor and America's entry into World War II., he revealed in a 38 page statement filed with the congressional Pearl Harbor investigating committee.

#### TRUCE SHOWN BY HULL

The diplomatic truce referred to by Stimson was shown to him by State Secretary Hull during negotiations between the United States and Japan in Washington. It would have lasted three months and under it, Japan would have been asked to evacuate China and cease aggressive action. In return, the United States would have permitted trade with Japan to supply her civilian needs, particularly in oil.

"It adequately safeguarded all our interests," Stimson wrote in his diary Nov. 25, 1941, altho he added he feared the Japanese would not accept the truce because of its drastic terms.

The next day, Nov. 26, Hull, instead of proposing the truce, delivered a note to the Japanese which literally broke off the negotiations. It proposed a complete withdrawal by the Japanese from their conquered territories and held out no hope for future negotiations.

#### MEMORANDUM

I have decided to grant the prosecution's request, made in the form of a motion, to defer decision of all pending motions to dismiss the above-enlisted cases for want of prosecution. This action is taken in order to permit an investigation to be made in Germany as to whether cation with her Aunt Elizabeth at a beautiful there exists any direct evidence of guilt of the defendants.

Ordinarily when cases including charges of commission of crime have been pending for a long period of time, the Court is not justified in granting additional time to investigate as to the guilt or innocence of defendants. But the present cases, which involve allegations of conspiracy to undermine the morale of the Armed Forces of the United States, arose at a time when Germany, where important direct testimony of guilt is said probably to be available, was in a state of war with the United States and access to such testimony was impossible. Now that the war is at end, it seems to me reasonable to permit the prosecution to have opportunity to complete an investigation which apparently has been under way in Germany for some weeks.

If a trial of these cases is to be set by the Court, it is important that directive of guilt, if it exists, should be adduced. Counsel for the prosecution has stated in argument before me that late decisions of the Supreme Court of the United States in cases similar to those pending in this Court have made him doubtful as to the possibility of sustaining a conviction, if one is obtained on the evidence now at hand. them. We can see in New York City what This statement of doubt of counsel is supported by his failure thus far to inform the Court, although requested to do so, as to his attitude toward actually proceeding with a prosecution. If a serious doubt of the legal guilt of the defendants exists in the mind of the prosecutor, who is fully familiar with the evidence and is advised as to the strongest aspects of the Government's case, it would seem futile to prosecute these cases through many tedious months. Especially is this true where the Court is compelled to call upon a large number of defense counsel to serve impoverished defendents without any assurances of compensation. On the other hand, if clear, direct evidence of guilt is found to be available against the defendants, they should not escape trial.

I am fully mindful of the fact that the defendants have rights which, under our laws. must be protected by the Court. The cases against them, long pending, should be promptly disposed of. The investigation by the prosecution should be completed in a reasonable time and then the cases should be either dismissed or set a date for trial.

I shall grant the prosecution until April 30, 1946, to complete its investigation in Germany. This is longer than the minimum period requested, but I wish to afford what seems to me beyond question to be ample time, so that a further extension will not be requested.

On or before April 30, 1946, counsel for the prosecution will be expected to advise the Court in writing (copy to be sent to each defendant) whether prosecution of the case is desired, also whether in his judgment, there is evidence available which reasonably will warrant the sustaining of a conviction of the defendants, if one is obtained, under controlling decisions of

Serving as chairman, Knowland led interrogation of witnesses in a weeklong Senate subcommittee investigation of lumber scarcity, particularly as it affects the national housing program and returning veterans.

In between hearings, Knowland conferred frequently with Secretary of Labor Schwellenbach, Secretary of Agriculture Anderson, Labor Conciliation Director Warren and with John R. Steelman, President Truman's special assistant, in seeking a compromise between AFL and CIO differences over collective bargaining for cannery workers.

While Knowland's committee findings were not complete, the hearings developed that OPA failed to ring its wartime pricing policies up to peacetime needs. Lumber experts from coast to coast testified that when price relief is warranted it requires "at least" 60 days and generally from four to six months to put into effect. Many small lumbermen can be put out of business in that time, witnesses said.
