ON THE PHYSICS OF METAPHYSICS

If some of you think my articles on TECHNICAL INFORMATION & CURRICULUM are off the wall, wait until you get to comparing universes as an exercise in theoretical alchemy. In that world all is fantasy; nothing but the equations are real. Or, as Niels Bohr has been quoted as saying to an aspiring physicist, "Young man, your idea is crazy, but it's not crazy enough to be real." Welcome to the plenum.

Take, for example, the Hadit point of views: "One point is all points; all points are one point." Imagine a laserium show: a single light source from one krypton tube painting all the colors of the spectrum above you in the planetarium. "Yep, folks, it's Allegory Of The Cave Time Again! (for those of you who thoughtfully skipped PHILOSOPHY 1A that is in Plato's REPUBLIC) in which what we call reality is explained as a shadow-play on a screen while "true" reality lurks behind the projector. So who is behind the projector? as in the movie WIZARDS. Who is the script writer? the Director? the Producer? but most important of all, who is the audience? i.e. who is paying to see it? Show me the difference. And if you want to see the Projector all you have to do is look at the Rosh card in the Thoth deck or the tanka "Buddha in Meditation" (Ristberg Museum, Zurich) Same-same.

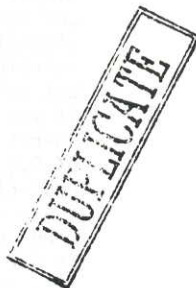

Dear Applicant:

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

We have further determined that you are not a private foundation within the meaning of section 509(a) of the Code, because you are an organization described in section 509(a)(1) and 170(b)(1)(A)(i).

If your sources of support, or your purposes, character, or method of operation change, please let us know so we can consider the effect of the change on your exempt status and foundation status. Also, you should inform us of all changes in your name or address.

Generally, you are not liable for social security (FICA) taxes unless you file a waiver of exemption certificate as provided in the Federal Insurance Contributions Act. If you have paid FICA taxes without filing the waiver, you should contact us. You are not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Since you are not a private foundation, you are not subject to the excise taxes under Chapter 42 of the Code. However, you are not automatically exempt from other Federal excise taxes. If you have any questions about excise, employment, or other Federal taxes, please let us know.

Donors may deduct contributions to you as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for Federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.

The box checked in the heading of this letter shows whether you must file Form 990, Return of Organization Exempt from Income tax. If Yes is checked, you are required to file Form 990 only if your gross receipts each year are normally more than \$10,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of your annual accounting period. The law imposes a penalty of \$10 a day, up to a maximum of \$5,000, when a return is filed late, unless there is reasonable cause for the delay.

Grand Lodge Report

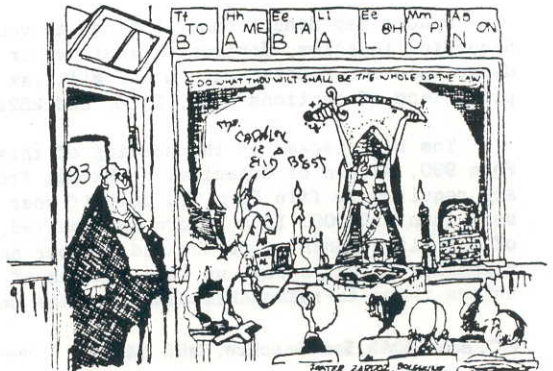

This time we have a bit more than the usual space for the Grand Lodge report, and it is just right for something beyond the ordinary. On the next three pages, you will find some possibly valuable papers — both for you personally and for the good of the Order. These include copies of the IRS letter of tax exemption and the Fiscal year report for 1981-1982 e.v. Please keep this 'Link where you can find it if you need it.

Why, you may ask? Consider. If you live in the United States, or if you are ever traveling in the USA, you might like to do certain things in safety. O.T.O. is a legal religion, a branch of Thelema, in the USA. That need not mean that O.T.O. is a religion in the international sense— in the USA, an organization qualifies as a religion if it maintains a Belief. We profess a belief in Liber AL vel Legis, The Book of the Law; we have regular ceremonies and other attributions of religious organizations. What that religious expression takes as a personal expression varies enormously from Thelemite to Thelemite. Nonetheless. O.T.O. Members have Liber AL in common along with the rituals and traditions of the Order. With the documents on the next two pages and either your initiation certificate or a letter of membership in good standing (a greeting letter on initiation or a letter acknowledging Associate Membership) you can prove in a court of law that many of the odder things you do are part of a recognized religion. Face it. There are still anti-witchcraft laws in this country. There are

there are laws against some of those things which our belief in Liber AL identifies as sacraments. To take a simple example, there are "dry" cities and counties in the USA which prohibit alcohol— because wine is one of our sacraments, you have a right to buy it but not to sell it anywhere in the USA. If you use Tarot or Astrology in your spiritual quest, the religious standing of O.T.O. provides you a measure of protection. There are other things that could be said, but these two minor examples should start your mind in the proper direction. Frankly, this religious status is not a whole-sale license or legal protection. Still, many religious organizations far younger than O.T.O. have gained freedom to use substances, including peote, in private religious observances. That's private, not public and not sales outside the group or to minors and visitors. To be sure, it takes up to ten years to fight a serious case through the courts, and it takes tens of thousands of dollars to do that. Still, if you keep these papers to hand and ask for advice from Grand Lodge in times of uncertainty, you have a very substantial improvement in safety and religious freedom. Hang on to them!

Now anybody with a need to drop down a tax bracket? The next three pages are your evidence of the tax exempt status and proper management of funds of your O.T.O. Photocopy them and do a little fund raising if you can. We will need to know about this as soon as possible to insure proper receipt of contribution, but by this means you can help us all.

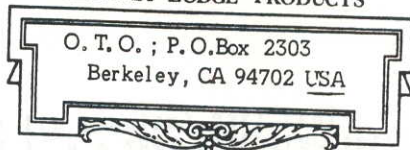
