ON THE ANDROGYNY EFFECT

One day in the Summer of '45 e.v. I was sitting in a long green Army tent at a green fold-out camp table on a green fold-out Army camp chair not far from those red clay graves of the American Army cemetery on the bluffs overlooking Normandy Beachhead...you would not believe those D-Day tanks...instant rusted dinosaur...thoughtfully reading my MAGICK IN THEORY & PRACTICE...which I usually kept stashed in my long green D-Day footlocker (that's what we called them) when this Captain walked in & said, "Hey, Mac, what'cha reading there?" I looked up at him, looked at the green ceiling of the tent, looked back down at my MT&P & knew there was absolutely no way in this universe or any other I was going to explain Aleister Crowley to this guy who had been a tank commander in the HELL ON WHEELS Armoured Division & was going back home to be a banker in N.Y.C., so I looked back up at him & said, "I'm studying to be a Pagan priest." He snorted & walked away. "That crazy McMurtry, Jawohl, Herr Kapitän. Just another Oberleutnant who had had his brains scrambled once to often on the long & bloody road from Normandy to Nürnberg.

For what I was reading was how Crowley was saying in the Aeon of Horus there would be two sexes in one person, the Aeon of the Child being that of the androgyny & the gynander. I must confess that I hadn't the foggiest idea of what he was talking about at the time...like so much of Crowley, MT&P

is a whole new book every time I re-read it every 5 years...but I have damn sure made a lot of observations since. One was of Crowley's amazing ability to see in time. In a letter to me dated Nov 21 '44 e.v. (see O.T.O. NEWSLETTER Sep 1978 e.v. for facsimile) he says, "1965 e.v. should be a critical period in the development of the Child Horus." And we all know what came down in 1965 e.v.: Acid & Rock. The Haight Experiment. Those of you who went thru it have some foggy idea. Those of you who are still around much more so. For it was not just a life-style that changed, but a radical new approach to human engineering. A whole new pattern, a different way of looking at things. A way so different we had forgotten it is as old as Mankind. The use of psychedelics for Sacramental purposes. There were some heavy Magick trips went down in the Haight. There is still that solid circle of yew around a redwood log amphitheater in the Botanical Garden in Golden Gate Park. And much of it hinged on Crowley, which is why the Gemini card in the Tarot was known as "the Acid card." Because in 777, Col. XLIII, line 17, we have ergot. Crowley didn't have clinical LSD. Neither did the Pharaohs. But they both had the same idea in mind. Changing the Psychic Body alchemically. Which is why Col. XLIII, line 2, has both hashish & cocaine at the Ajna Chakra level because of their "direct action on the deepest nervous centres" of the brain & spinal column. Right down to your coccyx. Alchemy being from the Arab AL-Chemie, the Chemistry of God. And that which God has

united together, let no man put asunder. Altho much of this is based on Crowley, 777 etc, most of the direct observations were made in the Haight, which is about the only place they could be made.

Take for example the Acid Tarot, or so it was called in the Haight. Here have 22 Major Arcana as re-interpreted under the impact of heavy psychedelic experiences. The reversals of meanings & fresh insights gained may have been controversial to more established heads, but by re-examining their material within the accepted framework at least they could be compared with "reality" as the classical scholars of this discipline understand it rather than some idiot's private head trip. Which are also interesting but mostly for their flaming debris

The real meat of the trip, however, lies in the tradition of the Gnosis, i.e. the use of LSD & other heavy psychedelics to awaken the Serpent Power-Kundalini-Tantric force (see TOWER -Mars-Pè card, THOTH DECK) This can be very dangerous...the Haight was a battlefield; only for artillery they used lightning= Acid-the Sword-Gemini-Twins-Zain =7 = The Lovers (see the Holy Guardian Angel trip since Gemini "the Elevator" crosses the Abyss) = Tiphereth connected with Binah thru Da'ath = the throat/Visudha chakra once constructed in the psychic body. Or, as you can read in your daily paper, "NEW STUDY BACKS THESIS ON WITCHES Article Says Ergot Poisoning Caused Behavior That Led to 1692 Trials in Salem," NEW YORK TIMES, Aug 29 1982, p. 30. It is best to have a friend who has been there before when you get your head into that particular far out place & for this reason mankind has had Initiatory societies, like the Native American Church, throughout the ages except in modern Western civilization where there are laws against such experimentation. But there certainly are none in the traditional Orient where Mohammed could smoke hash & talk to the angels along those far out camel trails like Ishmael (God-hear) 77777 = 451, Gen. 16:11. You will notice that the ears (N'ITH = 108) has a sword (Zain) in it. Nor are there in the Soviet Union where they are considered to be handy

adjuncts to psychic investigation. If a Uri Geller can bend spoons with his mind, what can their developed psychics do to our missile systems? Those Buddhists are going to start getting tired of mantras one of these days.

Among traditional initiatory practice is circumcision. Any male who has been automatically butchered by his mother's obstetrician in the delivery room should ask for a rebate. There is always a reason for any initiatory practice within a closed group, and "cleanliness" of the physical person is certainly not one of them. Shamans-medicene men-priests of all times have known the esoteric Yogic doctrine that there is a sympathetic neural connection between the foreskin & the pituitary gland = Binah see above. In that light circumcision could be seen as revenge on any outside group by crippling them psychically in a way that they would never know or suspect. Such considerations might lead to a number of parents opting for home delivery of their next child as it is almost impossible to expect a modern Western physician who, otherwise rational, sees even the use of vitamins as a waste of time.

The ultimate for our purposes, however, is to be found in THE HOLY BOOKS (see 'LINK Oct 1982 e.v.). Here, in Liber Cordis Cincti Serpente vel LXV (The Heart Girt With The Serpent) we have experiences loaded with reverse sexuality. "As Crowley goes thru the various levels of experiencing this phenomenon he slips in & out of sex roles easily as could be expected at this height of tantric androgyny." On the other hand he could be equally bawdy on the subject.

Do to the growth of the Order it is not possible for those of us at Grand Lodge to know all the people who are being initiated to higher degrees are in fact qualified. i.e. that they have memorized the rituals and understand and know the work as outlined in Liber MCLL. Therefore starting immediately all initiation certificates arriving at Grand Lodge must be accompanied by a copy of the Test given to the candidate. A test must be given by someone in the degree or above who knows the work. No one is doing a candidate a favor by initiating them into a degree for which they are not prepared.

We encourage people to study material in addition to the O.I.O. Study Program. But if someone learns such material instead of the O.I.O. Study Program then take your initiation in that group or Order.

Any additional ideas or feedback is welcome.

ATTENTION: MEMBERS IN THE USA:

Are you unhappy with the way you are receiving the Magickal Link? Would you like to get your copy faster each month and have fewer issues lost in the mail?

If you answer yes to these questions, this message is for you. First, if you have not been receiving all issues of the Magickal Link, take one that did come to you and bring it down to your Post Office. **COMPLAIN! BUG THEM!** Humbly correct your postal code or what ever if you are using an inexact address. Otherwise, IT'S THEIR FAULT. Make out and sign a formal written complaint. We routinely mail out our entire USA mailing list of the membership every month. A machine makes out the addresses. Unless there is a poorly entered change in your address label, all of the address labels used for your mailing will be identical every month. If you can show the postal authorities two Magickal Links with the same address and you did not receive one or more issues with a date between them, you can be sure that your local post office is the place to stop the buck. There have been cases over the years in which some postal carriers have simply dumped 3rd Class mail in the trash rather than bother to carry it as federal law requires them to do. Don't let lazy exceptions to a hard-working majority of postal workers mess you up. **Suspect RELIGIOUS DISCRIMINATION!** Even if that charge is pure BS, it will get attention.

There is a better way, but it will cost you...

The total tab paid by Grand Lodge to print and distribute the Magickal Link in the USA in one year is about \$750.00. This is only possible if we use 3rd class to mail the publication. 1st class would add \$1,700.00 per year to this cost! We just can't do it. But, you can do it! The present cost to mail one Magickal Link 1st Class in the USA is 37¢. We really don't have time each month to make up a special mailing, but you can address your own. Simply get 12 (twelve) envelopes

of #10 size (sometimes called "Legal" size). MAKE SURE THAT THE LINK WILL FIT WITH ROOM TO SPARE -- STICK ONE IN AND ACTUALLY SEAL THE THING TO BE CERTAIN THAT I WILL BE ABLE TO USE THEM FOR YOU. Then take the 12 unused ones, carefully print or TYPE your address on each. PUT 37¢ IN POSTAGE ON EACH (other wise forget it). Then put them all in a large envelope (please try not to fold them, it really slows things down on this end; what with hundreds to do in an half hour or so) and mail them to this address:

If the postal rates go up, I may send a note asking for more stamps. Also, you will still be getting your regular 3rd Class Magickal Link, so you will have a very minor hedge against a change of address in the future. If you do move, send me enough self-stick address labels to cover your old addresses on the ones you sent earlier.

I will be mailing these out first of all the Magickal Links each month, so you will probably get yours almost as fast as the Caliph gets his if you use this service.

Canada and Mexico already have this postal rate, but not first out service.

Outside the North American Area, a similar service is possible, but more complicated owing to the need to use differing rates and differing stamps from those of the local, national system. Something can be worked out, but not as simply---we will try it in the States first to see what the size of the response will be. Internationally, non North American would involve the use of Postal exchange certificates, special seals available only in the USA and a selection of rates.

EARTH SHATTERING NEWS!

The Grand Treasurer General has finally managed to bring all 1,000 odd personal accounts up to date. Sounds boaring--what's so earth shattering about that?

About 250 of the 700 odd active and ?! members of O.T.O. are in arrears in dues. Odds are about 1 in 3 that you, dear Bother/Sister are one. Now that the great hairy beast at the typewriter has done the dastard deed, there will be over two hundred bills for accounts payable going out in later January and February of 1983 e.v. This is the first time Grand Lodge has managed to get caught up enough to do this in about two years, so please brace yourselves. The average bill will be about \$35.00, with Minervals and Firsts averaging less and other Degrees averaging higher. Multiply \$35.00 by 250 and you will see why we can't let this go on any longer without a billing cycle. If nothing is done by the end of our fiscal year, February 28th, the accounts receivable will easily exceed \$10,000.00. This comes at a time when the Order is engaged in two aggressive legal actions to free the Thelemic Press from usurpers and actual terrorists (one arrest in London for a fire-bombing conspiracy already) and on the finish-up of the trouble in Edmonton. You can't sit still in this world, and to move and do costs money as well as courage. So, starting in February, Grand Lodge will be quarterly or semi-annually billing and invoicing dues anniversaries and accounts in arrears. We will also be notifying quite a few Associates of expired dues--instead of just dropping the mailings.

Several points to remember:

1. These accounts are going to have a lot of mistakes in them. To avoid making you suffer for my errors in entering financial data (not to say the errors further up the line), I will make sure that you get a complete statement and a step-by-step explanation of how to read it. Anything mailed out with action pending will have at least 30 days of grace period on it. Extensions will be easy to get. Corrections will be easy to make.



Supreme Council News

Third Degree and Higher Initiates
Please note:

Because of the need for a continuing approach to intelligent fulfillment of Crowley's plans for the Order, The Supreme Council (Board of Directors) of O.T.O. has mandated the following change in approach to Fourth and higher degrees:

Henceforth and until the membership in the middle Degrees (IVth through VIth) reaches a sufficient extent to enable formation of the middle administrative and inviting Councils, Senates and other middle Degree bodies of the Order; the Supreme Council members will constitute, with the Caliph, the inviting body to the Degrees Fourth and Above. Up to now, great confusion has reigned on this issue and some members have either passed upward prematurely or far later than they deserved.

If you are Third Degree or higher, believe that you are an Accomplished and Oathful Member of your Degree and have passed a year or two in your degree, you may communicate your readiness for advancement to the Supreme Council or to any Council Member. When four Directors OR two Directors and the Caliph have signed your invitation, you may take it to any duly chartered IXth Degree or VIIIth Degree member of this Order as evidence of your right to seek initiation. That initiator will make preparations for your initiation or will direct you to a place and person who will perform your initiation in due course.

In plain English, just write a note asking for invitation to the degree in question and either send it to:

or to an individual member of the Board. For prompt consideration, The Caliph, The Grand Secretary General and the Grand Treasurer General all are reached through this address---The GSG and the GTG are probably your easiest approaches unless you are near at hand to one of the four Emirs on the Supreme Council. Your note should state your deeds done and time in degree---feel free to brag about your attainments; this is not an Order where humility in the wrong places works.

The Supreme Council Emirs and the GSG and GTG are up for election in March
Ninth Degree take Note: March Meeting.

2. Anything sent in after about January First may cross a billing in the mails. Aside from the obvious good advice to get in your dues renewals early (naturally you will probably be reading this either on January 2nd or after blowing your entire fortune on O.T.O. publications, tapes, Magickal Child oils and a statue of Confucius-with-a-clock-in-his-stomach for that special person on your gift list), this means that the statements of account will be behind your payments in a number of instances. Likewise, the procrastination of initiators in sending in initiation reports may become suddenly obvious. Don't worry. There will be a phone number included, and a quick note in the mails will do almost as well in preventing the unwanted demit or inactive status.

3. Now that all that's been said; Eastern Canada, Mexico and every body outside North America---please relax. This billing will cover only USA and Western Canada at this time. Later billings will be adjusted for the special circumstances that apply in the other parts of the Thelemic World.

4. Associates will be notified separately of expirations of membership, and there will be a grace period of a month or two.

5. After the amounts owing to Grand Lodge have come in for a while, a separate set of notices will go out to those who have credit balances. We want to pay what Grand Lodge owes too, or at least give you the option of choice in the matter.

6. After about March of 1983, anyone will be able to have an almost immediate statement of account for the asking--we can do it now, but would prefer to get this larger mailing out of the way first.

7. Yes, time payments and other options can be made available. Working off dues has worked well in the Grand Lodge immediate area; and, when the totals of the fiscal year can be measured against the preliminary returns of the billing process, grants of dues credit in the same proportion as Grand Lodge internal operations will be made available for exchange of labor at initiating Lodges, Chapters and Camps--more on this in March.
