

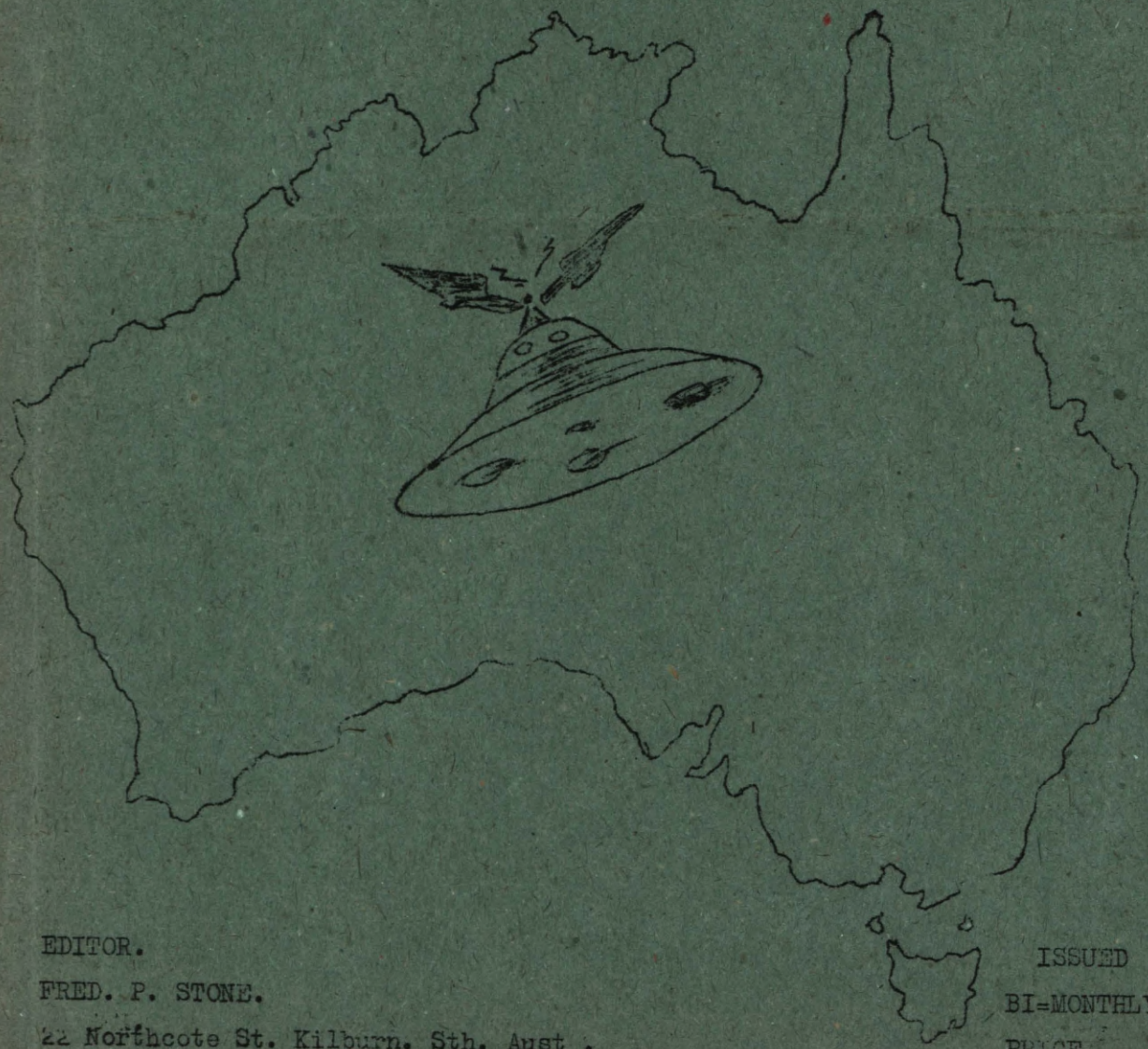

EDITORIAL INTEGRITY...????.

During the past twelve months and on some occasions prior to this, I as an Editor have been amazed at the standard of what I might term, lack of integrity, among some Editors of UFO journals, and amazingly this from some of the best produced ones.

In the big commercial world of production of written literature , one is not surprised to find at times a lack of camaraderie among fierce rival publications who are out to get a "scoop" or beat the other fellow to the post, and in this one does often see a great deal of " scrounging " i.e if we do not prefer to use the harsher word " pinching " of material .

However, in this field of UFO writing, which is supposed to be inspired in the main , by beings from outer space, who most magazines take the thesis of them as being of higher evolvment than others , especially ourselves. and this particularly on the moral scale of standards; it is amazing to think t that the methods of the commercial line magazines would be adopted, or even considered as being practiced. For surely of any we should be at least setting at least a little higher standard. that is if we practice what we preach .

Twice within the last year (12 months) I have found material which I had written up in this magazine . and exchange copies of which as usual were sent to other magazines Editors. actually taken out wholly and reprinted , without the least recognition as to where they got it from or from whom the article originated. no credits given either way .

In one case in a recent edition of a magazine a reprint of a reprint was made and because the Editor read it in the other magazine . no recognition was made either of this. at first I did not blame him , because I felt " well he has just copied it word for word from so and so's magazine. and added his comments but then I realised that the copy I sent the first magazine with the article in question in. a similar copy was as usual sent to him also. and therefor it meant he either had never read my humble magazine (this does not amaze me for the general tenor of his magazine has altered considerably , since his new management as Editor has taken place, and his attitudes to thinkers of my school is not very favorable.) or that he had read it and given it no consideration. except when he reads it in a much more commercially produced magazine he then goes to great lengths to search out and find out some explanations for the subject in question in the article. Put no mention of the fact that I wrote it, or that I explained fully in my text that I found it hard to find

proofs for. in fact I had recounted and given a story given to me when in New Zealand, and the relator of which had subsequently sent a signed statement from other confirming his story . However despite some research on my part I could not find any written evidence to verify the claims made.

Now Had Editor number 1. given due credit to me and my magazine . Editor number two would have known this and perhaps had the good manners to read my article if he had overlooked to read the copy of which was sent to him.

This was not the first occassion. Some years back . two magazine one in the USA and one in England. as in the above case. copied word for word . an article I wrote on the Fatima. incident. without any recognition whatever. to me or my magazine. Strangely enough this was in turn translated into another language and so it went on. and even in books today one finds this original thesis written up by me years ago in our original magazine " THE AUSTRALIAN SAUCER RECORD" being spoken of. and used. I certainly cannot take the credit for the incident or its relationship to UFO but having been receiving UFO magazines and literature for over 15 years. I cannot recall any writing about this story before the time I wrote it up in my magazine. the A.S.R.

Actually the article was not originally written then . I had written this in the book which I had written early in 1954 . (THE MESSAGE OF THE SAUCERS) but which never found a publisher , and still lies in its form unpublished and it was from this book I took the thesis I had written and gave it space in the A.S.R. a little later .

Well, Who cares? may be my material is worth publishing. or it would not have been copied, and although we do not get the credit. the truths we are telling gets an airing , and after all this is as far as this magazine is concerned is what we aim at. ceratinly not financial gain or profit. and finally there is an old saying. which maybe could be applied to this case, in an indirect way . IMITATION IS THE SINCEREST FORM OF FLATTERY.

Any Editor who copies any material from my magazine is welcome to do so. it being an understood unwritten agreement between most UFO magazines. except the few who jealously guard their material as being " holy" but I do feel we will each do each other more credit if we give honor to him from whom we have taken the material. I can only hope I shall keep to this myself. and learn the lesson from others who have not been so kindly thoughtful.

U.F.O. SNOBBERY.

I have previously in an Editorial some time back dealt with this so will not bore my readers with another lengthy one. on this subject.

However an article which appeared in an Australian magazine and widely read upon saucer research . and quoting statements made by leaders of an Australian organisation; I feel calls for a little restatement of the above regrettable growth of nothing less than " self conceited UFO snobbery".

The magazine , a well known a well read Australian Pictorial. in boosting up this society and its activities. of whom I have many friends among it. quotes from their magazine. as follows.

" In this magazine it objects to an " irrational argument" put out by a person described as a " veteran Australian Ufologist " (and by the way this is not me) who was reported by a national news paper as saying that extraterrestrials (people from other planets) landing on earth will tell us how foolish we are

to add " that poison " flouride , to our water supply.

Since it is not established that there are such beings as extraterrestrials, the editorial says. there can no point in speculating to what extent they might share our local views on topics such as the use of flouride.

Now before I go on quoting any further from these views given airing in the magazine. and quoted from a firmly established UFO society , which was founded on the belief that we are being visited from outer space by space people. Note the very complete change of views. (My , how we've gone up in the UFO scale. w no longer accept such as being established. Could this poor ignorant Editor ask a humble question. ?. What are we then dealing with ? Who are in control of the machines this society is supposed to be studying. ? How could they get here unless piloted by some inteeligents beings. ?? and so on the questions could go on and on. but why waste time.

Again. This Editor does not believe we have been instructed by space people NOT to have Flouride introduced into our water. He is well aware of the claims made by the " old veteran " above, and cannot agree with many of them . but who NEEDS A SPACEMAN TO TELL HIM OF THE HARM OF FLOURIDE IN THE WATER ????? HAVE WE NOT ENOUGH HIGHLY INTELLIGENT MEN OF MANY DEGREES TELLING US WHAT HARM IT DOES. AND WARNING US OF THE CONSEQUENCES. ??? and a little pointed question here, since when has the dental profession become so highly conscietious that they are willing to save people from having bad teeth. Do not their salaries come from the people whp have bad teeth. ? soon we will not need them if we keep the flouride going. Oh me Oh my . Since when does a man take the bread from his own mouth . (I suggest my readers read the book of Dr. Waldbotts " The Struggle with the Titans". if that doesn't open your eyes to the dangers of Flouride drinking , nothing will. and you wont need a space man to tell you. your own common sense should tell you to hear what learned men have had to say on the subject .

and to add to this infantile quotation . on flouride and space men the saucer magazine quotes " After all, spacemen may not even have teeth "

I leave it to my readers as to what sort of super snobbery is going on in that so called flying saucer society . sad to say this attitude has only taken this trend of latter years. and actually I am not surprised. for it is exactly as I expected it to. having kept a watchful eye on most Australian societies and their personal . it is not hard to see which way they will swing by those whom they allow to get in control. The same thing has happend in another large country, where change of control has altered their attitudes to the original conceptions, and this such pseudo scientific attitude has taken place . until they look down on the other worms among us who dare to think a little different .

Now here follows the requisite piece of clear demonstration. of how their attitude has become so haughty and holier than thou. Just analyse it carefully, for yourself and see what it really conveys and means .

" This unfortunate case vividly demonstrates a MENACE, which has beset ufology from its earliest days; the person who is attracted to UFO reseacrh not because of its intrinsic interest but because he sees in the UFOs a vindication and a justification of his own preconceptions. " (The EMPHASIS above is ours)

Well thats putting it plainly . these highly exalted saucer researchers have now formed a class , (evidently a most select one) in which anyone who DARES

to find in the UFOs some explanations to the many questions which have puzzled himself and his fellow man, and among his own field of thought, whatever that may be. has found that the saucers, somehow give some extra light and explanation? To such exalted he is dubbed a MENACE. actually it is nothing but gross smug hypocrisy, for who is there among us that has not had or does not still have "preconceptions" to which we try to fit all our search for truth into, to see if it fits!

Actually the whole of this attitude is nothing but a great bid to appear very scientific and thus appeal to the vanity of the people whom they seek to allure into their society. and one can almost notice around the UFO world today this sorting out, into sets or cliques. of those who are and those who are not.

Looking as it were and sorting such out, one finds the following schools of thought among UFO workers.

The True and purely scientific. (very rare and not as a group. each working mainly as individuals) The Pseudo scientific. the type who loudly mouth their objectiveness and by their very attitude in refusing to hear the other fellows story. (especially the contactees type) and if they do before they hear it have it all summed up from the start as not being "Objective".

It is in this class the self seeking. the opportunists. the publicity seekers Full of vanity and what our american brothers call mostly "hit air" the quickest way to test the genuineness of these types is to ask them to stand up against public opinion. to belittle themselves in their stand for UFOLUGY and my oh my just "see how they run". Its a sure test try, on some of them.

The next class is the Open minded seekers for Truth. who seek truth from ALL angles. they listen to ALL sides of the story. (hoping to find in it some answer. or may be some snatches of truth of not wholly the truth) not gullible but at least NEVER sneering at anothers point of view even if it not wholly acceptable, for often from the "mouths of babes etc" wisdom has been found to proceed. This is mainly because that 90 p.c. of the evidence we have on UFO has come from humble folk of the ordinary type. the mr. and mrs Jones or Smith. etc. the farmer. the laborer. the school boy and girl. the just ordinary folk. whilst the others in the schooled or academic class are very helpful such as the astronomers. and others of high intellectual type. and lower down the scale the pilots, navigators. engineers. etc etc. have given us very solid evidence to confirm the facts. we still must realise that the larger part is NOT from the higher ups but the "common folk" and it behoves each and all of us to try to come down to their level. i.e. if we think we are above it!

The next class is the harder to classify. as a bunch, for they vary so much and it is from this class that the real genuine gets labelled with the folk who are obviously be misled somewhere along the line.

This class is mainly those dealing with the metaphysical side of things, and as we covered this extensively but not as lengthy as we would like to have done in our last Editorial of the previous No 4. of this Volume. we must merely touch on it by saying. This school is the hardest to get factual proof from. and only mainly those who have shown that they have actually been directed by space people and have before an event has taken place. given the details of its fulfillment. could actually say "Well here is the proof" and if as in some cases this has been associated with actual saucer events. surely then one should give

these people the benefit of the doubt, and accept the fact that they DID receive their direction from a saucer contact .

Finally there are the real menaces. people who make all sorts of wild claims, statements, and confuse the issue completely by claiming to have knowledge of saucer matters. and again and again contradicting themselves. and making it hard for these who have to get up publicly and explain away the foolish behaviour of these so called researchers. In this class also is the type mentioned before , those who claim to have messages from space , and be in contact with high beings. and when compared with similar claims. to be found completely contradictory to the other ., for in one . will come a message taking a view point completely different to that supposed to come from another high being . all of whom are supposed to be the space brothers or leaders of the space brethren . until if one followed them all, they would end up on the psychiatrists table. confused bewildered and more than bothered. ... bedevilled!

We do not claim to be perfect ourselves and often find our trouble is to keep our feet on the ground, and also when the reverse occurs to keep an open mind but if a prayer should be made for us it is that we shall remain humble men and women, and that the Lord shall save us from considering ANY as not worth at least listening to , and that with an open mind and not a closed one.

I frankly detest snobs in any form of human society but when it comes to UFO snobbery, well, words fail me.

 LARGE ASTEROID HEADED FOR THE EARTH IN 1968.

Sydney. July. 27. 1966..

Prof. Stuart Thomas Butler, (leading scientist and physicist) said today that the Asteroid ICARUS is on course to the earth. He said any microscopic deviation(underlining ours) in the orbit of the asteroid Icarus would put it on a collision course with earth, causing " a colossal force impact of great destruction" equal to the power of 1,000 hydrogen bombs.

He added that the United States and Britain and Russia are studying the possibility of using a nuclear rocket to prevent the asteroid from smashing into the earth .

Butler, a 44 year old professor of theoretical physics at Sydney Uni. said Icarus is nearly a mile wide and presently is on a " near collision" course with earth . It will pass within four million miles of earth in JUNE 1968.

He said it could reduce any of the world's major cities to rubble in a flash if it diverted only slightly from its present course.

However he said the above nations are investigating how they can land a rocket on Icarus and smash it together. by using a nuclear warhead.

Our question is Professor . "What if it misses and causes the asteroid to deviate that microscopic bit you suggested? and what of other repercussions?? We received the same information of this from 3 sources but the distance from earth varied from 1 million miles to 4. In any case even 4 million is only a flea bite in space.

There is also to be an eclipse of the sun a month later in July . quite an array of celestial matter for 1968. "signs in the sun and the moon and mens hearts shaking for fear of things coming on the earth " . Now who said that?

THE CAPIO CONVENTION 1966

Although your Editor was not allowed to attend this convention, being literally "shut out" with some other well known UFO investigators, as explained in the following, he reports that the convention went quite well, with some very interesting papers being read by several representatives of the various bodies belonging to CAPIO. One of these papers is printed in this edition, and another a little too lengthy for this one will be published in our next. It seems a great pity that an organisation which promises to be such a good means of promoting the publicity and extending of the knowledge of the UFO and the work done by the organisations throughout Australia, was marred by obvious weaknesses in the controlling body, such fault we hope and believe will be rectified, so that in future such can never occur again. or it will mean that CAPIO will not be fulfilling that which it was formed for. a year ago.

Several UFO workers, some of long standing were invited to attend the conference as guests, not being members of Capiro they could not attend officially. Your Editor was one of these. However the hosting society in Adelaide, through a few of its controlling officials refused to allow these people to attend and bluntly said so, or suavely tried to put them off. making it obvious they would not be welcome. Naturally being gentlemen they did not attend. also the fact that Christian Grace seemed better to practice than enemy.

We do not bear ill will, rather feel that we lost nothing. in fact we definitely gained by this behaviour and won more than ever the confidence of many friends who were appaled at the insult given to us.

What your Editor wants to point out however is not the PERSONAL issues. for this is just what caused the very veto against those refused admission. But what does concern him is the fact that those in authority in CAPIO. ~~like~~ ALLOWED such regrettable behaviour to dominate the Conference. for after all CAPIO is supposed to be a Commonwealth organisation, and being made of up member groups of ALL states it should be the voice for ALL, and not one in particular. The fact that they allowed one state, even though they were the host. to dictate to the Official body of Capiro and lay down terms of who would be or should be invited. displays a great weakness in the construction of CAPIO, and it is to be sincerely hoped that those in control, will see to it that such a display of personal bitterness is not allowed to control a body which speaks for the whole. We have not bitterness against CAPIO some of its trends we are not happy about. but we believe and hope they will be overcome. Your Editors organisation, UFOPIA, was asked to join CAPIO some time back and this request was repeated again just prior to the Conference. However surely one could hardly expect an organisation to have confidence in joining forces with member organisations, when such bitterness exists and is and was most unfortunately allowed and thus condoned by those in authority of CAPIO. Maybe CAPIO has an answer to all this, if so, we will gladly print its reply, for we surely would like to know. why one member group has the right to dictate terms to the whole. Those allowed to attend should be set out by CAPIO and those who can attend as guests of member bodies should in future not be subjected to such potty behaviour of little men.

***THE STORY OF CAPTAIN. W.J. HULL. A GREAT PILOT.

This is the story of Capt J. Hull: the story of his reputation as an outstanding air pilot; the story of his original belief in the Menzel theory regarding UFOs; the story in his own words of the UFO he watched which ended his skepticism; and the story of his untimely death in a plane crash in Michigan .

Part 1.

THE STORY . By Rex Steele.

On Easter Sunday night, April 6, 1958, a Capital Airlines turbo-prop Viscount carrying 47 passengers and three crew members crashed just short of the runway as it prepared to land at Tri-City Airport near Saginaw. Michigan . All 47 aboard the plane, many home-bound vacationers, lost their lives.

The pilot of the ship was Capt. W.J. Hull, 44, of Westwood, New Jersey, one of the most respected commercial airline pilots in the nation. The mystery of the UFO was among his interests.

In 1953 , he wrote an article for the AIRLINE PILOT, a magazine published by the Airline Pilots Assctn . of Chicago. entitled " The Obituary of the Flying Saucers" in which he accepted Dr. Donald Menzels natural phenomena explanation. According to NICAP's UFO INVESTIGATOR he later agreed to a re-examination of the evidence.

Then , on the night of Nov. 14. 1956, Capt, Hull and his co-pilot, on a flight from New York to Mobile. Alabama, witnessed a two-minute performance put on by a UFO in front of the Viscount. Capt. HULL was no longer a skeptic!

Months later he released the story to Civilian Saucer Intelligence in New York of which he was a member, in a letter to its president? John DuBarry. The story was published in the july, 1957, issue of the CSI NEWS Letter. The story was also printed in the Aug- Sept . issue of the UFO INVESTIGATOR.

When Capt.Hull. was killed in the crash this April , it was revealed that he had recently helped NICAP in its investigations, was a member of the organization, and was about to be appointed as special adviser. NICAP'S Director, Donald Keyhoe stated: " His loss will be especially felt because of his stand against secrecy and the careful investigations made by this valuable veteran airman . "

THE SIGHTING

By Capt W.J. HULL.

On the night of Nov14th 1956,I was flying a Viscount at high altitude from New York to Mobile, Alabama. We were above the cloud layer which were occasionally broken , giving us a glimpse of the ground now and then . At 10. 10p.m. E.S.T. when only about 60 miles from Mobile, my co-pilot Peter Mac Intosh and I saw what we though was a brilliant meteor. We were flying south-southwest and it fell across our path from left to right, first becoming visible at the top of the windshield . The Viscount has wonderful visibility upward.

I decelerated rapidly, just as any meteor does when entering the denser layers of the earth's lower atmosphere. We expected to see it burn out with the customary flash which pilots often see, but it abruptly halted directly in front of us!

It was an intense Blue- white light , approximately seven or eight times as bright as Venus when this planet is at its brightest magnitude.

I shouted, " What the hell is it, a jet?" His first thought, of course was that the object was a diving jet fighter which had turned away from us and in

departing , was giving us a view right up into its glowing tailpipe. Instantly I knew this could not possibly be an airplane. I have seen the glow of too many jet pipes at night not to recognise one when I see it. It was not the right color; it did not diminish in size, as a departing jet fighter's exhaust should have done; and it remained motionless ahead directly in front of us, how far I cannot say, but it must have been quite a few miles.

" Bates Tower, this is Capital 77. Look out toward the north and west and see if you can see a strange white light hovering in the sky."

" Capital 77, this is Mobile Bates Tower. We are unable to see much of the sky because of the thick cloud layer. Do you think the object is in our vicinity?"

" Affirmative. It looks like a brilliant white light bulb, about one tenth the size of the moon . It is directly ahead of us and at about our altitude or slightly higher. We are right over Jackson, Alabama and have descended to 10,000 ft. Please initiate a call to Brookley Field Tower (an Air Force field 20 miles southeast of Bates Field.) and ask the controller if he can see it in their big Radar scope." (We did not have the military frequency crystals in our transmitter to work Brookley Tower .)

Just after this exchange , the object began to manoeuvre. It darted hither and yon, rising and falling in undulating flight, making sharper turns than any known aircraft, sometimes changing direction 90 degrees in an instant, and the object did not grow or lessen in size.

Mac Intosh and I sat there just completely flabbergasted at this unnerving exhibition. I thought of calling the passengers over the public address system , but the object was dead ahead of us and putting on its performance in an area whose arc was not large enough to enable anybody in the cabin to get a view of it out the side windows.

After a half a minute or so of the dancing, unorthodox flight , the object suddenly became motionless again and hovered dead still. We were simply confounded by this.

Bates Tower called back " We are trying to raise the Brookley Tower"

Right at this moment the strange light began another series of crazy gyrations, lazy 8's, square chandelles, all the while weaving through the air with a sort of rhythmic , undulating cadence, the likes of which neither Pete nor I had ever seen . Then , apparently content at the consternation which it had wrought, the object shot out over the Gulf of Mexico, rising at the most breath taking angle and at such a fantastic speed that it diminished rapidly to a pin point and was swallowed up in the night .

This unearthly exhibition probably went on for at least two minutes, according to our best judgement. I glanced at the clock and noticed that it read 10.12. The most puzzling thing about the whole occurrence, aside from the dancing flight, was that the object, whatever it was, had remained at the same distance from us throughout the performance. How do we know this? It never increased in size, and yet we were bearing down on it at more than 5 miles a minute in the Viscount. If it was in view two minutes and performing in one area we should have been at least 10 miles closer to it. Now, any object that flies certainly looks different when viewed at such a great variation in distance. So this UFO must have managed to remain at the same distance from us throughout the entire display.

If you know southern Alabama you know that it is pretty desolate country, with few inhabitants and only a few small hamlets between Mobile and Montgomery up in the middle of the state. We were above the clouds, precluding any reflections of searchlights from below. I have seen hundreds of advertising searchlights playing on clouds, and this was nothing remotely related. Likewise I

lights playing on clouds, and this was nothing remotely related. Likewise I am summarily ruling out aircraft (at least the ones we know), balloons, missiles, or any other earth-launched device within my ken. The one thing which I can't get over is the fact that when it came, it came steeply downward; when it departed after its amazing exhibition, it went steeply upward! Now I ask you, is this machine based on earth?

I followed up this spectacular sighting after landing at Mobile, the control tower operators had reached Brookley after a slight delay, but the controller had seen nothing, and since no night flights were in progress the surveillance radar had not been energized at the time.

PART 3 THE CRASH .

Saginaw, Michigan,- It was the night of April 6th, Easter Sunday. I was just dropping off to sleep. My clock radio hadn't shut itself off as yet and the news was on. I hadn't been listening but suddenly a certain statement by the commentator brought me out of my daze. The newscaster had just said; "This is probably the worst airplane crash in Michigan's history." Now he had gone on with the other news.

I switched from the Chicago station to WJR in Detroit just in time to hear the announcer say; "Stay tuned in for more details on the tragic air crash near Midland." Midland being a neighboring city, I was now sitting up.

At the time, it still hadn't dawned on me that this undoubtedly involved a commercial airliner, nor did I even think of the Tri-City Airport, (which serves Saginaw, Midland, and Bay City) in connection with the crash.

I had to wait a full three quarters of an hour before mention was further made of the tragedy. I was then completely startled to learn that the plane which had crashed was a Capital Airlines Viscount and that it had happened while landing at our own Tri-City Airport. I have flown in and out of Tri-City many times on Capital Viscounts.

The time was now 3 a.m. and I was wide awake. I knew I had to get some sleep since I was scheduled to fly out of Tri-City Airport that morning-- on a Capital Airlines Viscount!

With the aid of a couple of sleeping tablets I was able to go to sleep and slept quite soundly until the next morning.

On the streets the news boys were yelling "Extra" and I bought a copy on the way to the airport. The Headlines read: "47 DIE HERE, SOME OF TRI-CITY AS AIRLINER CRASHES AND EXPLODES." The story went on to say .

Forty seven persons, many from Saginaw area, died in a fiery crash last night when a Capital Airlines New York-to Saginaw four engine Viscount crashed and burned as it approached Tri-City Airport at Freeland. There were no survivors. The Civil Aeronautics Board rushed a team of investigators from Washington to probe the crash, one of Michigan's worst tragedies. It was the nation's worst civilian tragedy in 1958.

Capital Airlines officials in Washington said 15 of the victims were from Michigan, three from Saginaw.

The crash of Flight 67 was timed by the Civil Aeronautics Authority's weather station at the airport as 11.19 p.m. . The huge airliner, loaded with home-ward bound Easter holiday vacationists, had stopped at Detroit and Flint.

It was carrying 44 passengers and a crew of three.

An emergency morgue was set up in a Dow Chemical Co. hangar at the port.

most of the bodies were burned or mutilated beyond recognition . There was no passenger list available immediately, but officials identified the crew as; Capt. W.J. Hull, First Officer Earl M. Binckley and Hostess Ruth M. Bonecke of East Aurora, New York. Capt. Hull had been with the Capital since 1941.

The airliner crashed and burned about one-half mile southwest of the port as it was making an approach to the north-east- southwest runway . The crash occurred on airport property .

Cities and counties- big and small alike-- poured men and equipment into the Tri-City Airport area. Saginaw received notice of the fatal plane crash at 11.25 p.m. by 11.36, the " disaster" signal had been flashed to all hospitals and agencies in the Saginaw -Bay- Midland county area.

The Saginaw County Sheriff's Dept. rushed both their available cars to the airport at once and alerted sheriff Kackmeister and Undersheriff W. Franklyn Brooks. Brooks took along a walkie-talkie and worked keeping stretcher bearers moving and coordinating emergency vehicles.

Six cars and 11 policemen left from City Police H.Q. Police Chief Yule was on hand to direct operations.

Saginaw Auxiliary Police stopped at four Saginaw schools on the way to the airport to pick up 50 stretchers stored there.

The Saginaw Fire Dept. rushed 2 squads a 5 pieces of equipment. The Tittabawassee Township Fire Dept. and Dow Chemical Co. also sent men and trucks.

At this point we close the story as related originally in the "OLYMPIC UFO REVIEW OF SAGINAW" of Octt 1958.

It merely adds another story of further concrete proof that pilots of aircraft have seen and witnessed the UFO and their strange behaviour. and in the case of the unfortunate and excellent pilot Capt. W.J. Hull he had the integrity and courage to say so even if before he he disbelieved in them .

THE FLYING SAUCERS.

Recently I recieved an interesting communication from a New Zealand corres-
pondent . Following my reference to the propelling motor with the synchronized
lengthening and shortening of radius, as previously mentioned. He says. that the
apparatus must be one called the "Dean Device", invented by Mr. Norman L. Dean
of Washington , D.C. U.S.A. In 1956 he applied for a patent and it was grant-
ed in 1959 under No. 2.886.976. This model consists of among many other t
Things , of two ~~courters~~ rotating substances on shafts which are rotating in
a slight frame , The most important feature is that the power produced is
obtained by moving the two centres of rotation , These centres have no sub-
stance and are only geometric concepts, as they are easily pushed around be-
cause no power is required. A small solenoid, activated by a commutator, moves
the frame carrying the two substances, at the required moment . Thus the de-
vice will convert a rotary movement into a movement in one direction. Mr.
Dean's engineering data show that amotor of 150 HP may develop a thrust of
6,000 pounds. Both the "Dean Device" and the " Hullberg Device" thus transe
form a rotating movement into a movement in one direction. But apart from the
similarity of effect, the devices function on the basis of 2 different prin-
ciples, and the constructions are , in fact, widely different. Thus, it is a
question of two different inventions. It is possible to buy copies of the pa-
tent of the " Dean Device" in most patent agencies, and persons who are in-
teretsted may get thoroughly acquainted with all details(U.S. Patent No.
2.886-976- Appl. July 13 1956- Serial No. 597805).

Many experiments have beenmade with the electrostatic fields, with a view to
a practical exploitation of lift fro-space ships. By means of very strong
electro-static charges , it has been possible to keep various materials float-
ing at rather high altitudes. However, the powers are far too slight to lift
both materials and charges. On the other hand it is possible to construct an
electro-static " free energy" motor. The same construction may be used as for
the magnetic " free energy" motor. Instead of magnets, strong positive charg-
es are placed in a circle around the rotating shafts, on which a material may
be placed which is attracted. This will then have to be insulated on the side
turned away from the direction of the motion, and the insulation is bent a
little in front of the material so that no dead point will arise. But the mag-
netic motor is far more steady in operation.

Air and space vessels may also be propelled by means of ~~ultra~~sonic waves or
ultrasonic shock waves. Ultrasonic waves may exercise a very strong pressure
on a variety of materials when they vibrate in resonance with the atomic os-
cillatory vibrations. (it will often be possible to use the corresponding
harmonic vibrations),. In space ships, the ultra-sound willthen only have to
be in resonance with the materials that are placed above the resonance sources
so that the upward pressure on these materials will propell the ship. Today
it is possible to produce ultrasonic waves of more than 20.000 million cycles
per second and with velocities exceeding 4.000 metres per second. Among the
methods of producing ultrasonic waves is that of exposing piezo-electric cry-
stals (quartz) of specific forms to electromagnetic waves or to ^achanging
electricfield of high frequency. The ultrasonic waves may be reinforced by
passing through a semi-conductive or paramagnetic crystal, possibly under ad-
ditional influence from magnetic field , high frequency electricity, and

electromagnetic waves . If coherent waves (masers and lasers) are used it is possible to produce powerful ultrasonic shock impulses. By means of ultrasonic waves it is possible to erect an invisible wall through which it is not possible to fire a shot. If the space ships are shielded by these ultrasonic waves they cannot be shot down and collisions between the vessels may be avoided. Particularly for voyages to other stellar systems, it will be of great importance that meteors and meteorites do not hit the vessel, but in this connection a special frequency synchronization is required with electromagnetic waves as carriers for the ultrasonic shock waves. This may also be used as a weapon of defence, where it is possible with light as the carrier wave, to paralyse or strike down a person. Unfortunately , the vessels have the disadvantage in flight that the functions of electric apparatus are troubled or stopped and magnetic materials are influenced. Powerful ultrasonic waves may cause the electrons to vibrate with compression and strong expansion resulting in a greatly reduced density . The behaviour of electrons in metals follows the static rules of Fermi, according to which the energy of the electrons depend on the density. It is not until the vessel has passed that the electronic vibrations cease and the energy is once more normal, the electric installations resuming their functions. In magnetic materials, the ultrasonic waves may cause magnetic resonance in the electrons, with periodical disturbances of their spin and circulation which cause alterations, for instance, in a compass needle in some cases . Also vessels propelled by special processes in magneto-hydrodynamic plasma have these secondary effects . Thus , we see that there are certain similarities between ultrasonic shock waves (quasi-sound) and the magnetic shock waves (quasi-magnetism).

Fantastic quantities of universal free energy are generated by special processes in hydromagnetic plasma. When hydromagnetic plasma has reached a sufficiently high temperature; when the magnetic fields surrounding the plasma and produced in it, are sufficiently powerful and correctly placed ; when the large wall-in quantity of plasma is correctly placed in relation to the Earth; and when the mechanical influences are right; then the hydromagnetic plasma will establish a very specific form- the critical form- and then form a flowing quasi-magnetism hitherto unknown will be created in the plasma.

Under normal laboratory conditions, this flowing quasi-magnetism will alter the form of the plasma in a fraction of a second, and thus the creation of the quasi-magnetism ceases immediately. It has been an extremely difficult task to identify the conditions in which form of plasma may preserve its stability.

Firstly, the outflowing quasi-magnetism may be used, by means of specific processes , for supply of energy. During the creation of the quasi-magnetism , an independent powerful field of gravitation is established. Moreover, it is possible to obtain a not slight propulsion in a direction which is determined by the placing of the plasma form. Both the independent field of gravitation and the flowing quasi-magnetism, may ionize the molecules around the space ship where they are formed . The form of this space ship must necessarily correspond to that of the form of plasma, i.e. it will have to be very large and long- almost shaped like a cigar .

The field of gravitation established around these plasma ships is of a nature differing widely from the fields of gravitation around the vessels propelled by mechanical acceleration . Actually, string fields effects are produced besides the ionization , which means that an observer on the Earth, who is located in

another strength of the field , may believe that the vessel is very luminous owing to the alterations in the frequency of the electromagnetic waves. Moreover, a hazy light may appear around the vessels owing to the ionization .

The unipolar flowing quasi-magnetism may reach very far. Electric functions take place on the basis of the adaptation occurring between the loaded molecules and the basic field on the spot. The small variations in the strength of the basic field that may occur at the earth surface and in the atmosphere are, in general, of no importance to the development of the electric phenomena. However, the unipolar flowing quasi-magnetism prevents free motions of the electrons and all electric appliances cease functioning. That this is the case cannot surprise any ufologist. It is one of the best known secondary effects of the passage of ufos that all electric functions are disturbed or entirely suspended. Only if it is possible to make a rapid determination of the polarity of the quasi-magnetism and to interpolate an equally strong magnetism of the opposite polarity, will it be possible to compel the electric appliances to resume their functioning. As far as I am aware, the very strong quasi-magnetism of the large cigar-shaped space vessels flows out in a horizontal plane . If a space vessel of this type tilted over and took a vertical position the very powerful flowing quasi-magnetism would be able to paralyse even very strong electric appliances.

I imagine that many scientifically interested ufologists would like to know more of the branches of research that are connected to this new quasi-magnetism. The research itself , the experimentation, and the exploitation of the universal "free energy" by means of the hydromagnetic plasma have been kept severely secret. But numerous experiments are made with hydromagnetic plasma all over the world. so it will nevertheless be possible to find here and there some if the information that are actually of interest to us. I shall refer to a couple of scientific treatises, which in fact do not say much on the subject in a direct way, but which give nevertheless a few hints that the scientists are well aware of the new unconventional powers that interest us.

The first prize for the best treatise on gravitation offered by the Gravity Research Foundation , New Boston . N.H. U.S.A. , was awarded in 1961 to Winston H. Bostick, Professor of Physics, Head of the Dept. of Physics, Stevens Institute of Technology, Hoboken N.J. for a treatise with the title : " The Gravitationally - Stabilized Hydromagnetic Model of the Elementary Particle" Professor Bostick considers an elementary particle to be an electro-hydromagnetic whirl formed by an independent wire which has been gravitationally stabilized, electrically charged and conductive. This wire has the shape of a spiral and rotates in a way that produces the dimensions in the whirl model which corresponds exactly to the elementary particle in question . Part of the independent gravitational energy of the wire contributes to preventing alterations in the form, which is necessary for a stable elementary particle. The aim is then to shape the hydromagnetic plasma in such a way that it corresponds exactly in shape of an elementary particle and its rotation, but only on a larger scale. All masses are considered to be exclusively of an electromagnetic nature and otherwise determined by the independent field of gravitation. Professor Bostick mentions the theory of a continuous creation of energy and mass in the universe. Reference is made to the theory of Ernst. Mach, that the properties of inertia in any individual mass in the universe are due to an existence of the total number of masses in the universe. The own energy of all

elementary particles must be viewed in this light . The hydromagnetic plasma creates an extraordinarily great number of varying forms which have yielded very extensive information of a nature that such it has not been possible to predict them theoretically . The hydromagnetic plasma has a tendency to create threads of thin "filaments". Professor Bostick deals with some of the physical properties in a number of plasma forms. Attention is also called to the fact that further details on the phenomena induced by the gravitationally stabilized plasma threads cannot be given in the treatise in question. Finally, Professor Bostick states that in the hydromagnetic plasma there must be a hidden or overlooked magnetic moment, a hidden or overlooked angle ~~moment~~, and this must be the explanation that hidden ~~and~~ or overlooked extrapositive and negative charges may arise in the plasma. Nor is it possible to imagine any other explanation from a scientist, as he cannot produce an explanation in contradiction of the law of maintenance of energy, which the exploitation of the free universal energy actually does.

In Scientific American, of April 1965. Henry H. Kelm and Arthur J. Freeman deal with many interesting phenomena in connection with intense magnetic fields as strong as 250,000 gauss. I just mention a few points. The following information is given : " One of the most significant scientific advances of our age has been the discovery of macroscopic quantum states, or systems of electrons that in the macroscopic dimensions exhibit the property of waves that are coherent, or all in step. Since intense magnetic fields are capable of selectively influencing the basic constituents of matter and the quantum laws that govern their interaction, such fields have already begun to play an important role in studying some of these dramatic macroscopic quantum effects" The powerful electric current transmitted through the plasma, results in a rapid oscillation of the individual atomic particles of the plasma between the electric poles . The light electrons move faster than the protons and the neutrons. Under the right conditions, the electrons may take the form of a spiral-shaped coherent waves which may have the same properties as the electron-magnetic whirl in an elementary particle, only so much more powerful that it corresponds to the greater macroscopic dimension. Thus, an independent gravitationally stabilized field is created during the emission of a strong quasi, magnetic current. This may quite well be described as " dramatic macroscopic quantum effects. "

Kolm and Freeman briefly mention that work is also done in laboratories investigating the stability of ball lightning. If a plasma with a high temperature and surrounded by a powerful magnetic field is exposed to a so-called plasma shock, in certain conditions a very peculiar field may be created, which suddenly moves around in an apparently intelligent way. It is not a magnetic field, but it displays nevertheless several characteristic field effects. It generally gives off a light- often a rather hazy one- and often greenish. The phenomenon frequently occurs in connection with air and space ships that are propelled by processes in electro-hydro-magnetic plasma. In ufology, they are designated as telemeter discs. They are not dangerous. It is known that ball lightnings consist of strong, static, electric field. But a field of this type would be dissolved much faster than the ball lightnings actually are. And a purely static electric field would not be able to move in the way that the ball lightnings are known to do. As the movements of the ball lightnings are much like those of the telemeter discs, it is supposed that the ball lightnings consist of a conglomeration of a powerful static electric field which is

prevented from being dissolved by a basic field similar to a magnetic one.

" Shock Waves and High Temperatures" is the name of an article by Malcolm McChesney in Scientific American of Feb. 1963. It gives a good insight in the efforts of science to create very high temperatures in hydromagnetic plasma. Reference is made in particular to hydrodynamic shock waves and to compressions of the plasma in order to create the high temperatures . The last paragraphs touches lightly on th points which are of particular interest to us. It is said here, among other things: " Experiments with the pinch effect were plagued from the onset by unstable magnetic forces that distorted the plasma column, eventually causing it to break up. To counteract these forces and stabilize the plasma , it was found necessary to create a magnetic field inside and along the axis of the column". When a hydrodynamic shock wave pressed the plasma to the centre a new phenomenon was created, which was called a hydromagnetic shock wave. This hydromagnetic shock wave displayed properties which was in complete contradiction to the recognised laws of physics.

In recent years, a great number of articles and books have appeared concerning the study of hydromagnetic plasma. Although the processes in the plasma which are of importance as a propellant for space ships, are kept severely secret for military security reasons, so many scientists are engaged in the study of hydromagnetic plasma that it will always be possible to find some information of interest somewhere if only one knows where to look for it. I have just another couple of small examples.

In Science Newsletter of 19th Dec. 1964, in an article concerning results of research for 1964. the following statements was made; " an important step toward controlling hydrogen fusion reactions for peaceful purposes to provide unlimited electrical energy was taken when what is called " burnout" was achieved in laboratory experiments ." And perhaps the best example . A small item in Science News Letter of 6th Nov. 1965 which says: " Scientists at Lockheed Aircraft Corporation try new techniques in research with the ionized gas. plasma, which surrounds space vehicles re entering the earth's atmosphere and accounts for the brief communication blackouts during astronauts' final descent. Secrets of its behaviour are expected to provide a new source of power for sending man into space". In fact, nobody can demand any clearer hints concerning this research when the results are not allowed to be published. Here reference is made both to the " blackout" phenomena and to the new source of power for space vehicles in connection with the plasma.

Where do the enormous quantities of energy have their origin, which are developed in connection with mechanical acceleration and with the processes in hydromagnetic plasma? Actually we get more energy than is used for the processes. Do these free energies arise from nothing? Is there only one hidden potential in the universe? A space continuum, a universal field, a relativistic basic field, or whatever name is preferred. If the hypothesis of a unit potential is accepted it must be recognised at the same time that this unit potential must have a great variety of properties as its influence on the physical world takes place in several fields. Consequently, it is not possible to reject the hypothesis of several potentials with varying properties. Common properties are: the potentials are mutually transcendental , which is a property they also have in relation to the physical world, and the physical world to them . Transformations from one potential into another or into the physical world may take place in certain ,critical states. When elementary particles

transform one or several potentials they receive energy for motion, with a secondary product in the form of a magnetic field. Therefore the gyromagnetic rate is of great interest to science. (Gyromagnetic rate: the relative proportion between velocity spin and magnetic field.) The celestial bodies also transform potential. In fact, the field of gravitation is due to a deficit in potential in the vicinity of the celestial bodies.

Many years ago, when Ernst Mach advanced the theory now generally recognised, that inertia properties of any mass within the universe are determined by the existence of all other masses in the universe, he pointed to a very important property of the potentials which is that they seem to act independently of physical space and time; they act instantaneously everywhere. The new cosmological energy of Fred Hoyle aims at the exact expression of the energy of an elementary particle both in relation to the total masses of substance of the universe and in relation to the localized field of gravitation. Although potentials are instantaneous and independent of physical time and space the idea cannot be excluded that they are subject to other time and space values, or that they possess entirely different properties in their place. According to the new scientific concept, the expression "time" is only to be understood as "level of energy". In 1945, J.A. Wheeler and R.P. Feynman proved the existence of electrons having both recoiling and counter-recoiling time, corresponding to the positive and negative charge. However, the theory of symmetry of time of the particles is not accepted by all scientists.

Thus, the potentials may be transformed into our physical world level as energy (or matter: the theory of continuous creation of matter). But masses of substance and energy from our physical world may also be transformed into other world levels of other potentials, and they then exist outside of our physical space and time. The masses can be brought back into our world level, and it is of no importance to return whether this happens on the earth or somewhere else in the universe. I can clearly imagine that many people will think now, 'Well, H.L. is telling us many fantastic things, but now he is going too far'. But that is just what I am not doing, for this is not something that I am inventing. Those things are ancient history, at any rate to some people. Already in 1930, the famous and distinguished English scientist P.A.M. Dirac propounded the theory of the so called "extraordinary world", which was described as "holes" in our physical world with which our matter could not collide immediately. Even the theory of several multi-dimensional spaces existing concurrently in the universe, was advanced. And later on numerous theories of anti-worlds, mirror-worlds, symmetry-worlds, mental worlds, etc. have been stated. Anti-worlds etc. are not to be understood here as matter having an opposite electric charge (this is the most general use of the word "anti-world"), but as a world entirely outside our physical world. Also Russian scientists are interested, and I remember an article by a Russian scientist producing the theory that gradually as we humans shot masses of matter into the anti-world the equivalent in masses of matter from the anti-world would automatically make their appearance in our physical world. (I have forgotten his name, but the article was also printed in one of the booklets "Cahier G" published by Centre Européen pour les Recherches sur la Gravitation, Via Borghesano Lucchese 24, Rome, Italy, if anybody would like to verify it).

But what was this? If we shoot matter into the anti-world? Then, can we do so? Yes, we can. If more energy than required is induced into electrons in order to bring them up to the velocity of light (and it is not a question of an

infinite quantity of energy). then the electrons disappear entirely without giving off any energy. The only result that could be traced, is some magnetic field effects. For instance, experiments are made with refrigeration of masses of matter to approximately the absolute zero, with influence from powerful magnetic fields and with irradiation by frequency doubled light by means of the crystal technique. Good results have said to have been produced even with great quantities of matter , which it has even been possible to bring back in an entirely different location . The information on these things is very infrequent as these experiments are not without danger because after the completion of the experiments some powerful potential strengths may remain in the place . which may not only provoke field effects but even transformation of substances (ships, planes). A territory for experiments is said to have existed east of Florida. To an ufologist, these things should not be unknown as innumerable observations of space ships are made, as they appear and disappear in the place.

For the sake of good order, I just want to emphasize that, in my opinion, not all ufo-reports are due to observations of terrestrial flying saucers.

Many ufologists all over the world have attacked the authorities, and especially the military services, with the reproach that information on the flying saucers have been kept secret. But this secrecy has its good reasons. The individuals all over the world as well as societies have not been ready to understand new things and to secure a quiet development of the social structure if the new natural forces were taken in use on a large scale. If the ufologists want the secrecy to be continued they have just to continue their attacks on the military services and other authorities. But we ufologists are to a certain extent prepared for future events. Let us now show that we are responsible citizens . Let us express ourselves and our comprehension of the difficult situation in which the authorities have placed themselves by the long secrecy and let us give them our full support in the measures that are required for the the publication, for that is the only way of promoting our cause.

ANOTHER THEORY OF SAUCER PROPULSION ..

The following is yet another theory of the means by which the saucers propell themselves , the writer is a well known electrical engineer , and a very good friend of the Editor. He is also the past and newly elected Treasurer of CAPIO His theory differs from that previously of the lengthy one given by Hans Lauritzen, whose main thesis is that of electro -magnetism . whilst this article tells the idea of that of static electricity . .

We all watch television. Like the Beatles, Bob and Dolly Dyer , and Barry are more real to us Australians than Jesus Christ. Recently, as often happens, Barry disagreed with the answer to a question, as to what electricity means . Julius Sumner- Miller, my fellow employee of the A.B.C. was called in to decide. But, again, as often happens , he did not decide.

I claim that the word "ELECTRICITY" was given to a phenomena observed by the ancient Greeks, which has no relation to the current force which we use today. It was produced by direct friction on an insulator, not by chemical or magnetic means.

My father served his time with Siemens Shukertwerke, during the renaissance of science, in the last decade of the nineteenth century. One of his fellow apprentices was a boy named Nicola Tesla. Tesla was a very remarkable man . A lucky man indeed , for he was able to spend his whole life, and finally sacrifice that life for his ideas. Scientific- not political . At the climax of his experiments. his laboratory. high in the Alps , was destroyed by the forces of nature he had succeeded in harnessing , and his death led to the advancement of their control.

My Father renewed an old friendship with him, when he stayed with him in 1936 during a two year visit to Europe. He told many things to me. mostly still very confidential about Tesla's accomplishments.

As you all know, the " electricity " we use from batteries or a power point has no affinity for the mass of the earth. For certain reasons an artificial connection is made to water pipes.

But static electricity , made by friction, seeks it's neutralisation in the earth , no return circuit is needed . Nature stores up this force in the atmosphere until it becomes overloaded, and flashes to earth. as lightning. And my friends, I can tell you that there are some more mega amperes in one flash of lightning, than that all that realised by the Snowy Mountains network .

Why do you think that the Wimshurst Machine and the Tesla coil have disappeared from all schools and public places, during the last fifty years?. Not because they are obsolete, but, because they are too advanced for public knowledge.

The new science of bionics is being developed to enable man to use his own senses to control forces of nature which cause phenomena which are too powerful, or too fast for our unaided reactions.

Our bodies have better radar, better computers, better brains, than any machine that will ever be made. We have developed many converters , machines which turn radio waves into light, or sound. Machines which convert the Sun's energy, stored in water and vegetation into heat, power, light, sound and other useful things.

Propulsion and Static Electricity (2)

We cannot explain anything, except by reference to something we have seen. I could not make you visualise a new colour, as different to red and blue, as these are to each other. I have to say "it's a foot long, and very hard." But one day, we develop a radio receiver, and find the air full of waves from distant stars, static noises from electrical equipment. Then we develop a Geiger counter, and find radioactivity is everywhere. But until we suspect these things and make the apparatus capable of translating their effects into something which will be visible, seeable, feelable, hearable, or tasteable. we don't know it is there.

So, when a child first finds out what happens in a motor engine, he is quite disappointed, to find it is quite easy of comprehension, by analogy with other physical phenomena. But there are many things we can't explain, many are considered supernatural, which are definitely not so.

I believe in the supernatural, I believe in the Creator, and therefore I believe in miracles, I believe HE can do all things. But I don't expect Him to do conjuring tricks, for my amusement.

Yes, my friends there are supernatural things, but Flying Saucers are not created, they are made, by men. Angels don't need machines to visit us.

Given a new development of a basic natural force of propulsion, and the men properly trained to control this force. flying saucers are no more wonderful than helicopters.

Our electric current is the same, whether it is in the form of light, heat, magnetism, gravity, or "electricity". Static electricity, from the Greek, Amber, and to rub, is something else again. And it is this something else that advanced scientists are bending to the use of mankind. but lead masks will not shield us from it.

Every new scientific development has found the men ready to meet its challenge, ten years ago a man could not have walked in space, passed through the Van Allen belts, in fact we did not know there were Van-Allen Belts. We didn't even know the size or shape of the earth till satellites told us. And, by the way, we are still firing "space vehicles" like crackers. But electricity, by its own limitations cannot leave the earth, its home. but it can be developed to the immense force needed to launch rockets, carrying only steering fuel, and payload.

And, believe me friends, I am sorry to disappoint you, but flying saucers are very real, and natural. But don't let this lose any of your healthy interest in sightings and research. Already we are making UFOs a basis for human frailty. I have even read and heard scandal, jealousy, and worse libel among members of groups, which disgust me.

The writer ends abruptly here. maybe. his disgust was too much to continue. Could be he feels as we do. that to talk about Space Brethren. coming among us. only to find the above. and claim we are leaders of movements which would WELCOME THEM as BROTHERS. is rather incongruous with our earthly behaviour. No wonder they don't want to meet us or more Contact us. Perhaps the very close contact of their presence with us would defile them. or maybe the reverse it would be so powerful. it would "burn us up". So before we talk about contacts lets get right with each other first.

COMET-LIKE OBJECT SEEN IN STH. AUST. SKIES.

TULLY " SAUCER " SEEN IN THE U.S.A.

The "Sun" Oct 27. 1966

New York. Wed. A " grass-scorching" flying thing visited Long Island at the time of a similar visit to Tully, Queensland. last April .

The disclosure was made today by the head of radiation control in the area, Dr. Seymour Becker .

Dr. Becker said he had investigated 14 reports of UFO sighted along the eastern end of Long Island. But the most baffling was the " grass eating " report this occurred in a small fishing village of Amagansett.

Two women, he said had reported seeing a large round object with a red light on top in a field near their home on April 14th .

He investigated the incident that night but found nothing to report. But when he returned to the spot the following morning he discovered a 30 ft. circle of flattened grass . He also saw that nearby trees had been stripped of bark" just like you would peel a banana."

Dr. Becker said the sight reminded him of a photograph he had seen of the flying saucer nest in Tully Queensland.

That picture described pretty much what I found" he said.

He added " I am completely mystified,"

The official said that he had also received several reports since March of a "large , brilliant white light" that travels along the Atlantic shore and turns inland to hover over two large ship- to - shore radio towers.

The eastern end of Long Island is a favorite summer resort area.

Last night Detective J. Kelsey and his two sons, sighted an object, so they alerted the police.. Five police who rushed to the scene said they too , saw the object. It was described as " round and very high with a red and green

green colour with yellow in the middle." Police later said they believed it was a satellite.

MYSTERY BALL FOUND IN U.S.A.

Wisconsin . (Tomahawk)

A mysterious hard metal sphere found in a heavily wooded area near here has been sent to Air Force experts for indentification .

A police spokesman said yesterday the object " showed the effects of intense heat, as though it had come back through the earth's atmosphere."

Hitting it with a hammer failed to dent it, and scraping it with a file failed to scrtach it.

A similar object found at Mt Sruart station, 210 miles north of Broken Hill in July 1963 was identified as a fuel cell from a space vehicle.

There have been at least four similar objects of this nature found in Australia. mostly in the Central and Northerh parts. Some of these have never been officially identified. and in some cases no countru has made claim to them. however we do not feel that they are " saucer " parts. and are more likely to be some of the 500 or so piced of man made ironmongory'up there'which have fallen to earth . However we are open to hear opinions. either way .

U.S.A. ADMITS THREE MYSTERY SATELLITES ORBITING EARTH.

Advertiser. 2/11/66.

Three small objects orbiting the earth did not appear to have been launched by any nation the US revealed today . The satlellite situation report, published biweekly by the Us. Space Agency , reported that debris had been discovered in orbit " which had not been identified with any launching or country of origin" It ws the first time since publication of the report began in 1958 that UFO had been reported in earth orbit.

The report whilst published by the civilian space agency is compiled by Space detection centre of Nth. Amer. Defence. (NORAD)

Informed sources said NORAD believed the objects were meteoroids from outer space in orbit , but had hesitated about announcing their presence for fear of causing talk of flying saucers.
