

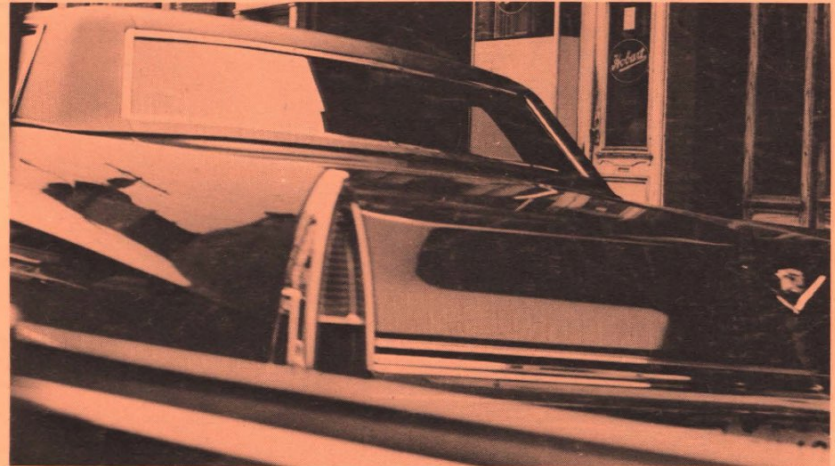

# Editorial Notes

## ABOUT THIS ISSUE

You will note we are adding a stiff cover with this issue, in a further effort to continue to improve SAUCER NEWS. We thank the hundreds of readers who have sent many compliments - and many brickbats.

## THE 1968 CONGRESS

The fifth Congress of Scientific Ufologists, held in Cleveland, Ohio on June 21-23, 1968, was successful and rewarding, according to a broad sampling of members polled.

Closed sessions, (for members only and to which the public was not invited) were held on June 21st at the Inn America. Allen J. Manak acted as Chairman.

Included in the business of the Congress was:

A report on the Fanning Committee on Recording. Mr. Ralph Fanning reported that the year's study by the Committee had indicated that a recording project, such as had been suggested by the previous Congress, was unrealistic, because of the thousands of man hours and funds which would be required. Unless a sizable grant could be obtained and such a project operated on a scale which it was determined would be required, the idea should be deemed unfeasible. Fanning distributed the voluminous report to all members.

An open letter to the assembled delegates by Edward Biebel. Mr. Biebel stated he hoped the Congress would take a much more definitive and positive approach than it had done previously, and that he felt the Congress could accomplish much

more than it had done to date.

A review of the Constitution of the Scientific Union of UFO Organizations. After a discussion of the subject the Chairman turned the matter of review over to Committee.

A review of the question of a Consolidated Statement of Ethics. After discussion, a motion was that the Permanent Organizing Committee and the Operations Committee meet jointly and create or draft a form of by-laws for the conduct of future Congresses was adopted.

Attendance report. Chairman Manak informed the second session that of the 58 organizations which had been informed of the Congress, 34 had responded. Twenty-two organizations were represented at the current session.

A bid for the 1969 Congress site. Gray Barker was called upon to introduce Ralph Jarrett, president of UFO Investigators, of Charleston, W. Virginia. Jarrett made a formal bid that the next Congress be held in Charleston, and this was accepted unanimously by the members.

A discussion of MIB (Men In Black) cases. The Congress heard first-hand reports of interference by mysterious individuals who attempted, by threats, coercion (and in one case even shooting at a researcher) to silence members of the Congress. A special commission was set up to study all such cases during 1968-69, though it was stipulated that the actual committee remain anonymous for reasons of security. An avenue of communication was established, whereby those reporting such cases should communicate the information direct to the editors of SAUCER NEWS who would forward it confidentially.

Revision of the Code of Ethics. Among revisions to this code were:

Provision that no organization or individual convey the impression that they constitute or represent agencies of legally established authority; that they not give the impression of conveying exclusive authority in any matter; that they should oppose abuse of investigative capacity by unscrupulous or irresponsible individuals engaging in practices that violate the necessary standards of scientific discipline; that the free flow of information is the indispensable prerequisite of scientific Ufology.

The Condon Resolution: A specific Congress resolution, unanimously accepted by the Congress, concerned the work of Dr. Edward U. Condon, and read as follows:

(1) That Dr. Edward U. Condon is a distinguished scholar and distinguished American.

(2) That Dr. Condon has, by his unflinching good cheer and uniformly courteous consideration of those around him, made a valuable contribution to the progress of Ufology.

(3) That it is the sense of this Congress that Dr. Condon has been subjected to the unnecessary and unmerited burden of irresponsible personal vilification, which has needlessly complicated the already impressive challenge of his office.

(4) That the leaders of the Congress appreciate Dr. Condon's apparent intention of full public disclosure in the conduct of his present investigation.

Therefore, it is the hope of the Congress that the close cooperation and mutually amicable relations between Dr. Condon and itself will remain in the future, as in the past, a source of constant encouragement - a bright light on the horizon of tomorrow's Ufology.

#### MOTHMAN "CONGRESS"

Of somewhat less import was the First Annual Mothman "Congress", held at the Pleasant Point Resort, Point Pleasant, W. Virginia, over the Labor Day weekend.

Organized by editor Gray Barker, the "Congress" represented not only a social get-together for many top Ufologists, but provided the opportunity for researchers to do on-the-spot investigation of the many UFO and "monster" reports which have come from the area. Members also visited the site of the Silver Bridge disaster, and looked into the legend of the "Curse of Cornstalk", whereby the town of Point Pleasant was condemned by the murdered Indian chief for roughly 200 years. Ironically this time was said to elapse, almost to the day, at the date of the collapse of the bridge. Members examined carefully areas where "Mothman", a huge bird-like creature with glowing eyes, was seen by witnesses.

Members occupied one entire evening with a "saucer watch", which proved to be unsuccessful be-

yond the sighting of some unidentified red lights - and a mysterious cloud of smoke which nobody could explain.

### A 'FIASCO' HAS TWO SIDES

As a follow-up to our Editorial Notes, titled, "NICAP Condemns Condon", in the Summer Issue, we are reprinting the following article, published in the May-June, 1968 issue of THE A.P.R.O. BULLETIN.

The author, Mr. L.J. Lorenzen, is Director of the Aerial Phenomena Research Organization, 3910 East Kleindale Road, Tucson, Arizona, which is an organization of international scope, and is also the oldest civilian UFO research organization now in existence, having been formed in January, 1952. This article appeared in the official publication of the afore-mentioned organization, having been published continuously on a bi-monthly basis since A.P.R.O.'s founding.

Mr. Lorenzen, until approximately a year ago, was a saucer technical associate at the Kitt Peak National Observatory at Tucson, Arizona. At that time, he retired from the Observatory in order to devote full time to the UFO problem.

This is an attempt to answer many queries received at this office concerning an article in a recent issue of LOOK magazine regarding the UFO study at the University of Colorado which described that study as a fiasco and a \$1/2 million trick.

To begin with, I wish to make it clear that I do not question the author's (John Fuller) integrity or accuracy of reporting. I do feel, however, a study to point out that the piece is obviously slanted to support a particular viewpoint and that there is another side to the controversy. I will now proceed to play "The Devil's Advocate" in order to bring out this other side. My source of information consists of numerous conversations with principals in-

# THE NATURE OF UFOS

It is doubtful if any in the ranks of organized Ufology have ever speculated that some extraterrestrial UFOs might be advanced "sensory organs" serving a multi-dimensional spacial intelligence. Yet, this is a very real possibility.

Such "sensory organs" would act as the "eyes", "ears", "nose", etc. of a non-material spacial intelligence. They would be artificially created for various purposes and tasks. One of their collective tasks might be to collect and relay information on the multitudinous civilizations in space back to the "master intellect" for usage. Conjecture as to their specific or ultimate mission is largely pointless since human experience is thus far so limited. These sensory probes, of course, would require no "pilot" or "crew". The vehicle itself would be the sensory organ or probe. Such vehicles could "sense" human emotion and experience just as we can sense changes in our environment and measure them with instruments. This type of extraterrestrial intelligence would have no use for direct contact with mankind.

Less advanced ETs (extraterrestrials), employing more primitive instrumentalities might elect to contact human beings, however. But the "contacts" would not be the ETs themselves, but merely their semi-robotic creations - "quasi-men" so to speak, some form of very refined synthetic men. It is improbable that they would risk sending their own among us no matter how proficient they are in self-defense. There would be too many uncertainties. Their use of such "proxies" could be compared to our use of biological substitutes such as artificial hands, arms and legs. Their "proxies" would probably be so perfect that it would be impossible to distinguish them from real human beings. Most likely they would be "programmed" with some type of rudimentary intelligence simulating human thought. They could express all of the ideals in

human thought but none of the subtleties which characterize the human thinking process and determine individuality. Many of the "contactee" stories could be explained in this manner. Many of the supposed "space people" have consistently emphasized man's warlike nature and have stressed "Peace", "Love", "Freedom", "Understanding", "Brotherhood", etc. - the rudimentary human thoughts and ideals - the powerful emotions of our times. And their expressions, in most cases, go no further; they present no concrete plans for helping mankind. Obviously, they are not here to "help" mankind, they are simply here to probe and observe and collect information. They have no desire to involve themselves or their "proxies" directly in human affairs.

Still other ETs could be visiting us completely undetected. If they do not conform to our specific space-time frame of reference we could not perceive their presence. There are so many things beyond man's meager powers of perception and comprehension that we would probably be either completely dumbfounded or horrified if we were suddenly blessed with total awareness. Man is a pathetically limited creature and only one thing transcends the harse realities of his existence - his thought. If man could not think beyond himself he would be an awfully dull and unprogressive being. He can imagine things that he cannot yet physically perceive or create.

Thus, in the ascending order of intelligence established throughout the universe it seems that approximately six major levels of intelligent technological life has evolved: (1) Those that are still confined to their own world and are largely unaware of the universe about them, (2) Those that have become aware of the universe and are taking their first steps into space, but are still confined to their own solar system or "local" space (example, Man),

(3) Those that have become truly universal or at least "galactic" and can span the interstellar gulf to explore and study other solar systems and worlds, (4) Those that still retain their physical form but employ only remotely controlled devices in their exploration of space, (5) Those that have shed their physical form and have transferred their total knowledge and experience to non-biological instrumentalities, and (6) Those that have developed beyond all material form and instrumentalities - Pure intelligence and multi-dimensional space, the theoretical end-point of evolution. This ultimate evolutionary product would be virtually omniscient and would be capable of manipulating the very "fabric" of the universe.

More than likely, most civilizations and cultures die out or decline before reaching the third level of development. The third type of intelligent life would utilize space vehicles requiring living pilots and crews and also unpiloted probes after reaching their destination.

The fifth level of intelligence would employ remotely directed probes of a more advanced type than those of number four. The "sensory organs" as discussed in the first two paragraphs would be the products of the fifth level intelligence.

Six needs little explanation since it requires no material instrumentalities. "It" or "they" would make their influence felt in many subtle ways throughout the universe.

In all practical respects, the fifth and sixth levels of intelligence would be immortal; they would only pass out of existence through violent, unnatural means. The third level of intelligence would have lifespans measured in the tens of centuries. Most extraterrestrial UFOs probably are of the third type.

At this point it would be appropriate to examine the two forms of evolution possible in this universe that eventually culminate in intelligence: (1) The organic evolutionary sequence, and (2) The inorganic evo-

# MEN in BLACK, CADILLACS, DOPPELGANGERS and LASER BEAMS - - - *you name it and we have it in Jersey*

**B**efore I begin to recount all that has been happening, let me state that I am only reporting. I have seen nothing, or has anything strange happened to me. Sometimes I wish it would, for I feel sort of left out.

I have no reason to doubt my informants - and as for one of them, I had better not, FOR SHE IS MY WIFE!

The beginning of this report might be said to start on the battlefields of Korea, for it was while one of my informants, George Smyth, was fighting in that land that he became interested in UFOs. He and two other soldiers saw a flight of two saucers sweep over them, and reported the incident to their commanding officer. They were requested to report to Intelligence. When they did so, they were then told that they were suffering from battle fatigue. Regardless of this "battle fatigue", however, they were not relieved of their front line fighting duty.

Smyth then became very interested in the UFO phenomena and began to seek information regarding it. When he returned to civilian status he proceeded to study it from his home in Elizabeth, New Jersey. He also became a SAUCER NEWS subscriber.

On October 10, 1966, two teenage boys of Elizabeth reported observing a very tall (more than 6 ft.) being, which was green in color, while they were walking in nearby woods. Before they ran away, however, they also noted that the green-headed being had two small beady red eyes and a mouth which seemed to be drawn into a horrible grimace. The creature had no nose, ears nor hair on its head.

Smyth learned of the incident and joined a crowd of people who were questioning the lads. As he did so he also noticed a large black car parked a good distance from the crowd. While the excited crowd questioned the teenagers, he observed two dark-visaged, heavy-set men who e-

merged from the car, leaving one of their party seated behind the wheel. The two men joined the crowd as Smyth watched them and once or twice he heard them question the boys. Smyth also noticed they had a slight slant to their eyes and spoke with an accent which he was unable to identify.

Smyth informed SAUCER NEWS of the incident and a S.A.U.C.E.R.S. team investigated the report. Smyth, who remained outside the home of one of the lads while the team interviewed the witness inside, again noticed the same black car parked down the block from the house. Again the same two men got out; they came close and watched the house until the SAUCER NEWS investigator emerged; then they returned to the black car. Other witnesses in the neighborhood reported to him later that the car remained in the vicinity for at least ten minutes before it departed.

Two weeks after this incident, Smyth received a mysterious phone

call. An unidentified voice told him to give up UFO investigation and then broke the connection. A year passed without any further incident. Then on Thanksgiving eve of 1967 a black car stopped in the dark, a short distance from his home, while Smyth was in front of the house, walking his dog. A swarthy looking man got out of the car and approached Smyth, calling him by name, as the dog arched its back and began to howl like a wolf. The man, who never identified himself, told Smyth that he wanted all the material on any UFO investigation he had obtained. When asked for identification, the man would give none. Smyth refused to show him anything.

"Are you sure you want it that way?", the swarthy man asked.

"Yes", Smyth replied.

"You'll be sorry!" stated the visitor, as he returned to his car, the door of which opened weirdly for him without his touching it. The door had no handle which Smyth could observe. He was able to get a glimpse of a red upholstered interior before the car moved off silently, as if it might have been electrically powered. He also noticed a gold "V", with a lightning bolt superimposed upon it, decorating the door, and the license plate which bore the number, "U 1496".

Smyth reports that the man's eyes seemed to have a hypnotic quality and tended to affect him in an unexplained manner.

The next day a battered car driven by a black-leather-jacketed man wearing large sun glasses almost ran him down in a deliberate manner; the day after, a very tall, white-faced man, with silver-colored hair, followed him to the usual bus he took for work, passing him as he got on the bus, and turning the corner. As the bus reached the corner, Smyth observed a large dark car speeding away. The next day was uneventful until an evening telephone caller advised him to give up his interest in UFOs. Then the phone went dead.

About a month later, a man phoned, claiming to be a Major White, of "UFORICE". When Smyth said he had never heard of any such group, White said it was a California organization, that he was visiting New Jersey and had received information about Smyth from a friend. He

knew a great deal about Smyth, including incidents which the latter had not mentioned to anybody. White refused to identify the friend, explaining, "I do not wish to get him into any trouble."

The next day Smyth observed the same white-faced man with the silver-colored hair following him again, this time from work to the bus stop. Once again he disappeared rapidly. A week later Major White called and asked him if he would be interested in seeing a UFO. When Smyth answered in the affirmative, he was told to be at Montana Park, in Elizabeth at 8:30 P.M. Smyth complied, but no UFO appeared as promised.

About the same time the above events were transpiring, a Mrs. Caporino, of Jersey City, reported to me that she had sighted a UFO out over the ocean, from the shore at Ocean Grove, New Jersey. The sighting was published in the ROBINSON REPORT (A limited UFO news report service made available to the author's colleagues in the UFO investigative field. It is not available to the general public. - Ed.) and carried in several UFO publications. Mrs. Caporino later reported to me that just after dark on three consecutive Fridays at exactly the same time (7:00 P.M.), a large black car with red upholstery pulled up under a tree, which left the car in the dark, and on each occasion two men got out, mounted the steps of her house, stood in the darkest spot of the porch after ringing her bell. One of the men carried some type of case with him.

Mrs. Caporino did not answer the door on any of the three occasions, after peeking through the venetian blinds to ascertain who was ringing. She was too frightened to find out who the men were, and also unable to get their license number and other pertinent information.

#### CHASED BY MEN IN BLACK

A person in North Jersey (who did not wish his name or research group identified) called me about the same time to give me some unusual information. This man, Ron (I am permitted to use only his first name), had extensively investigated the Wanaque Lake Sightings and had continued to investigate the entire area.

He was particularly interested in a convent which had previously

housed children each summer, but which had closed down after the wave of strange sightings; and a college in the same area which had also closed its doors, and erected a steel barricade on the road leading to it.

Ron was driving over the roads surrounding the reservoir when suddenly his companion in the car called his attention to a parked car with some kind of electrical equipment set up in the rear seat. The equipment, with extensive dials, illuminated in a bright, bluish light, reminded him of a large amateur broadcasting set a friend of his once possessed. As they drove on, discussing this development, he noticed a roadside telephone booth in his rear view mirror. A man suddenly emerged from it and darted to a car across the road which began to follow him. Ron drove up a dead end road and stopped. The other car drove past him, with only one man, carefully keeping his face in shadow, inside it. It parked fifty feet beyond Ron's car. When Ron turned his car around and drove off, the other car took off after him.

Ron drove into the town of Wanaque and parked outside the police station. The other car drove about 100 ft. beyond him and also parked. This alarmed Ron and his companion further, so he made a U-turn and left the town, with the other car in hot pursuit. An expert driver, Ron managed to elude the pursuing car in turnpike traffic and swiftly drove home. Since this incident he requested and received a permit to carry a gun.

#### THE IMPOSTERS

During the first week of May, 1968, a car pulled up across the street from the home of George Smyth. Three men stepped out. Although Smyth had never seen the men before, he quickly identified them from a picture published in SAUCER NEWS. They were John Keel, Gray Barker, and James W. Moseley - or so he thought. Smyth, who had observed the men from an upstairs window, ran down the stairs to greet them, only to see their blue Volkswagon speeding away up the street. It bore no license plate.

Feeling there had been something strange about the men, he telephoned Moseley and Barker, who told him they had not been away from home

all day. He checked again with the picture. Although the men bore facial characteristics identical to the men in the picture, including Keel's copious beard, Smyth knew there had been something generally wrong with what he now believed to be an impersonation. Then he remembered: Barker and Keel had been of the same height - that is the impersonators - while Moseley was the shortest of the group. In reality the actual order of height in the picture was Barker-Moseley-Keel! Whoever the impersonators had been, they had "goofed" on heights.

A week later, while he was passing a parking lot on his way home from work, three men stepped out of a black Plymouth, of 1960-62 vintage, and which bore West Virginia license plates (strangely distorted, since the "West Virginia" was printed at the top instead of properly at the bottom - while the numerals, "1436", have since been determined not to exist on such plates without some other type of prefix or designation).

The men accosted him as if they knew all about him, even though they asked him if his name was George Smyth. When he replied in the affirmative, they displayed S.A.U. C.E.R.S. membership cards, bearing the names of Arthur Davidson, Thomas Murphy and Walter Mulberry, (or Mulbarbery). They next asserted that they were well aware

of all the events which had happened to Smyth and which he had related to the SAUCER NEWS staff. They simply wished him to relate once more the events as they had occurred. Smyth then reviewed for them the entire series of strange happenings, while one of the trio wrote in a notebook. Then they urged him to continue to report all future events to SAUCER NEWS.

Later, when Smyth spoke to Gray Barker by telephone, he learned that neither Barker nor any of the staff had disclosed any of the information to anybody!

#### OUR HOUSE IS WATCHED

During the last week of May the strange series of events seemed to be drawing closer home, when my wife, Mary, mentioned during a supper conversation that she had noticed some odd people near the house each morning as she went marketing.

A large black car was parked near our front door and a statue-like, tall, corpse-white man with very light hair was always standing beside it. The car, she told me, had bright red upholstery. The tall man, however, had not caused her any alarm. But a dark, swarthy-faced man in a dark or black suit had looked piercingly at her as she emerged from the outer door, and then had peered into the vestibule, as if to determine if anyone else were com-

ing out. Since this had occurred on four successive days, it was getting on her nerves. She had hesitated to mention it, she told me, for fear I would think she was "imagining things", and assured me that she actually had seen the men.

I pondered on this, for I knew that when I left for work at 8:00 each morning, I had seen nobody on the street. Whoever the men were, they were avoiding me and showing up half an hour later, when Mary went shopping. Why did they not try to frighten ME, for I had been involved with the SAUCER NEWS investigation of the experiences of Smyth, and other strange events?

Suddenly I remembered that James W. Moseley's name was on my mail box. He did this so that he could receive mail from certain confidential sources at our address - and then he often stayed for several days at a time at our house when engaged on research projects which involved much reading and concentration (thus he could avoid telephone calls and the many personal visits by friends and people interested in interviewing him).

Could it be that the visitors were checking up on Jim and were relatively disinterested in Mary and me?

I immediately phoned Jim and told him about the men, though noises on the line led me to believe the line was being tapped. Jim told me to instruct Mary to secure the license number of the car, should

she see it again, and suggested I familiarize her with the Cadillac emblem so that she might recognize it (Both Jim and I knew that most of the men-in-black reports included a large car, usually a Cadillac.).

The phone call evidently set off another series of happenings which are difficult - or impossible - for me to evaluate.

Next morning when Mary went to shop, nobody stood in the factory entrance as usual; nor did a large black car with a pale-faced individual occupy its usual position. However, as she returned home, she noticed Jim Moseley standing in the middle of the nearby street acting almost, it seemed, like a traffic policeman! She stood and watched him for perhaps three to four minutes, while he turned and looked in all directions, apparently without noticing or recognizing her. Mary had the impression that he was attempting to see what would happen if he exposed himself, and that he evidently did not wish her to approach him. So she entered the house. She gave it little further thought, except for thinking that it was a very early hour for Jim, who usually arose about noon, to be in Jersey City (Jim at that time lived in Manhattan and the trip to Jersey City would have consumed about 45 minutes).

A grocery item she had forgotten to purchase made it necessary for her to return to the market, so she went out again. Jim was still standing in the same position, still looking in all directions and not appearing to notice her. She observed that while he was dressed in the usual business suit, he was also wearing the gray topcoat he had worn the past winter. She knew that I had gone to work dressed only in a business suit, and that I had remarked how warm the morning was. In fact, the topcoat was the only circumstance which really struck her as odd about his being at the intersection.

She went to the store, and when she returned, she again stood and watched Jim at his "station". Then she entered the house and proceeded

to clear the breakfast table, with the thought that Jim probably would ring the bell, have a cup of coffee and a chat before he returned to New York. She also again wondered how Jim had managed to get up so early - for he liked to do his UFO research late at night, and into the early morning hours, away from the pressures of his office and the many telephone calls.

In about ten minutes the phone rang and it was Jim on the line. He explained he was still in bed, but has awakened and was wondering about the "MIB" situation. He had an impulse to call her briefly before going back to sleep. He asked her if she had looked outside yet to see if the men were still there.

Without explanation, she asked Jim to hold the phone. Then she ran outside (our windows do not overlook the street). Jim or the man who had looked exactly like him, was no longer there, and, for the first time, this was very upsetting to my wife. She wondered if she were "imagining things", due to her worrying about the visitors. She ran back into the

house and tried to explain what she had seen to Jim; though by that time she had become quite shaken.

Although he couldn't quite understand just what she had seen, Jim advised her either to stay in the house, or dash over to her neighbor's house and stay with her until I returned that evening.

When I returned I found a very frightened wife, who by that time had regained her composure and was able to give me all the details in a coherent manner.

I called Jim, and although I kidded him about Mary's seeing his doppelganger\*, I secretly wished that I were able to get my hands on the impersonator. Later that night I called Gray Barker and gave him all the details, and he tended to connect it with the Smyth report of the impersonations described above.

Days passed without further incident. Mary, however, had begun to leave the house the same time as I did on weekdays, and would visit various neighbors while I was away. On Saturday, May 18, Jim called to

\*Doppelganger is a German word describing the exact double of an individual. It is not so much associated with the etheric or astral body of an individual as it is

a kind of physical double. Although this phenomenon is said to occur rarely, it is firmly implanted in occult tradition. I personally feel this case involved an impersonator,

carefully made up to resemble Jim, with the rather glaring mistake of wearing a topcoat in summer

make arrangements for Timothy Green Beckley and himself to visit us and make copies of some of my many tape recordings. It was agreed that they would arrive early (for Jim), at ten o'clock the next morning.

As they approached my house, they observed a black Cadillac parked in front of the closed factory next door. They decided not to stop, but to drive around the block and make some passes in front of the house, to observe and take pictures (Jim had thoughtfully brought his camera). They also noted the swarthy man Mary had described, standing in the factory entrance. They managed to make only two passes and to secure the two pictures accompanying this article, before the man evidently fled; on the third circuit of the house both he and the Cadillac were gone.

Mary has identified the man in the photograph as the same person who had looked at her so piercingly on those five mornings.

At this writing (July 1st) there has been no repetition of any of the visitations. Yet, on June 11, George Smyth had called me with a report which seemed to tie in with Mary's experiences.

He asked me what I thought Jim had been doing in Elizabeth that morning, and I replied that he had not been there, for I had just talked to him at his apartment, having awakened him in order to get a telephone number which I urgently needed.

Smyth then related what had occurred. He had been on the bus, going to work as usual, and had observed Jim standing in front of the Cartarret Hotel in Elizabeth, as he passed there on his usual route. Jim, he

said, had smiled and waved at him. Smyth stated that Jim had worn a gray suit, with striped tie and white shirt (Moseley's favorite mode of dress). The only irrelevant information concerned a trench coat "Jim" carried on his arm, which Smyth described. Jim has never worn that type of coat, to my knowledge.\*\*

A day or two after the incident, Smyth began to hear from acquaintances who told him they had been questioned by a very tall, gray-haired man, who also made inquiries about him. All but one of the people had asked the man for identification, whereupon he departed abruptly without further questioning. Those questions by the tall stranger had one thing in common: all were employees or owners of the various eating places Smyth frequented near his place of work. Only one person, the operator of a hot dog stand, had spoken at length with the person. Apparently the tall man already possessed a great deal of information about Smyth (although the stand operator knew much about Smyth, it seemed he was unable to supply the man with anything he did not already know!).

During the early evening of June 15, Smyth's phone rang and a "cultured voice", as he described it, advised him to stop all saucer research and to discontinue any connections with Barker, Moseley, Beckley, Keel and myself. Further, he should not attend the forthcoming Congress of Scientific Ufologists in Cleveland. If he did not comply with the requests, he would deeply regret it, the voice warned.

Since Smyth does not know Beckley, nor exchange information with him; and since he did not plan

to attend the Congress, his caller was evidently partially misinformed.

On the 18th Smyth called to tell me he had been unable to go to work that day, due to a particularly upsetting occurrence. Early in the morning, as he was preparing to leave and catch his bus, his dog had begun howling like a wolf while it looked out the window. Smyth went to the window and looked out. On the other side of the street was a large black car, with one man in the driver's seat, and two people in the rear, both of which were attending some kind of electronic equipment. One of the men apparently wore earphones, while the other raised a contraption which he described as "a crystalline wheel", with a two to three foot rod extending from it. The wheel began to glow with a yellow light; then the light suddenly concentrated into a yellow beam, which shot out striking Smyth in the forehead, as he felt a blast of heat. Before he blacked out, he was able to note the license plate on the car. It resembled a U.S. Government plate, and bore the identification, "U 1436". The car quickly left after the ray struck Smyth. When he recovered consciousness, he was suffering a splitting headache. The headache persisted throughout the day and two more "blackouts" occurred.\*\*\*

#### THEY HAVE BEEN IN CLEVELAND ALSO

During the Cleveland Congress, a rather odd incident occurred in the luncheon room of the Wild Boar Inn, a part of the Sheraton Airport Motor Inn, where most of the attending delegates were lodged. On the afternoon preceding the Open Ses-

\*\*Much evidence points to Moseley's having a double, or that a person of the New York area looks very much like him. When I appeared with him on the Long John Nebel "Versus" show early this spring, John chided Jim for not speaking to him when he encountered him in a

passing taxi cab. He told Jim he had rolled down the window and spoken to him, and that he (Jim) had looked him directly in the eye, but had apparently not recognized him at all. Jim has been on various Long John radio shows many, many times, and surely would recognize John. Jim

told John he had no memory of the encounter, and apologized for not speaking - though he could not possibly imagine how he could fail to recognize the famous radio personality - G.B.

\*\*\*Smyth's dog behaved similarly to "Bandit", the dog belonging to Newell Partridge, of West Virginia, who complained the animal might have been kidnapped by "Mothman", in November, 1966. He said the dog

"howled like a wolf" prior to his seeing two glowing eyes near his barn. Men in black were also connected with the Mothman sightings, as will be brought out in my forthcoming book. Readers may also

remember that Al K. Bender, who first publicized the three men, suffered painful headaches (See "Flying Saucers and the Three Men", now out in paperback, published by Paperback Library, Inc. - G.B.

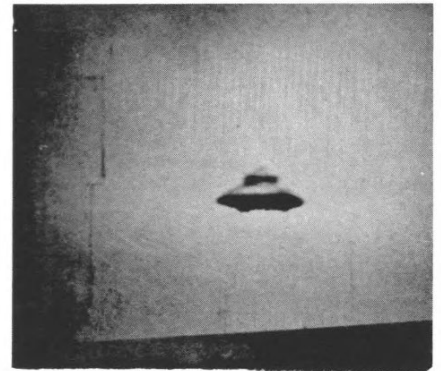
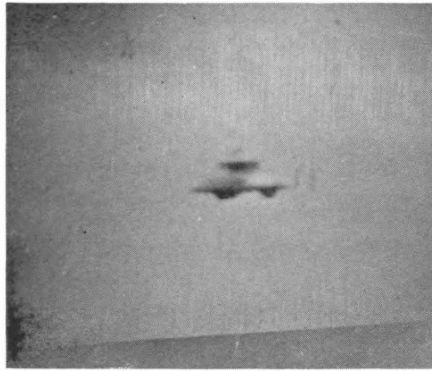
sion, a group of delegates met to have lunch prior to departing for the Valley Forge High School auditorium where the public lectures would take place.

The tables, each seating four, were occupied by the elite of the Congress, such as Captain Robert Loftin, Moseley, Beckley, Ralph Fanning, Gene Duplantier, and Allen H. Greenfield. Mary and I, along with Barker and Roseanne Maruca (a bibliographer, interested in Ufology, who has just completed cataloging the huge UFO publication collection of Moseley - and is trying to track down the many items which recently have disappeared).

Mary suddenly glanced toward a table, directly behind me, and near the door of the Inn. In a voice, which suddenly had been raised, and which startled all of us, she exclaimed, "Concentrate, everybody, we are being watched. Quiet everybody! We are under surveillance!"

Barker looked up from his late breakfast to determine what was causing Mary's concern. He said nothing, but just stared past me. As quickly as propriety allowed, I managed to turn my chair and my head to look in that direction. I saw the backs of two male figures, leaving the room in a most precipitate manner.

Mary, who had observed the men for some minutes before speaking out, and then, in her fright, had cried out rather loudly, told us that a very pale, blue-eyed man, with silver-colored hair, had been staring at Barker from an uncluttered table near the entrance of the room. He had been dressed in a black turtle-necked sweater, and had been accompanied by another man, in a

black suit, and who wore large sunglasses. The latter had not been looking at our group; but when Mary made her exclamation, he appeared to be startled, quickly arose, and beckoned for the silver-haired man to follow him.

And that is just about all of it,

up to this writing. Barker did call me, immediately after he had returned home from the Congress, noting that he had been unable to evade the constant "tailing" of a car driven by a dark-clothed priest, which followed him most of the way home from Cleveland. \*\*\*\*

\*\*\*\* Dr. Robinson does not have this entirely correct. My 6' 4" nephew, Donny Barker, accompanied me to Cleveland, though he did not attend the Congress, not being interested in Ufology and preferring to visit relatives instead. He is an expert driver and agreed to pilot my Ford Wagon most of the way in exchange for expenses. When we returned to West Virginia, he drove us to his home, some 75 miles south of Clarksburg. On the way back from his home to Clarksburg, I was tailed by a man in black, who I identified

as a priest, when I deliberately pulled off to let him pass. As he went by he gazed at me most unusually. I suppose that by that time (and after such a wonderful time at the Congress) my imagination probably was just getting the better of me.

After reading the above I asked Donny if he noticed anybody following us on the way back from Cleveland, and he at first had nothing to report. The boy usually doesn't talk very much, and it is difficult to get much conversation out of him. However, a few minutes later (I was visiting his

house at the time), he finally got around to telling me the following:

"You know, Uncle Gray, there was something queer about that trip back. All the time I was driving, I didn't say anything - you were liking the trip so much and telling me about saucers. I got the impression then, as I did all the time, goin' and comin' from Cleveland - as if there were somebody behind me all the time - only when I looked back, there was nobody there!" - G.B.

# The Crawling Lights

Normally Toledo, Oregon, is an extremely quiet community. Situated far from the bustling city of Portland, it is located in what can only rightfully be termed logging country. Yet the residents of Toledo and nearby Siletz are considered city folk to those husky backwoodsmen who make up the large percentage of home owners on Pioneer Mountain.

Typical of these residents is the Douglas Reeves family. Or should we say former residents, because they no longer occupy their former modest dwelling. In back of their decision to leave is one of the most harrowing and baffling UFO incidents to date. Their account may well go down in UFOlogical history as the first attempt by UFO occupants to observe the daily actions of a rather typical, hard working, Earth family.

A total of some 35 to 40 persons claim to have witnessed some type of strange phenomena near the Reeves property. This strange phenomena ranged from spaceship-like crafts, pulsating, doughnut-shaped lights

that crawled along the walls of the house, to strange stump-like creatures.

The beginning of these weird events on Pioneer Mountain was in early March of 1966. During a walk through the woods, the Reeves' 16-year-old daughter, Kathy, and a girl friend suddenly glimpsed from the side of their eyes an apparent fire burning in an open section of ground some distance away that had been cleared of trees sometime previous. Approaching closer, the teenagers noticed that instead of a fire there was some type of object hovering a few feet above the ground. The object, as the girls later described it, appeared to be giving off a "ruddy" glow which could be seen for some distance.

The object appeared to be dome-shaped with sparks and smoke flying in all directions, as if the craft were burning. Finally managing to get up some nerve, the two overly excited and somewhat frightened girls headed for their nearby homes to get some older witnesses to back up their observations.

Hurrying now through the woods, they suddenly found themselves confronted with what appeared to be a large searchlight beacon. Thinking that someone was either trying to frighten them or play a joke on them, they both picked up some rocks and threw them at the light's source.

Suddenly, and without warning, they found themselves surrounded by identical lights which seemed to be moving in on them from all sides. Now near panic the two raced at top speed to tell their parents.

On arriving home, minutes later, the two teenagers managed to blurt out to Kathy's mother, Evelyn Reeves, what had happened. At first Mrs. Reeves didn't take the girls seriously. She felt that they must be trying to pull her leg, not having taken seriously before reports of UFOs. However, she noted that they were extremely frightened and would not retract their story no matter how hard she tried to get them to.

After talking with her husband, and the parents of the other girl, Mrs. Reeves decided the best thing to do was keep quiet about what had

supposedly happened. After all if these weird things had occurred who would believe them? They figured that the entire family would be held open to ridicule.

However, had the family known about what was to happen that very same night perhaps they would have thought otherwise.

At about midnight, after everyone had retired for the evening, Mrs. Reeves was awakened from a sound sleep to find the air filled with a strange pitched hum like nothings she had ever heard before. Getting up to investigate, her eyes were at once attracted to the partly opened window of her bedroom. In between the curtains she could make out a light that appeared to be pulsating. As she drew the curtains apart, the entire bedroom was suddenly filled with a harsh glow emanating from what appeared to be a large object sitting in her yard. Suddenly all the rooms in the house were filled with the same glow. Likewise, appearing from nowhere, were strange doughnut-shaped lights which seemed to be creeping up the very walls of their dwelling.

By this time the rest of the family had also awakened. The high pitched hum was louder and more menacing than ever and the weird crawling lights were rapidly increasing in number.

Grabbing a gun from its rack in the living room, Mr. Reeves ran to the window and pointed it toward someone or "something" he thought he had seen moving outside. Suddenly the house sparkled anew with bright lights. Many more "crawling lights" also appeared on the walls and for a time it seemed as if the family would be overcome by hundreds of these strange doughnut-shaped lights.

Then the original reddish glow gradually dimmed and then disappeared; the humming sound faded away and the night was black and still once again.

Although the Reeves were very frightened, they still felt it to their advantage to keep their "invaders" secret. And with the dawn of a new day all seemed back to normal again. It was as if the previous night's happenings had been part of another world, totally separated from normal reality.

By and by the family forgot

about the strange sounds, the bright red lights in their yard, and most of all the lights that had seemingly crept up their very walls. They soon dismissed the entire affair, feeling it would be best to leave well enough alone. They felt as if the worst had passed and they could again live a normal existence.

But their hopes were in vain, for the weird sights and sounds soon returned to haunt their home on Pioneer Mountain.

In the weeks to come the Reeves family was continually shaken out of a sound sleep about two or three o'clock in the morning to find the entire house filled with a rosy glow which they described as being so intense that "you could read a newspaper by it". In fact these occurrences became so frequent and annoying that they finally boarded up their windows in an attempt to keep the lights out. Even this failed, and the crawling doughnut-shaped lights continued to creep up the walls.

On one particular occasion Mrs. Reeves happened to look toward the door leading into their darkened living room and saw a cloud about the size and shape of a watermelon, but transparent, just hanging in mid-air. It seemed to hover there for minutes before it dissipated into nothing.

It was at this point that the family agreed it would be best to call in outsiders to have a look at their UFO phenomena.

One of these "outsiders" was Delbert Mapes who told investigators how he had himself seen various lights and objects flying in a helter skelter fashion through some trees in the Reeves' apple orchard. He described the phenomena as consisting of small round disk-shaped objects, giving off a bright light, traveling at high speeds. He also indicated that they produced a high pitched hum that was almost inaudible.

Another of the witnesses was Max W. Taylor, a personal friend of the family. Taylor is a chemist employed by the Georgia-Pacific Corporation. At the request of Mr. Reeves he and a group of neighbors camped out on their property in an attempt to find a rational explanation for the phenomena. Although Taylor was highly skeptical when first contacted, he soon joined the

ranks of believers. For he was not on the site more than a half hour when he saw a number of strange pulsating spots of bluish light. According to Taylor and the other witnesses, one spot turned up on the outside wall of the living room while the other spot appeared at the opposite end of the home, on the outside wall of the kitchen. Surprisingly enough there was no apparent source for the light and no beam could be seen in between.

Making a call to the local police, Taylor brought in a deputy sheriff, Thomas W. Price, from Lincoln County. At about 1:30 A.M. Price arrived at the Reeves, and as he was disembarking from his squad car he glanced upward and saw a fast moving object that was flying from northeast to southeast. It was accompanied by a high pitched whine.

Writing in the police log, Price said that the UFO itself was orange color and appeared to be spinning on end. As it headed in a southeasterly direction the object suddenly came to a complete stop and then made a sweeping motion toward the southwest and disappeared over the horizon.

Deputy Price stated further that before this incident, "I had never believed in UFOs - but I can only report what I myself was a witness to. It actually made the hair on the back of my neck stand on end."

Other residents, likewise skeptical, also reported odd occurrences. Five or six persons, who the police termed "apparently sober" insisted that they had seen "stump-like" creatures moving across an open field near the Reeves residence on two occasions.

A 17-year-old high school senior, Douglas Whitlow, found himself being followed by an object down the Siletz-Toledo Highway. The object remained visible for nearly an hour over the area and witnesses told how it criss-crossed the open highway, following the auto's bright lights, at low altitude. The description of the UFO tallied with the objects seen on the Reeves property.

But perhaps the best look at the UFOs came from a group of six teenagers who told reporters they had viewed the objects through binoculars near the Reeves home. They described the craft as "oval-shaped with a string of red, blue

This is a follow-up to Mr. Greenfield's article in the Spring, 1968, SAUCER NEWS, where he recorded much terminology which has become a part of the language of civilian UFO investigators. **U**Fology terminology has more than one level. The terms described in our previous article are, to a considerable extent, in wide use. Those that follow may be less so, generally.

**ORTHOTENY:** Aime Michael's term for straight lines between UFO reports. This is an interesting possibility, particularly in conjunction with "leys" (see below). It is difficult to estimate the popularity of this term at present, but we gather it is somewhat less in use than "UFology".

**LEY:** Alignments between ancient monuments, from an old theory. Stick this together with the above and you may have something interesting.

**GRAPH:** An obscure term used, I gather, in connection with emotional "ups" and "downs". See our comments on "monger" in the previous article.

**ZAMN:** I kid you not. This term comes from a recent book, published by Saucerian, entitled Document 96. The term means "Zenith Articulated Modified Nuclear Power".

**GAZAMN:** Apparently, super Zamn. This one stands for Gravitation Anti-gravity Zenith Articulated Modified Nuclear Power, which tells it all right there.

**CONTACTEE:** Getting back to more normal terms (did I say "normal"?), I don't know how I missed this one last time around. I am indebted to John Harney who publishes a portion of his own terminology list in the March/April, 1968

issue of his Merseyside UFO Bulletin, which is being used in connection with this article, as a "memory refresher". Be all this as it may, a contactee is someone who (A) makes contact, or claims to make contact, with a being or beings from another world, or (B) perhaps only claims to have seen such beings, or (C) something approximating this.

**THE ETHERIC BEAM:** Coined by Dominick C. Lucchesi in the '50's to express the abandoning of the usual scientific methods of UFO investigation in favor of borderland sciences such as spiritualism, "4-D" etc. It might also be expressed that such a researcher has gone OFF THE DEEP END.

**HUSH UP or SHUSH UP:** I think these terms are used to describe the incomplete silencing of a UFO witness or investigator. Such a person, though he may be able still to talk about UFOs, is severely limited as to what he can tell. Of the two terms above, SHUSH UP probably expresses the least severe silencing. But when some witness or researcher is SILENCED, there is no talking at all, beyond, possibly the statement, "I can't answer that." The above usually comes about after a visit by the MIB (see below).

**MEN IN BLACK, MIB:** This term is with reference to a group of individuals allegedly out to silence UFO witnesses and investigators. Other terms in the same general area are "silence group" and "international bankers".

**MOTHMAN:** A strange creature allegedly seen in the West Virginia area.

**GHOST ROCKET:** This term is associated primarily with the wave of UFO reports over Scandinavia in the mid-1940s, but might be found in connection with any rocket-shaped UFO.

**FOO FIGHTER:** Another anti-UFOlogical term, as is the above. A name given to unidentified lights which followed military aircraft during World War II, prior to the coining of the term, FLYING SAUCER. U.S. airmen thought they were secret German developments and the Germans suspected they were ours.

Harney's article brought to mind another terminological problem UFOlogy has, that being the use of initials to identify UFO groups. Here are some explained:

**NICAP:** National Investigations Committee on Aerial Phenomena.

**APRO:** Aerial Phenomena Research Organization.

**ROAP:** Research Organization of Aerial Phenomena.

**SAUCERS:** Saucers and Unexplained Celestial Events Research Society.

**CAPIC:** Canadian Aerial Phenomena Investigations Committee.

**CAPIC:** Cleveland Aerial Phenomena Investigations Committee.

**APIC:** Aerial Phenomena Investigations Committee.

**NASI:** National Association for Saucerian Investigation (not to be confused with NASA).

## VICAR SEES SAUCER

In Bristol, England, the Rev. Anthony Millican, vicar of St. Christopher's at Brislington, told police and members of a local UFO group of an unusual saucer he had seen on May 4.

"It was uncanny", he said. "I had the strange feeling that it was in some way malignant."

The 40-year-old vicar and his wife saw the thing as they took an evening stroll through Arno's Park.

"We saw a light that grew larger and larger and for more than 20 seconds we clearly saw a transparent dome-shaped object that hovered above the grass and appeared to pulsate. Then it sped away.

"It was about 15 ft. in height. We did not approach - because, quite frankly, we were rather frightened."

## UFO DETECTOR

For several months Mrs. Candida Lycett Green, wife of a London clothing chain owner, waited patiently for her UFO detector to "Catch" a saucer, while her husband, a UFO skeptic, kidded her about spending six pounds (about \$7.00) for the device.

Mrs. Green is a member of a society called Contact, which meets bi-monthly at Caston Hall to discuss the UFO scene.

In early May, however, the detector "went off" for the first time,

but unfortunately Mrs. Green was out. She came home, however, to find her husband in what she termed "a traumatised state".

"When he heard it," she said, "he rushed out and immediately saw this light moving slowly across the sky, for about a quarter of an hour. Until then, he was a complete disbeliever. He didn't know what on earth to do when he saw it, and was really quite terrified.

(Editor's note: Saucer detectors which react to changes in local magnetic fields, apparently do really work. Ralph Jarrett, president of UFO Investigators, Charleston, W. Virginia, reports similar success, this witnessed by members of his family.)

## TRIANGULAR SAUCER

The following report comes from reader Stuart A. Zagnit, who interviewed a neighbor, a beautician, about a remarkable sighting she experienced.

At about 8:30 p.m., October 27, 1968, the witness was disturbed by a strange humming sound coming from somewhere behind her house. After waiting a short time to see if the noise would stop, which it did not, she decided to go out and investigate. She stepped out to see a huge glowing triangle, about 60 feet wide, rise out of a field in back of her home, and hover at about 1000 feet in the air. The object was in sight for about five minutes and during this time, it was seen to change color, but in a definite pattern. At first, the object glowed red, then from red to green, and from green back to red, and so on. The object followed no set flight pattern, however, it moved across the sky, according to the witness, to the left, back over to the right, hovered, and then flew quickly out of sight.

The object resembled no type of conventional aircraft she knew of; it pulsed violently during the time it was in sight, and with the exception of the humming noise, it made no noise.

It may be interesting to note that there are high-tension wires very close to the witness's home. Reminiscent of the sightings of September,

1966 at Exeter, New Hampshire.

After the object was gone, the witness, now greatly upset, called a friend of hers, and together the women went out to look at the field. While looking around for some proof that the object had actually been there, they came across three strange marks in the grassy field. These marks were not indentions in the ground, but rather discolorations of the grass in those three spots, which were triangular in pattern as the mysterious object had been.

The next day, when she went back to see them again, the marks were gone and no evidence left of the event remained.

Still not being able to believe what she had seen, she began asking neighbors if they had seen or heard anything unusual the night before. Everyone she asked knew nothing of any disturbance, including the owner of the field, who had not been at home the night of the sighting.

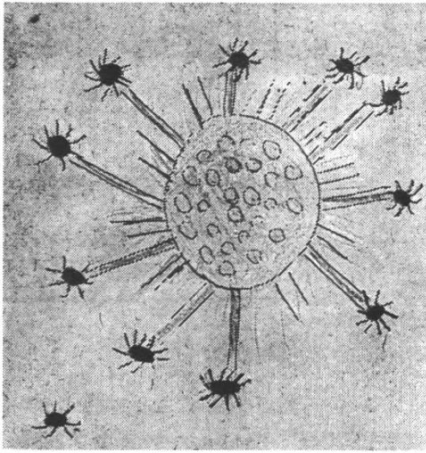

## UFO INTERRUPTS TV

The Editors are indebted to Harry M. Costello, of Ottawa, Canada, for his investigation of a spectacular UFO report and obtaining a drawing from eye witnesses.

The saucer, the second seen north of Ottawa in 14 hours, interfered with a family's TV reception and disrupted their supper on February 7.

The object was spotted three miles south of Deep River on the farm of W.J. McCarthy off the Wylie Road.

Miss Mary McCarthy, 65, a retired CPR wire operator said her 16-year-old nephew Lee Elliott, one of six children of Mrs. Dan Elliott, who also lives at the farm, had first sighted the object from the supper table.

Miss McCarthy described it as being extremely bright and about 16 feet in diameter. It remained in a stationary position on a hill she said about 1/4 of a mile from the farm house.

She said the bright yellow lights would dim at short intervals but that the object also appeared to have red lights glowing from its outer rim which seemed to leave and return again.

"When the object was spotted at 6:43 p.m., the television set went on the blink," she added.

Two of Mrs. Elliott's children, Francis, 8, and Jammie, 3, cried during the ordeal but older sisters Cathy, 12, and Margaret, 13, began to draw pictures of the object.

Miss McCarthy said, "I was more curious than scared. If the snowmobile was working, I would have gone to investigate."

"When the object disappeared about 40 minutes latter the television reception was restored," she added.

Miss McCarthy said she had telephoned the town police department and neighbors William Gleason and Mrs. Eddid Hogue when the object was sighted. The two neighbors arrived to witness the spectacle but the police cruisers came - after it had vanished.

Another sighting of an unidentified flying object was reported by

three Ontario Provincial Police officers about 6 a.m. Thursday.

"A brightly lighted" object was seen in the sky one mile south of Killaloe Station by OPP Constable Ted Wark. He radioed two other OPP officers near Barrys Bay who reported seeing a similar object. Barrys Bay is 40 miles south west of Deep River.

#### SAUCERS STOP CLOCK

Over Seattle, Washington nine flying saucers puzzled residents, affected pilot Rudy Malaspina's magnetic compass and stopped the clock in his plane.

The red lights soared back and forth about Seattle for more than 40 minutes Sunday night, July 7th. Thousands of callers swamped civilian and military telephones in the Puget Sound region. The glistening objects far outshone the stars.

Although they were clearly visible from the ground, the only comment released by the Federal Air Route Control Center in suburban Auburn, and local and military airfield towers, was that "we couldn't spot them on radar."

Pilot Malaspina was flying directly under the things when he spotted them.

"Four rockets were fired from these objects," he stated; "and they were not flares - they were rockets. Three of them hit southeast of Green Lake and one of them hit the southern tip of Green Lake."

He said the objects didn't just "dim out and fade away", but accelerated upward at tremendous speed.

"They were definitely aircraft," he said. "I wouldn't believe it myself but I saw it - and figure this. My magnetic compass was reading 300 degrees when I made my landing at Boeing Field and it should have read 130 degrees. And my clock in the plane stopped at 10:25 p.m."

Seattle police, probably in an effort to calm citizens, said they accepted reports that pranksters had attached lighted railroad flares to balloons and sent them aloft. The military and coast guard gave no explanation.

egg-shaped piece of rock with a shotgun. It was the only physical evidence to substantiate reports of burning objects falling from the sky and strange nude little men.

On Tuesday night, July 2, hundreds of persons in the area, which is near Joliette, reported seeing a tumbling ball of fire. In fact the phenomena were reported at the same time in several parts of the United States, from Vermont to Maryland and from the Atlantic to Ohio.

The farmer, Paul-Emile Desbiens, said that another farmer had found the stones still hot after a large burning object that illuminated the sky fell into a nearby field. A huge burned patch of grass was also left as evidence. He said he was guarding the mysterious stone until federal authorities could pick it up and analyze it.

But the stone was not the weird part of the happening. Provincial

police confirmed they had received several telephone calls on the same date, reporting that nude little men had been seen running along a country road.

Constable Marcel Vaudreuil said no men were available to check out the reports, and pooh-poohed the whole matter by saying: "People were just having illusions." He would not say how many calls had been received by the police.

In deprecating local citizens, however, he also was contradicting two members of his own police force.

Constable Michel Michaud told a reporter for Montreal La Presse that he and a fellow policeman did check on the nude men and arrived on the scene in time to see them jump into a ditch and flee. They gave chase but were unable to catch them. (Thanks to Gavin Neil Fergusson; source: Vancouver Sun, July 6, 1968.)

#### **PROFESSOR BELIEVES IN UFOS**

Dr. James E. McDonald, University of Arizona meteorology professor, said at a press conference in Los Angeles during March that he believes in saucers.

"I have no bright ideas where they come from," McDonald said. "It does not seem very likely that they come from other planets within our solar system."

However, he explained that doesn't mean unidentified flying objects don't exist because, McDonald pointed, "We may be in a very permanent state of development, and the fact that we can't explain them doesn't mean they are not possible."

He spoke of a number of UFO sightings he investigated and said one remained outstanding:

"There is a case on record in

New Guinea, where I had an excellent chance to check the facts and witnesses.

"This saucer appeared and witnesses could see a number of figures on top of the UFO. First, one person on the beach waved, and one figure on the saucer waved back.

"Then two people on the beach waved, and two on the vehicle waved. Finally, all 38 witnesses were waving and the four figures were waving back."

McDonald said those who saw the saucer and figures said they looked somewhat similar in configuration to humans, but it was difficult to tell their exact shape because of a golden glow which surrounded the craft.

Prof. McDonald was no doubt referring to the classic Father Gill case.

#### **PUERTO RICAN PHOTO**

SAUCER NEWS is happy to publish for the first time a photograph taken by reader Lester Rosas of Santruce, P.R. (See below) Following is the report of his sighting:

On December 23, 1966, I had awakened early to attend Misa de Aguinaldo (a Christmas season mass). When I returned home about 7 a.m., I decided to lay down for a nap.

The window in my room faces a vacant lot, so I have a very good view of the skyline from that vantage point.

I was removing my clothing when I suddenly saw a strange object in the sky. It was hovering stationary.

It emitted no sound, appeared about the size of a quarter held at arm's length, was dark bluish in color.

Luckily I had borrowed a telephoto lens from a friend, and had managed to attach this to my own camera, for I planned to make some photographs on the beach over the holidays. I quickly grabbed the camera and ran out into the back yard. The UFO was still hovering, and I started clicking the camera in rapid succession, as quickly as I could reset the shutter. I was trembling with excitement, and my hands could hardly hold the camera steady.

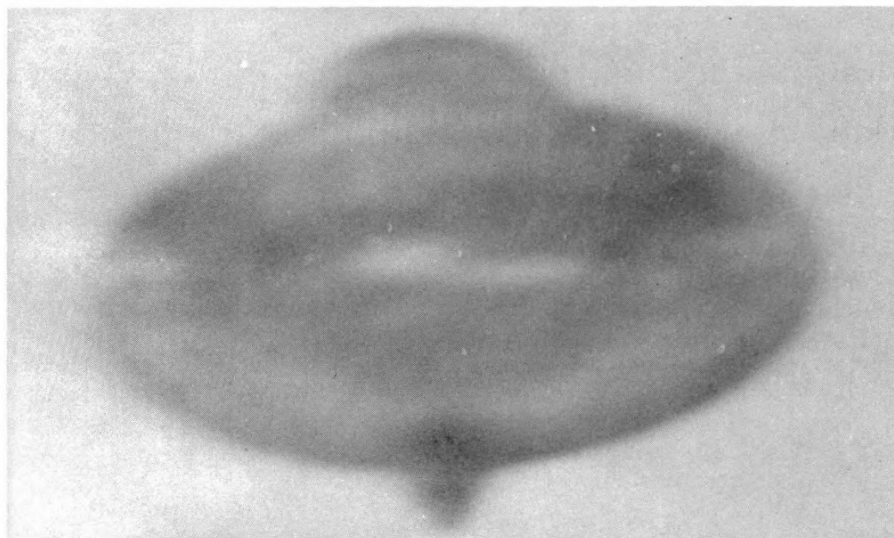
Suddenly the UFO turned from blue to red and sped away toward the North and the sea.

I had once before tried to photograph a UFO, without success, and, having used no tripod, I felt that the pictures would not come out. Consequently I delayed having them processed for two weeks, when news of some local sightings reminded me of the film. As I suspected, most of the shots showed only dark blotches and undefinable shapes. One of them, however, did turn out reasonably well, to my great joy - for with it I could prove my experience.

Comparison of this photo with those taken by George Adamski leads me to believe that the object I photographed was a similar craft. The print I am enclosing is greatly enlarged.

#### **'THE THING' STRIKES AGAIN**

In Stockholm, Sweden, the incredibly power "thing" had struck again, on April 8th, for the second

time making a huge hole in the ice covering a lake.

The first hole was discovered a few days previously in a lake near Malung, in the Dalarna District of Central Sweden. It was 700 square yards in area and had been made through ice almost three feet thick!

The second hole discovered, in a lake near Serna - also in the Dalarna district but some distance from Malung - was more than twice as big as the first one and through equally thick ice.

Police and military experts, called in to investigate, were at a loss to explain the holes. Frogmen were sent down at Malung, but found nothing in the lake that could have made the hole, but there was thick mud on the bottom.

"It could have swallowed up anything," an official said.

At Malund there were no traces around the hole, only big blocks of ice which had been thrown up, indicating that whatever made the hole was incredibly powerful, an official said.

Although these incidents may have had nothing to do with UFOs,

saucerenthusiasts often suspect that saucers use oceans and lakes as hiding places - maybe bases.

#### MAP VENUS BY RADAR

According to a report reaching SAUCER NEWS via reader Vera Volkov, from Canada, U. S. scientists are mapping Venus by radar and have quietly been doing this since 1964.

By the use of radar they can pierce the cloud veil to "see" the more prominent surface features.

Prof. H. Jurgens, the Cornell University astronomer in charge of the group which is putting the map together, said unusually rough areas noted might be giant mountain ranges.

The scientists say two bright features located are known to be in the northern hemisphere of the planet.

"About one-third of the planet has been mapped now and we have data for preparing a larger map that will encompass almost the entire planet," Mr. Jurgens said.

Measurements for development of the map were made in 1964 and

1967 at the Arecibo ionospheric observatory when Venus was closest to earth - a distance of 26 million miles.

"This is the first time that an approximate map has been constructed of rough and smooth regions of Venus," said Mr. Thomas Gold, director of Cornell's center of radiophysics and space research.

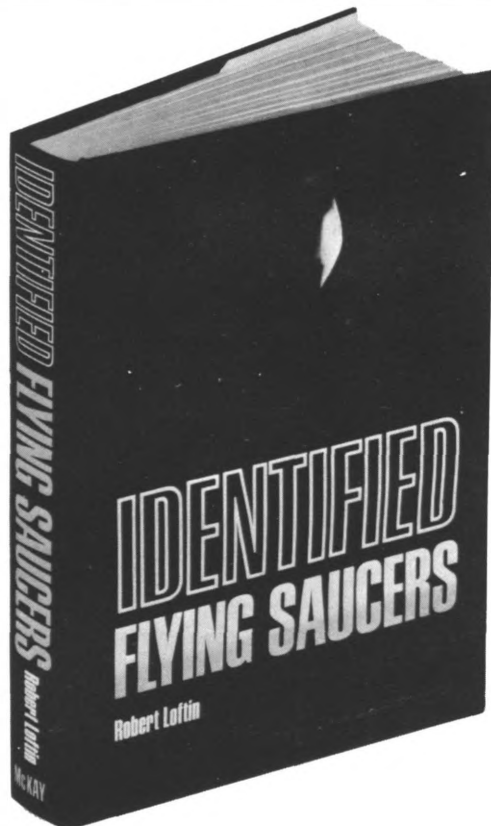
"These observations confirm that Venus is rotating in such a way as to face the earth the same way each time it passes this planet at its closest."

The Arecibo radar observations show rough areas near the equator of Venus and a prominent feature in the southern hemisphere which may be a steep mountain range.

Venus generally has a smoother surface than the moon, the astronomers said, but the newly-elected features were about twice as rough as the average surface of the moon.

To produce the map radar astronomers used a technique known as Delay Doppler Mapping.

They measure the time it takes a radar signal to bounce back and shift in the frequency of the echo.

### NEAR LANDING IN AUSTRALIA

During the weekend of January 13th, four youths, A. Tory, J. Rizzo, J. Smith and M. Zines went camping at Wattamolla Beach, 13 miles south of Sydney, Australia. Since it was raining for a few days the water started to collect in puddles around their tent. It was just an opportunity between showers at 2 a.m. to dig a trench which would re-channel the water back to the sea. They were shovelling sand by hand and Andrew Tory was shining the torch for light, suddenly a bright light was noted in the Northern sky, not high above the hill extending across their view. They thought it to be a plane or helicopter at first, but a jerky movement of the light in its descent towards and behind the hill, with no sound, did not fit this assumption. The light reappeared on the other side of the crest of the hill swerved south to cross the ridge, then began approaching them. It grew bigger and brighter as it came closer. At this stage it was evident that the light was actually composed of two lights, one bright and large on the front and one smaller and red on the back. It also appeared that they were part of an object having a triangular or rather bell-like shape. As the object glided silently closer and closer, the whole area beneath of bush and rocks suddenly became brightly illuminated in a diameter of some hundreds of feet as though being lit by a spotlight. The boys were now frightened but soon became composed. The object had stopped, switched off the lights and hovered about 400 yards away and 200 feet high. Silhouetted on the dark background of the sky there was still a darker shape, triangular with a base of about 50 feet and a small dome at the apex. Along the sides of the object there was a dim reddish light reflecting from the surface and coming out of a row of small lights situated along the edge. "There were possibly ten red lights in the row at each side, but none at the surface facing us, on top, or on the bottom" all boys agreed. The dim red light was just strong enough to outline the bell-shape of the object and make the surface visible and

give an impression of a dark metal. No windows, antennae or other appendages were visible. By now the boys' courage returned and two even decided to go closer and see what the object was, but changed their mind. Instead Andrew, having a powerful flashlight in his hand, decided to shine it at the object, hoping that the light would reach so far. It did not, but as soon as the light was switched on, the object responded by switching the big lights on. Andrew was perplexed and the boys became frightened, so he switched the light off and similarly the object answered. Three times Andrew signalled to the craft and twice the craft responded. The third time the brilliant light of the object did not switch off, but after hovering for about 25 seconds, the craft began moving slowly away. It went in a north-westerly direction, then following the line of the ridge of the distant hills, it suddenly disappeared behind them. The boys were amazed at their experience and discussed the matter at length, finally reaching the conclusion that the object was not any conventional craft, but appeared to be a UFO.

### STRANGE POWERS

From our Fortean department, via Military Editor, Gary Oxton (who got this report from the Stars and Stripes), comes word of a Russian woman, Nelya Mikhailova, who has the power to move objects without touching them. When she wants something she just stares at it and it starts creeping toward her.

Nelya has astounded scientists here with her alleged ability to make

things like match sticks and wine glasses move without touching them, the paper said.

Moskovskaya Pravda (Moscow Pravda), published by the city's Communist party organization, gave this account:

Nelya, married and in her forties, claims she uses mind over matter to make a one-pound water pitcher slide across a table, or to stop and then restart a pendulum swinging.

In one experiment she concentrated on a compass. First the needle spun wildly, then the whole compass itself and its wrist strap revolved on the table.

In another experiment, under scientific supervision, she apparently caused a small aluminum tube to shift positions under a glass cover.

And yet another time, matches and an apple jumped off a table at her "command".

Is it "focus mocus" (Russian for hocus pocus)?

Nyet, said writer Lev Kolodny. He said he watched Nelya in action and could find no hidden threads, magnets or other gimmicks.

He quoted Soviet scientists as saying they don't know how Nelya does it, but they're sure there's some logical explanation.

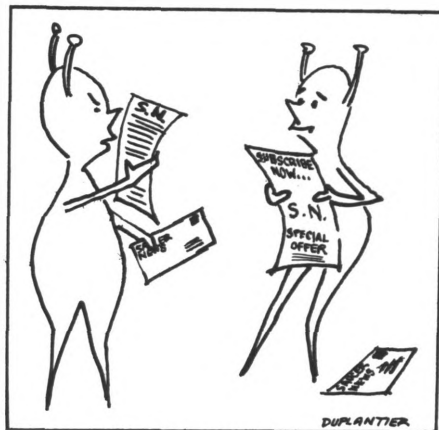
"It's nothing supernatural," said scientist Y. Sitkovsky. "When a person thinks, he radiates energy. The character of physical-chemical reactions is stronger in some people."

Another scientist said it had something to do with "electrostatic activities" connected with the brain, but he said Nelya would have to be studied further to find out what it is.

### ODD SHAPED SAUCER

A report reminiscent of the "wheels within wheels" of Ezekiel's classic sighting in the Bible, was submitted by J. C. Cardin, of Cushing Oklahoma. Here is the report in his own words:

I wish to report on a sighting I had here yesterday about 12 o'clock noon, March 13th, 1968. The sky was clear and we had a wind out of the south blowing about 15 miles per hour. I happened to glance up in the sky and this object was circling overhead. At first I thought that it was a bird of some type but the cir-

cling it was doing attracted my attention more and upon closer examination, I saw something different. I noticed that the wings were round, and not shaped like a birds wing.

It was going in a counter clockwise circle and it would make three even circles then it would rise a bit and make three more, and then over again, always making circles in the same direction and as far as I could tell they were about the same size circles each time. At no time did the thing reverse direction but always moving in a counter clockwise motion. These circles were fairly close and tight circles and the same edge was always leading forward.

The thing seemed to be very light and acted like it was floating on the air currents and eventually drifted north out of sight still doing its counter clockwise circling.

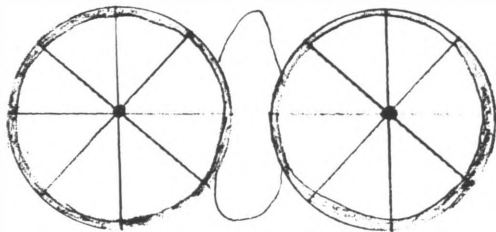
The color of the thing around the outer part of the round wing was black and faded from black to a light tan color near the hub or center of the wings, and looked like it might be nearly transparent.

I do not know how large the thing was but it was nearly overhead when first spotted and I will say that the tip of my index finger at arms length would not cover the machine and as near as I can figure it would take the width of about one and one half fingers wide to cover it.

My estimation was that each wing was around fifteen or possibly twenty feet in diameter, and of course there was a small cabin which was rather short between the wings and it was still about the same color as the rest of the machine.


One peculiarity about the round wings was that they had a hub in the center and you could see the spokes running out to the edge like they might be able to rotate.

The enclosed rough drawing is a good approximation of what I saw, from my viewpoint which was almost directly beneath the machine.

**SAUCERS OVER COLUMBUS**

Franklin County sheriff's deputies, newsmen, and residents viewed an amazing UFO demonstration over Columbus about 8 p.m. on May 20. But mysteriously, Lockbourne AFB authorities concerned with UFOs reported they saw nothing on radar and received no telephone calls about the phenomena.

Sheriff's deputy Thomas Barker and Deputy Edward Durbin of the Prairie Township police department gave this account:

About 8 p.m. the two were dispatched to the vicinity of Big Run and Gantz roads, to look for "lights hovering in the sky" after the sheriff's office received five telephone calls from southeast area

families.

On arriving, the deputies immediately saw two such lights.

"They appeared round," Barker said, "it was like looking into a spotlight up close . . . about the brightest thing I ever saw in the sky.

"They appeared to hover about as high as most commercial airplanes fly around here - about 1500 to 3000 feet. One hovered a little higher than the other, and they stayed in that position for about 30 seconds," Barker said.

"Then, as we watched, they changed positions with each other, and hovered that way for two to three minutes."

Within another minute or so, the deputies reported, the upper of the

two glowing, yellowish vehicles "zipped down" to meet the other, and the two remained parallel and motionless.

The deputies remained in contact with the sheriff's office by radio, and by this time the sheriff's radio dispatcher had telephoned the Lockbourne AFB UFO office to inform military specialists.

As the deputies continued to watch, one of the vehicles left the

other "so quickly that it was like trying to watch a bullet in flight," Barker said, and disappeared from view while the other waited motionless.

After several minutes the object which had left returned, and the two moved in formation to a point above the four antennas of the old approach lights for the Lockbourne runway, west of I-71 and slightly south of Rt. 665.

There both objects descended, until "they appeared to hover almost on top of the antennas," and remained above the light towers for several minutes.

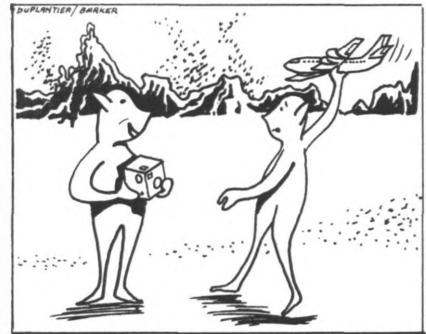
"Then they moved away from the towers," Barker said, "and one of them began moving southeast, horizontally and at a slight upward incline. It was completely out of sight in less than five seconds."

Several area residents and the Franklin Township and Grove City police departments corroborated the deputies' stories, the sheriff's office said.

This reporter and Dispatch Photographer Thom Rockey arrived in the area about 15 minutes after initial reports and soon sighted one of the objects hovering about three miles east of Grove City.

It appeared flattened, vaguely circular in shape and shone all over with a glowing, yellowish-white light. The object seemed to be about the size of an airliner, except for its shape. It made no noise.

The object would hover for as much as a minute at a time, then would move several miles away as

fast as the eye could follow, and hover motionless again.

The reporter and photographer tried to follow the object in its erratic path to get close enough to photograph it, but were hampered by its ability to move "as the crow flies".

After the Dispatch team had followed the object around southern Franklin County by freeway for nearly a half hour, a second appeared and hovered near the first in a one o'clock position.

About 8:45 p.m. two identical vehicles appeared over the North Side of Columbus, glowing brightly and hovering in close formation for several minutes. By this time a number of airplanes appeared presumably in search of the objects, but apparently did not succeed in approaching the disc-like objects.

Shortly before 9 p.m. all objects disappeared: the hovering pair near northern Columbus appeared to simply extinguish themselves like candle flames.

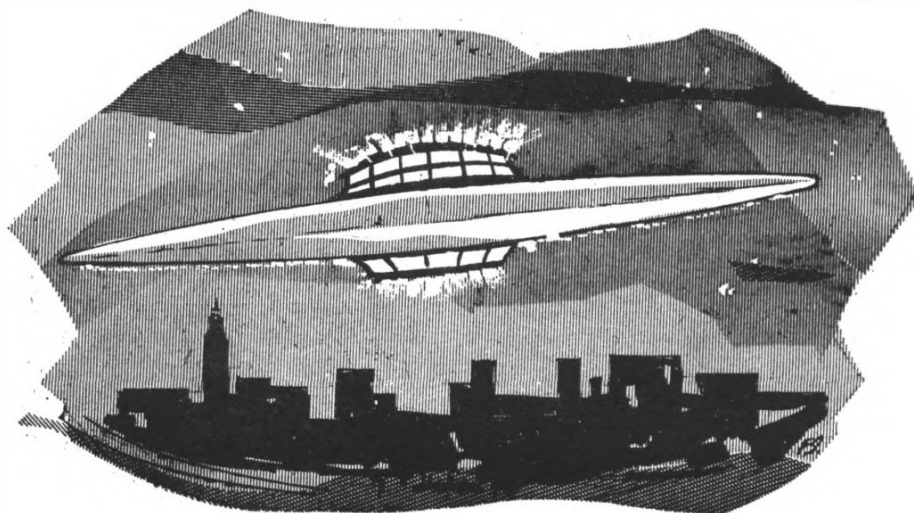
The pair of objects south of Columbus disappeared to the east slowly at first, then vanished almost instantaneously in a burst of speed.

Both Lockbourne officials and Port Columbus tower spokesmen denied reports of UFO sightings or radar identifications of any such vehicles.

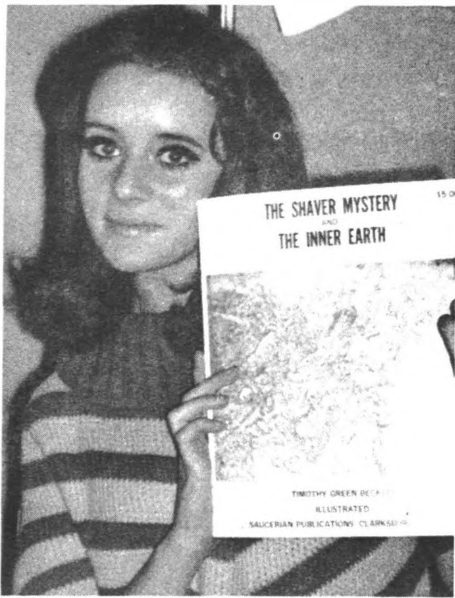

## Report From South America

# UFO Activity Over Argentina

By NICOLAS M. OJEDA (Representative of SAUCER NEWS in Argentina)

### I: A FLYING CONE

At 4:30 p.m. on July 3, 1960, Captain Hugo Francisco Luis Niotti, a graduate of the National School of Aeronautics at Cordoba, was driving in his car from Yacanto to Córdoba, when at a spot 70 kms from Córdoba, he perceived an object at what he estimated to be about 100 meters from the ground. It was raining at the time a very fine drizzle.

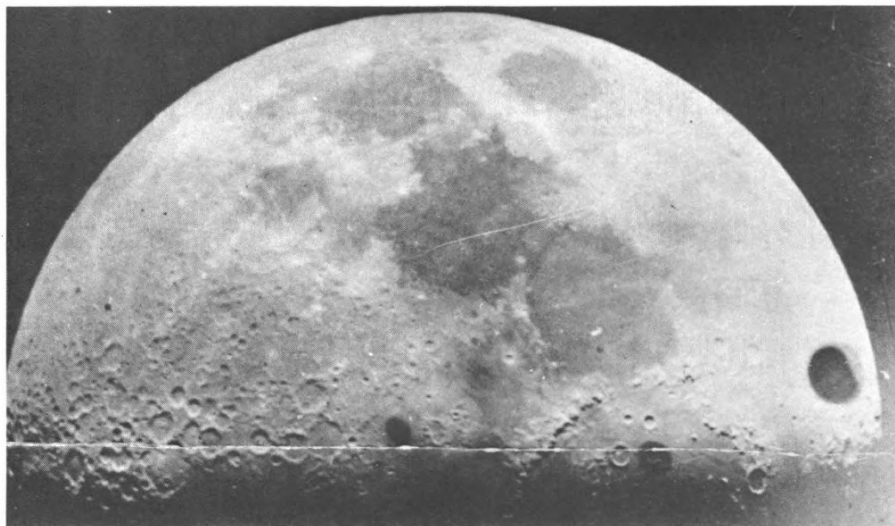
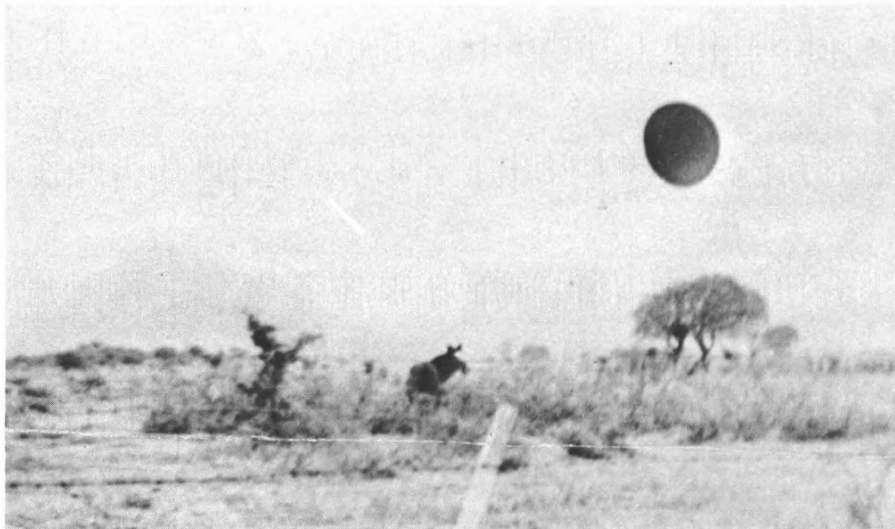
The object was rotating on its axis and traveling slowly southward. He was astonished by its shape and the total absence of any sound from it. There was nothing to indicate any motor or engine, any smoke or flame.

He got out his 35 mm camera and took this picture. Despite the fine rain, visibility was good. After he had watched the object moving slowly and silently along, it suddenly shot straight up vertically and vanished among the clouds.

We consider this piece of documentary evidence of the greatest importance in view of Captain Niotti's standing in the Argentine Air Force and his reputation for probity.

The negative was analyzed by Argentine Air Force photographic experts. They reported that they found no signs of trickery or tampering, and concluded: "What the photo shows is a faithful reproduction of what was photographed."

The photo was published as an exclusive feature in Number 222 of *La Revista Nacional de Aeronautica*, the OFFICIAL organ of the Argentine Air Force.

## II: UFOs SILHOUETTED AGAINST THE MOON

About a year ago the Reverend Father Segundo Benito Reyna, a Jesuit priest who is the Director of the "ADHARA" Observatory at San Miguel in the Province of Buenos Aires (ARGENTINE), held a press conference and showed the newsmen a sensational photograph taken with the powerful telescope of that observatory.

Father Reyna, a distinguished scientist who holds the degrees of Doctor of Philosophy and Doctor of Science, has kindly made a print of this photograph available for SAUCER NEWS.

The history of the picture is as follows: At 8:30 p.m. on December 1, 1965, the Observatory began to receive numerous phone calls informing them that there was something strange on the Moon and asking if they could see it.

As it happened, the staff of the Observatory were indeed occupied with the Moon, but they were taking photographs of it at four-minute intervals and were not looking at the Moon itself. When, however, they came to develop the pictures, which had been taken with a camera affixed to the telescope, the sixth of the series was found to show what looked like UFOs, one of them somewhat bell-shaped like the saucer in the well-known photo by the late George Adamski. There is no question whatever that these objects were saucers, as can be seen from their size. Furthermore, a few minutes after the photo had been taken, three strange, luminous bodies passed very low over the city of La Plata, to the astonishment of hundreds of witnesses. (See photo)

## III: GIANTS IN ARGENTINA

It was raining heavily at dawn on October 18, 1963, Eugenio Douglas, with a truckload of coal, was driving between Monte Maiz and Isla Verde in Argentina, when a brilliant headlight on the road, apparently from an approaching car, blinded him.

There was only one light instead of the usual two, and Douglas slowed down to avoid collision. The light became brighter and his eyes could not take it any longer.

He stepped on the brake and put his head on the steering wheel. The truck was now on the edge of the road. The driver got out of the lorry and through the veil of rain saw in front a circular metallic craft about 35 feet high.

Suddenly another light of lesser intensity appeared in the vehicle. It came from an open door. Several tall figures passed through the opening. They were human-like but extremely tall - over 13 feet, dressed in tight-fitting suits with a sheen.

They wore strange headgear with protrusions that looked like small antennae.

Douglas said there was nothing repulsive about the big men, yet he was terribly frightened. The moment his presence was discovered by the figures, a ray of red light flashed burning his skin. Eugenio Douglas was in such a state of nervous tension that he could think of nothing but grabbing his revolver and firing three shots at the tall beings. He then started to run on the road toward Monte Maiz.

The burning red light followed him wherever he went. Shortly, when he reached the village, he noticed that as the red beam touched electric lights in the street they turned violet and then green. A strong smell of some gas immediately spread all around. As he came to the nearest house he began to shout for help.

This was the house of Ribas, who died the night before. His relatives were assembled in prayer near the dead body. Unexpectedly, the candles around the corpse and all the electric lights in the house turned green. A strange smell instantly filled the house.

Hearing the shouts outside and seeing the weird happenings inside, the Ribas family rushed out to find Douglas with an overcoat over his head and a gun in his hand.

Neighbors appeared on the scene to watch the changing street lights and approaching visitor. The driver, Eugenio Douglas, was taken to the police station where he showed burns on his face and hands, and related his uncanny experience. The police officer then recalled that he had a number of calls regarding the change of color of the electric lights, but attributed it to irregularities at the local power plant. Douglas was

examined by a Doctor Dabolos, who stated that the burns had been caused by radiation similar to ultraviolet. The following day the villagers went to the site where the driver met the strange machine with the giants, and found large footprints. (See photo)

# REPORT from CANADA

By GENE DUPLANTIER

On June 13, two men had the strangest experience of their lives - a visual contact with aliens from another sphere of existence!

Around 2:30 a.m., Carmen Cuneo, an employee of a mining firm in Caledonia, Ontario, stepped

outside briefly during his coffee break and saw something he had never seen before. He is not likely to ever see it again either. In the vicinity of the lower part of a mine dump by a pond, he saw a cigar-shaped craft and another over and

to the left of the main craft, but at an angle.

One was about 36-feet in length with four evenly spaced small windows along the side facing him and a boom-like aerial sticking out one end. The other was saucer or disc-shaped and about fifteen feet in diameter. Both craft were about 12 feet above the ground. Almost at the same time, Carmen noticed three small men with hats similar to those worn by miners and which had four small amber lights (in a row) on the peaks, walking on the ground under the boom of the large ship.

After watching the sight for about ten minutes, Carmen thought he should get someone else to verify what he was seeing and called his friend, Merv Hannigan, around 2:45 a.m. When they returned from the building the little men had disappeared into the craft. Both Carmen and Merv continued to watch the hovering craft until 3:05 a.m. At that time both crafts began to move noiselessly off toward the southwest with manycolored lights in evidence.

Later the same morning, Carmen went over to investigate the landing site and saw a large gouge in the ground and oil on the burdock leaves. He thinks the gouge was caused by a large set of steps from the ship for the convenience of the occupants and that the oil came perhaps as sort of a splash from one or both of the vehicles. Tiny bits of metal seemed to be a part of the oil. Carmen also said that the three men had human motions, that they seemed to be picking up something





from the ground, examining it, and putting it back. The aliens were about 4 feet tall.

It should be noted that there was a clear sky with a full moon. The lights in the windows of the larger craft were yellow-red as if looking into a firebox. The crafts were about 150 yards away from the two witnesses. It was also noted that the vehicles took 2 to 3 minutes to lift off the ground and were in sight for 4 minutes after take-off, the smaller disc following the larger ship.

#### LITTLE MEN IN WHITE

In mid-August, Stanley Moxon

of Toronto was driving along Highway 15 near Joyceville, Ontario, early in the morning and saw a green light in a field. He shut off the car's headlights and swung onto a side-road to get closer. Then he turned the lights of the car on again. He wasn't prepared for what he saw! He saw a huge craft resembling two saucers, one inverted on the other and two "people" in white uniforms and helmets about 4 feet in height.

"The pair", he stated, "almost flew inside the saucer," and the craft lifted quietly but at tremendous speed until it was out of sight. Constable Steve Whitton investigated the case and said there was no reason to doubt Moxon's story. Moxon had not been drinking.

Later in the same year, in late October around 9 p.m., Donald Marshal of Melfort, Saskatchewan, was walking home after visiting his cousin.

Nearing his home he saw a light at the back of the house. On approaching and getting a better look

all the time, he saw what appeared to be a square light about 12 feet off the ground and about 4 feet high and about 16 feet long.

It looked as if it were a window in a much larger object, perhaps about 50 feet long. There was no sound and Marshal came to within 200 feet of the object.

Suddenly a bright spotlight came on and he saw three small humanoid figures coming from the machine. They moved very fast, were clothed in green uniforms and wore some type of headgear. The three aliens disappeared somewhere and the craft took off slowly at about 5 miles per hour. He didn't investigate the area at the time because he did not know for sure what had become of the little men. In the morning, he found no evidence except for some broken trees. When questioned, Marshal said he is convinced he saw a UFO. And we wonder whether it was the same one that Carmen Cuneo saw earlier in June with his friend.

## Report From Australia

# *UFO's Over Western Australia*

Recent UFO activity in western Australia was brought to our attention by a report from the South West. A contractor, who wishes to remain anonymous, had an unusual experience while driving along the Mayanup-Kojonup road on October 13th, 1967, at approximately 9:30 p.m.

He stated that while driving his car at about 60-65 M.P.H. the car was suddenly stopped, the lights extinguished and the radio silenced. There was no sensation of stopping, or feeling of inertia or deceleration, as one would expect in such circumstances! A beam of light descended on the windshield of the car, which appeared as a tube of light up which he could look, and on doing so he saw a football-shaped object at a height of about 100 feet. The object appeared iridescent blue in color, similar to

lightning.

As he gazed up the tube, he had the feeling of being observed, although he did not see any sign of life and was not frightened. The time taken could have been a few seconds, or several minutes . . . he could not tell as he appeared to be in a state of 'suspended animation'.

After a period of time, the tube of light was extinguished and he was again driving at 60 mph without any feeling of acceleration! The object moved off in a westerly direction until out of sight, obscured by the trees which grow to a height of about 70 feet.

He reported the incident to the local police and the policeman on duty stated that the man was really frightened and had definitely seen something. Three other people in the area reported seeing the object that night.

#### HUMMING SAUCER

The next report is from a Mr. A. Poole of Yerecoin, about 80 miles northeast of Perth, who, while mustering sheep in a Landrover during the evening of November 16, 1967, became aware of a humming sound, which at first he thought may have emanated from the generator of his vehicle.

As the humming increased he saw an object approach at a distance of about half a mile; it appeared to be coming in to land, in a similar way to that of a light aircraft. It approached his vehicle and stopped next to it at a distance of about four to five feet from the Landrover.

The humming noise was very strong and he could feel vibrations from it, but was not physically affected in any way. The object appeared like an inverted saucer about

twelve to twenty feet in diameter, with four windows - two round and two square on the side visible to him - a grey metallic color, about five to six feet high. It appeared to hover a few feet above the ground as there was no disturbance or marks on the wet grass after it had disappeared.

He demanded to know what it was doing there, and his words were repeated back to him in his own voice, as though an echo - but an echo would be most unusual in this particular circumstance. No electro-magnetic effects were apparent, although his wife stated, when told, that the T.V. set had acted up at that time. He attempted to alight from his vehicle and upon opening the door, the object

immediately ascended vertically; by the time he had stepped out, a matter of two or three seconds, it was out of sight . . . although he could still hear the humming noise. He stated that the length of time from when he first saw the object until it disappeared was only about ten seconds. It did not appear to have any landing gear. The weather conditions were cloudy with a slight drizzle and strong winds!

#### THAT HORRIBLE NOISE

Mrs. Pamela Maciejack, has stated that on Sunday, November 18, 1967, about 5:15 a.m. she went to the front gate and heard a "very horrible noise". Continuing, Mrs. Maciejack said she "saw an object with the terrible noise - worst noise I have ever heard. I saw the grey-blue object about the size of a 'mini' car - but am unable to describe its design as it was going too fast and disappeared into the north."

Mrs. Maciejack stated she had heard many motorcycle sirens in Europe during the war, but nothing like this. "I call him the monster - he is a monster - it broke me up!"

Together with her family, she went to a soccer match in the afternoon, but did not see the game . . . "only thought of the object!" She did not believe people when they said they saw 'flying saucers and things like that'. When she read in the paper about the Yerecoin sighting she said to herself "it must be imagination . . . nothing like that would happen to me!"

Now she says, "Saw once, never wish to see again!"

Mrs. Maciejack said that whenever she speaks of it the noise comes back to her head. She does not drink. An old man living next door also heard the noise.

Reports have been received of neighbors having trouble with their radios later in the morning of the same day. One man who lives at the rear of Mrs. Maciejack's home said he turned off his radio as blue flashes were coming out at the back of it. The time was about 7:30 a.m.

#### OTHER SAUCERS

At 7:15 a.m. on November 20, 1967, Mrs. Sandra Moir of Swanview (a suburb northeast of Perth) was driving her Mini-Minor from Mid-

land to Swanview when her eye caught the sight of an object. This she thought was a plane because commercial aircraft landing from NE to SW are often in the vicinity. On taking a second look she saw it was a 'flying saucer' of disc-like shape with domed top, and what appeared to be portholes in the lower half. It appeared quite large, then turned on edge and gradually went up toward the north. It was silvery color and moved fairly quickly. Mrs. Moir drew a sketch of the object in a book she had with her in the car. The sketch closely resembles the accepted design of these craft.

We heard from Mrs. Anias Pusey of Cloverdale, another eastern suburb, who stated that about three weeks ago, on a Tuesday at 6:30 p.m. she was driving along Orrong Road, Kewdale, when she saw a 'flying saucer' coming from the north and going toward the southwest. "It was about the size of a very small car," Mrs. Pusey said. "It stopped for a fraction of a second and then disappeared behind a building . . . but I saw no sign of it coming from the other side." Mrs. Pusey went on with her report - "it was a flat disc-shaped silvery white light . . . very beautiful. It appeared to be two to three miles away. There was no color change when it moved off. My car appeared to be slowed down somewhat . . . but of course, this may have been due to my attentions being diverted and not concentrating on driving."

Early on the morning of November 30, 1967, Master Norman Sinclair, a lad of about 16, of Dianella (a northern suburb) awoke and looking out of his bedroom window, saw a white object with three lights at each end. Knowing he would not be believed when he told his family, he awakened his elder brother, Peter (21 years of age) and together they observed the object. Peter continued this observation for about three quarters of an hour; at the same time took a note of the recordings being played on the all-night radio station to prove that he was awake . . . and also to note the time. He had noted the position of the object in relation to a star. Peter dozed off, and on re-awakening about half an hour later, was disappointed to find the 'object' had gone. The star was still visible.

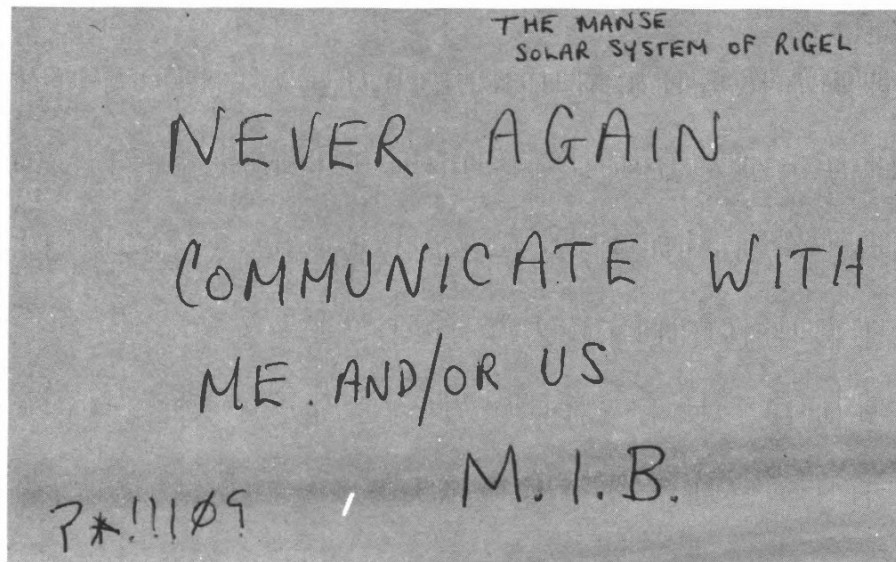

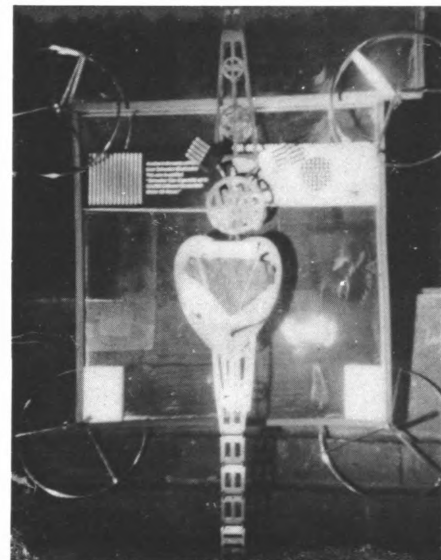
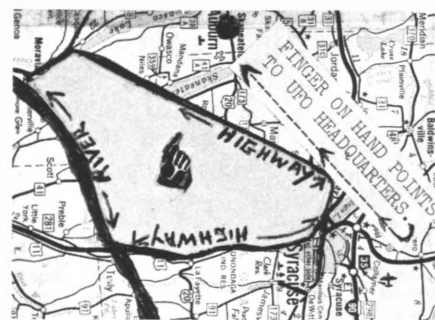

vading those ants, I tried to use it as a way to tell the insects how much better off they would be if they used only one-half of the sidewalk. Thus they would not get stepped on.

It worked. Simply by contacting the queen ant by ESP, those ants were taught by me, only a human child, how to better survive. 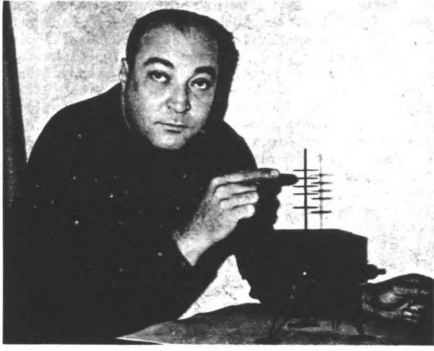

I left my apartment about 11:20 and had to wait but a few minutes to see Lit. I was, of course, very cautious and asked all of the Forces of Light and everyone in the Heavens to be by my side. I certainly needed all of the support I could get, as I found to be the case later. 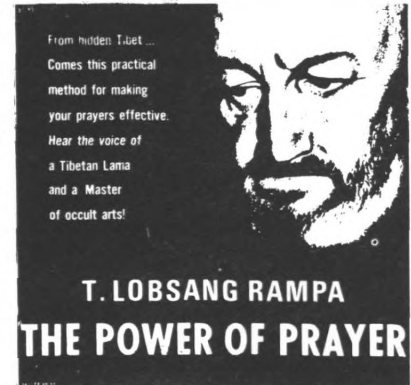

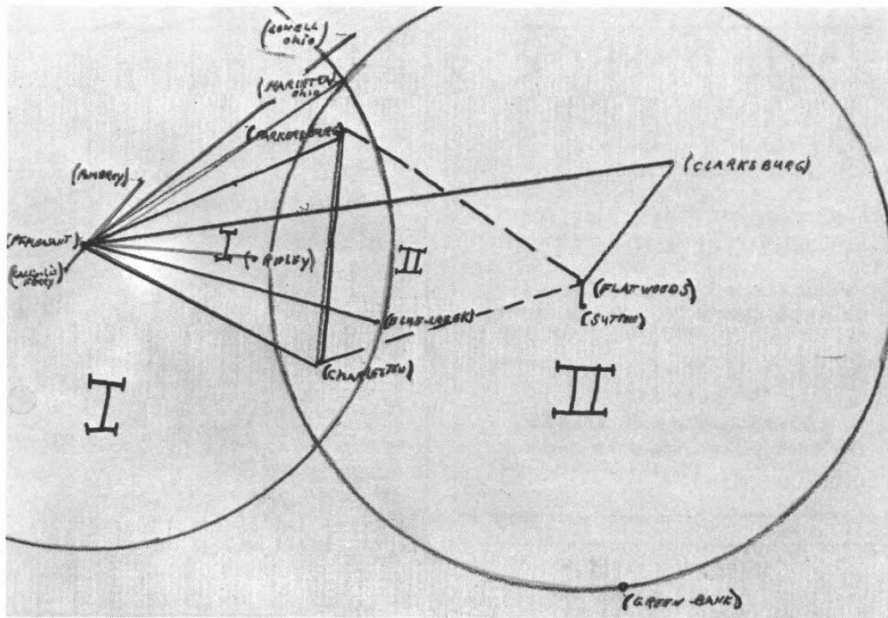

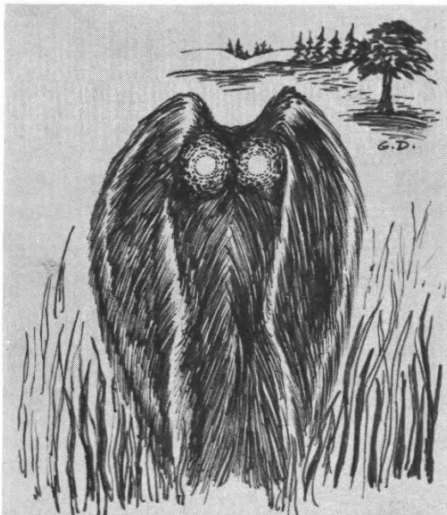

BENDER'S SECRET

Dear Gray:

This is a commentary on Albert K. Bender's FLYING SAUCERS AND THE THREE MEN, especially as it is a long-awaited sequel to your old classic THEY KNEW TOO MUCH ABOUT FLYING SAUCERS. It would be too easy to be disappointed in Bender's book, at least if one did not know what Bender was trying to do, and did not know of the limitations under which the man still operates. The book is not "fraudulent", per se; but much of it may be imaginative fiction, meant to lead the unwary UFO researcher "off the trail".

Basically, I consider Bender's book to be reasonably true and accurate up to the first new paragraph on page 70 of the paperback edition. From here on fact is mixed with science fiction. The most accurate portion of the latter pages are doubtless those which attempt to limn the

three "men in black", though even these descriptions are corrupted by such probable fictions as "their eyes shone like tiny flashlight bulbs". Two objections can be raised to Bender's tale. First, the whole tenor of his experience is different than that related in your earlier book. In your book, there is an undercurrent of almost psychic fear that cannot be justified by anything in Bender's book. Secondly, assuming Bender's recent story to be true, the "bad slip" he claims he made in the interview recorded in your book would be very easily located. Clearly, that discovery which held Bender in fear still holds him so, and you could not drag the true story out of him with a Sherman tank! Bender was probably ordered to write the book by the same people who keep him sworn to silence.

I think I know Bender's secret. Roughly speaking, he discovered the following:

That for several thousand years (at least) this solar system has been visited by interstellar and even intergalactic civilizations.

That since circa 1897 this planet has been under sporadic observation by beings from another star, this observation being in three waves - the 1897 "flap", a small "task-force" from 1898 until 1943, and the main visitation since 1944.

That this visitation is by a civilization between two or three hundred years in advance of our own probably from the Eridani system.

That these visitors are humanoid, apparently olive-skinned, in the main very slightly shorter than Earth average.

That among these visitors are a good many "midgets", of much the type usually seen on Earth; they are expert "technicians", who because of their size are valued as space-voyages - that is, they can easily service the engines of the "saucers". They are often employed by terrestrial aircraft companies for just this purpose. These little men are often pilots of very small scout-craft.

That for the past twenty years Earth has been at war with the flying saucers. While the weapons of the spacecrafts are far in advance of anything on Earth, we are winning the war because of the tremendously-long supply-lines of the

enemy.

Bender's visitors were CIA men, who forbade him to reveal what he knew. The visitors were (and are) afraid of public panic if people learned that their planet was under attack by people from outer space. The CIA agents warned Bender that if he "left the cat out of the bag" that he would go to jail for a very, very long time. If the visitors had been spacemen, they would simply have killed Bender, or spirited him away, perhaps to the home planet.

The space-people have a subversive spy-system on Earth, with agents in various governmental and social circles. The whole thing much resembles the television program, THE INVADERS, which may be a CIA "leak" to "prepare" the public for a future announcement that Earth really is "at war with the flying saucers"!

#### INTERCEPTED LETTER

Dear Mr. Crabb:

Shortly before the Colorado UFO flap, and almost immediately after the Alamosa incident (Snippy the pony's death, attributed to a UFO), several strange incidents occurred in Las Vegas.

During the weekend of September 17, 1967, a UFO with the same magnitude as Venus appeared in the West. It moved from the West and traversed Northeast, moving ap-

proximately 3-5 degrees per second. The object was an intense electric blue and there was a fuzzy haze around it. Although the intensity of its light made it difficult to determine its actual shape, it did seem to be disc-shaped. It cast a bright reflection on shiny objects on the ground, as well as on a thin layer of clouds overhead. Later that evening I noted a strong odor of burned plastic, along with the stench of iron sulfide.

On the Wednesday following this incident, a more controversial sighting, made by close to a hundred of my fellow classmates as well as some townspeople, occurred. At about 10:30 p.m. Mountain Time a formation of dim-lighted objects passed from Northeast to West of Las Vegas. The speed of these objects surpassed the calculated speed of any migrating fowl. They were circular, at an approximate elevation of 2,000 to 5,000 feet above the city, this calculation being made by referring to the relative positions of the UFOs and the scattered cloud layers. The objects were visible at times when below the lowest cloud layer and beyond visibility when above the clouds. The cloud elevations were tabulated in geology lab the following day, based on weather reports for the evening.

I might add that there is little aircraft regularly over the immediate city, except for some commercial flights and some minor activity from Air Force bases in Colorado.

I call the latter a "controversial" sighting, because some fellow students and I received threats as a result of it. The next day a friend phoned me and reported he

was warned not to report the information to the authorities or he might be killed. He begged me to refrain from reporting it, and I did, for a while, anyway.

A few weeks later I was out riding with one of the city police. We drove up into the mountains near the Gallinas Canyon to see the view of the city, when a light appeared in the sky. At first the light seemed to be no different from any aircraft; however it soon began to move erratically, and then it completely reversed its direction without any normal circular deviation of known aircraft. It seemed to be descending on the Eastern horizon near an old water tower, about five miles from our position.

We raced full speed in that direction. When we arrived we discovered a series of small brush fires near the tower. After extinguishing these, we decided to search the area. We came upon a deserted ranch house surrounded by a wooden fence, on the other side of which was a sharp decline into a canyon. Upon reaching this fence, we were astounded to feel a surge of heat coming from the canyon. At the same time the area immediately in the decline

was turning blood red. Then an object, about 50 to 75 feet in diameter, shot straight up into the sky at fantastic speed. The object was blood red. Later, after an intense investigation, we radioed in for official help. The rest I cannot disclose, because the investigation became official and gradually got into the hands of the Air Force. I tried to sleep it all off and to forget it, but certain events which occurred after this almost caused me to have a complete mental and physical breakdown. Not many will believe the rest of what I have to say, but it does not matter that much.

Two days after the above experience, I too received a threatening phone call. I was told that I should keep all the information about the sighting to myself and forget the entire affair. The next day a man met me on the street. I had never met him previously, but he knew all the details of the sighting and even gave me added information that confirmed some of my own research on Atlantology.

Concerning the sighting, however, he openly threatened me to keep my mouth shut. I retorted that not many people would believe me anyhow. I made no mention of the policeman who was with me at the time of the sighting, but I let my thoughts refer to it. As if he had read my mind, he immediately mentioned the name of the policeman and added that he had also been encountered and warned. I later heard that he had lost his job.

I hesitate to give you the rest of

the story, but to keep it to myself might result in my having a complete breakdown.

Two days following my encounter with the man on the Las Vegas street, and again while I was walking downtown, a black car speeded in my direction, and came very close to hitting me - too close for comfort. I reported it to the nearest policeman, who passed it off as a reckless driver running a stop light.

I was ready to forget the incident when I remembered details about the car. The windows were not clear, but were deeply tinted. The license plate on the rear did not identify any state; as a matter of fact it consisted of only "XXX". The tinted windows made it impossible for me to see the occupants of the car.

Toward the last weekend in October, while having a cup of coffee at a cafe and discussing politics with some fraternity fellows, a shot rang out. A bullet came through the front window and tore into the wall about an inch above my head. Luckily I had suddenly bent down to sip my coffee. However, this last incident was not enough to satisfy the intentions of the strangers. A series of bad luck breaks and freak accidents began to occur. Somehow I began to take the hint after I was bed-ridden with pneumonia for two weeks and failed in my studies. So by the end of the quarter I lost all hope of returning to New Mexico Highlands University. Now here I am back home, once again, unemployed and back to 1-A.

Still, the words of the stranger keep returning to my mind. He spoke about a series of violent earthquakes all over the world, caused by the breaking of the San Andreas fault in California. He also mentioned a shift in the Earth's axis, causing a great amount of the polar ice to melt. The new rise in the waters would undoubtedly cause great havoc. This is nothing new from what I have learned on my own; however, there is one added fact that I still don't seem to understand. Why do people have to suffer as a result of knowing the truth about these things? I know that I share the misfortune and threats of many others, but why? What harm is there in sighting UFOs?

I have hesitated to write many



times since returning home, but there must be a time that I, when faced with other difficulties, should reconsider my hesitation. Perhaps by going into the service to back my price for freedom I will eventually forget the past few months. Meanwhile, I will refrain from further investigation of UFOs until I once again regain my confidence.

For I have also encountered the mysterious and terrifying "Men In Black".

### INTERCEPTED LETTER

Dear Editor, LOOK Magazine:

As Chairman of the 1967 Congress of Scientific Ufologists in New York, I must take exception to John Fuller's assertion that it consisted of "far-out supporters of undocumented and highly colorful UFO sightings". One of the principal speakers was the internationally-known naturalist Ivan Sanderson, who should be of special interest to LOOK as he has a current UFO book published by Cowles, and entitled "Uninvited Visitors". Other main speakers included a university professor and equally respectable writers in various fields. Their views, though speculative (in regard

to an area where no one yet has a provable answer, pro or con), were well received by the audience - of which John Fuller was not a member.

Regarding the Condon Committee, I consider it highly irregular and most unscientific to pre-judge the members of their report before any report has been issued. I have known Mr. Fuller as well as Major Keyhoe of NICAP for a period of years, and I am sorry to see Fuller fall into NICAP's well-established pattern of judging UFO books, UFO sightings, and events in general without investigation of any kind, merely on the basis of preconceived prejudices.

Time will tell whether or not Dr. Condon hands in a properly unbiased report on the UFO enigma, but time has already run out for NICAP, which long ago lost its influence with the vast majority of UFO buffs who are interested in a "middle of the road" approach to UFO investigation rather than endless diatribes against the Air Force and all who work for or with them. In the UFO field, NICAP stands for: censoring out all (to them) unacceptable views within the field; character assassination; dogma, based on faith rather than investigation; and dedication to "respectability" at the expense of



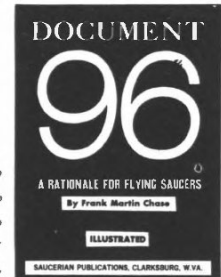

Document 96 - A Rationale for Flying Saucers, by Frank Martin Chase, is offered in a paper bound folio 8 x 11, of 125 pages, and is well illustrated with artist's conceptions of the space vehicles described in the text, and with diagrams of the mechanical principles given.

Gray Barker's introduction to the book suggests that the text may possibly have been written on two levels, the conventional UFO text as well as a deliberate encouragement to read between the lines for untold and unexpressed ideas. Mr. Barker further notes that each reader will need to determine for himself how much is Fact or Fiction.

The book offers many concise descriptions of the best known sightings with a chart indicating the "inexplicable nature" of each case, as well as the "most probably scientific cause". Presented, also, is much scientific data relative to nuclear power, atmospheric anomalies, plasma and related subjects.

The questions of whether or not the disc-like craft may be man-made and manpiloted is thoroughly explored, pro and con. The subject is then related to the matter of supposed government censorship of sighting reports.

The experiences of Rex Bell near a nuclear power plant in 1940 are correlated to incidences in the area 28 years later, with some imaginative, though possible implications being drawn.

New words such as Zamn and Gazamn, related to power principles and Cosmo-cybernetics and Cosmocyperloid Beings, new mind stretching concepts, are used and explained. A listing of a few of the chapter sub-titles will indicate the range of topics covered: Zamn Power is Here; Great Eastern Black and Its Many Possible Implications; UFOs and National Economic Problems; Seeming Correlations; Can the Dynamical Principles of Disc-Craft be Revealed?; the Oberdorfer-Gurtheman Tale; the Micro-Nuclear Thrust Engine; and the Ten Astonishing Cases of the Little Men.

Until we have met with space beings and examined their craft we are free to postulate on the nature of the UFOs and of their purpose in our heavens. Document 96 offers many such postulates for your consideration.

For these and other reasons, NICAP was strongly censored in a resolution passed by majority vote of the 1966 Congress of Scientific Ufologists meeting in Cleveland, Ohio, and has been generally considered by serious UFO researchers to be without hope of contributing anything substantial to the eventual solution of the flying saucer mystery.

I regret that LOOK has chosen to publicize this one view within the UFO field at the expense of all others. Our own organization finds itself on good terms with the Air Force and the Condon Committee on the one hand, and at the other extreme, with those who claim personal experiences with flying saucers and/or their occupants. Even this vast spectrum does not include NICAP, however.

### MISSING SUBMARINE

The French Navy had given up hope of finding alive the 52 men aboard the missing submarine, Minerve, according to an announcement issued January 30.

During the same week, not one, but two subs had mysteriously disappeared. At the other end of the Mediterranean, 69 crewmen aboard the Israeli sub Dakar also were hopelessly lost.

While world intelligence organizations speculated that the Soviets might have developed a mysterious new method of submarine warfare, and was testing it out, UFO buffs noted the reports of an "undecipherable transmission" picked up on the same frequency as the Israeli sub's radio buoy.

Again, in the case of the French

sub, mysterious and undecipherable signals were also picked up, this time on sonar, which gave evidence of metallic object on the sea floor near Toulon.

Saucerenthusiasts were reminded of the many reports of flying saucers submerging in the sea and wondered if they could have anything to do with the two mysterious disappearances.

involved in the fiasco including Condon, Low, Saunders, Levine, McDonald and various members of the study - both before and after the blow-up.

Before going further, let me freely admit that I am indulging in Monday morning quarterbacking which is always easier than the Saturday afternoon variety.

The complaint can be stated generally as follows:

1. That Edward U. Condon, aided and abetted by Robert Low, approached the UFO problem facetiously and irresponsibly and with a strong predisposition that there was nothing substantial to the mystery.

2. That Condon made repeated public and private statements which suggested that his mind was already made up even though he had hardly glanced at the evidence.

3. That attempts by members of the Committee to take a firmer look at physical aspects of the problem were discouraged or vetoed while a sustained effort was made to emphasize the psychological aspects of the problem.

4. That when attempts were made to discuss these attitudes, Condon and Low were intractable to the point that the scientific integrity of the project was in jeopardy.

5. Low's memo, "Some thoughts on the UFO project" shows that the project was undertaken in bad faith.

An answer to the complaint might be couched as follows:

1. NICAP's offer to help was really an attempt to control the study. Keyhoe wanted the committee to endorse his own conclusions, adopted twenty years ago without the benefit of research.

2. Dick Hall's (then of NICAP) visits to Boulder for consultations and briefings at Committee expense were devoted partly to attempts to convince younger members of the team that Condon was the wrong man for the job. This led some members of the team to take a paranoid attitude whenever any of their suggestions were turned down for any reason.

3. It should be noted that Saunders and McDonald are also members of NICAP and were part of a sustained effort to undermine Condon. This distractive influence be-

came intolerable and forced the dismissal of the chief offenders.

4. That there may be dissenting voices in any research or study program is understandable, but the prerogative of the dissenter is to write a minority report with the items of dissent stated clearly and concisely for the record.

5. Low's memo was written chiefly for the purpose of convincing certain University staff members that the UFO study could be undertaken without the University's public image suffering as a consequence. Since most of these members were convinced that there was absolutely nothing substantial to the UFO mystery, Low felt it was necessary to approach them in that frame of reference. Nothing in the memo was binding on the study. It was merely the sort of "puffing" that goes along with any selling job.

6. There was no attempt to emphasize the psychological aspects - merely to deal with them. J. Allen Hynek has recommended a study of the people who report UFO - he feels that such a study would show that reports tend to come from normal reliable people.

So much for the two sides of the Fiasco.

APRO, of course, is in general agreement with NICAP as to what a truly objective study of the UFO problem will show. I am, however, in specific disagreement with NICAP's attempt to "take over" the Condon Study. To me it is inconsistent to advocate an unbiased scientific study while attempting to impose one's own bias on such a study.

It can be easily and effectively argued that bias already existed in another direction. I will not dispute this point but will merely point out that there are more effective ways to deal with such bias.

How much better it would have been had Levine and Saunders stayed with the study to its conclusion and stated their dissent clearly and concisely in a minority report (or possibly a majority report). Since Condon's office is physically removed from the Woodbury Hall offices of the study an excellent opportunity existed to compile "files protection" in the form of inter-office memos. Such a report would become part of the record and provide a

stepping stone for future studies. As I understand it, Levine and Saunders would have gone along with the minority report idea (which had been discussed early in the game) but McDonald felt that an immediate confrontation was necessary and personally forced the issue through his letter writing.

It can be argued that time is of the essence of the problem and that we do not have time to wait for the current study to grind to a halt - for another one to get underway, etc., but I am afraid that this "Fiasco" has made the time when a truly, unbiased, unencumbered study is likely to get underway, more remote than ever.

Several years ago Dr. Olavo Fontes wrote that the UFO problem was primarily an emotional one and only incidentally a scientific problem. A problem which science could solve quite readily if the emotional obstacles (in the form of bias, etc.) and political considerations could somehow be set aside. History serves to verify this observation.

It looks like we can now all go back to playing IWWAF, (if it weren't for the Air Force) that social transaction which provides busy work, diversion and various other emotional pay-offs and leads us not one whit closer to a solution of the real problem.

It is certain to be asked by some just what contribution APRO made to the Condon study. Without attempting to insinuate anything more than cooperation, we announced our support of the study at the beginning. When Mrs. Lorenzen and I made our tour of South America in August, 1967, we carried with us a letter from Mr. Low which was designed to help us gather more UFO information on an official and unofficial level. When we

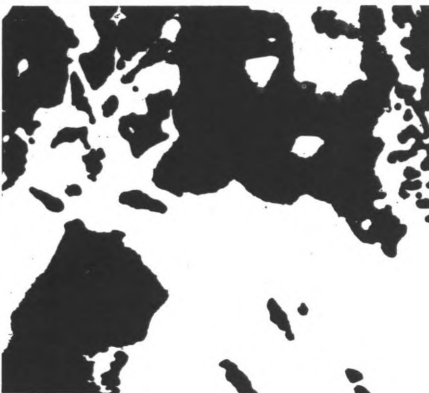
returned, we went to Boulder and briefed the committee on the UFO problem in South America (there was a "flap" in progress during our presence there). We then furnished the committee the names of some 300 APRO members for their "early warning" network, and forwarded copies of APRO's best cases for their files. We still continue to cooperate with the committee in any way possible without attempting to influence the resulting report."

#### CHRIST OF THE MOUNTAIN



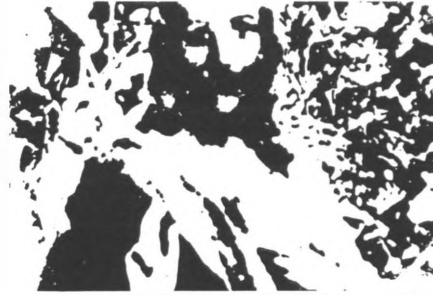

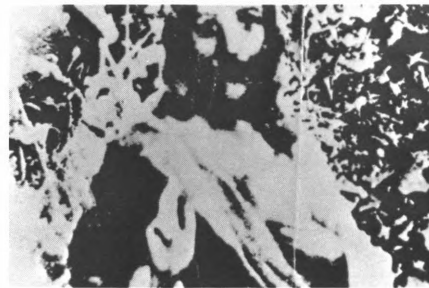
spoke to her and told her to go into the garden and take a picture. She did so, and the image of Christ miraculously appeared in the photograph.

Again, the picture of Christ appeared. Mrs. Phoenix believed the date of the photo was around 1947.



This third photograph (above) was sent in by Mera Gaskill, who wrote us, "Imagine the jolt I received when your magazine showed an exact copy of a picture I treasure greatly, and which I keep framed on my desk. It also is an 'accidental picture of snow', but taken by people I know in California in their back yard during a freak snowstorm in the early 1930's.

"This snapshot was taken of an incinerator in their back yard, with the trees and shrubs overshadowing it - and was taken for the mere purpose of showing they really did have snow there at that time - near Huntington Park, California. When the negative was developed the photographer, in amazement, asked the owner of the negative if she knew what she had on that picture. She said, 'Yes - an incinerator in the snow.' mainly in that it contains more half-tones, which could be lost through a series of copying of copies.

#### STILL ANOTHER VERSION

Mrs. Victoria Cross Johnston of North Bennington, Vermont, sends us still another version of the story, but with a photograph identical to the fourth one reproduced above. She tells us it is ascribed to a Catholic woman in Bennington, who snapped a picture of a snow-covered bush in her back yard.

"Everyone in Bennington bought many copies of this picture," she writes, "because they believed it was a miracle, and I felt too sorry for them to let them know the truth. I could have shown them the same picture, as published in FATE magazine, some years before, with a different explanation.

"Now the same thing is being pulled again," she continued. "What miserable little people there are in the world and what they will do for financial gain!"

Another reader, Edith Chandler, of Union, New Jersey, tells us, "It is strange how that picture and story crops up in various parts of the world. They circulated many many years ago in China. I heard this from missionaries who returned after 50 years of service in China."

SAUCER NEWS reader, Lewis A. Anthony, who sent us the second illustration, printed on a tract, observes that "There are several opinions one can take of this matter! One that I prefer is that the duplication of the pictures is further proof of the existence of Christ."

#### CHRIST IN THE SKY

We received only one picture which was clearly dissimilar to our "Christ of the Mountain" photo, and this is reproduced separately with descriptive text. It allegedly was taken by a pilot during World War II.

We do hope that Mr. Anthony's observations are the most correct. If, indeed, the first of the different versions (if one could track it down) were true, reproductions with conflicting stories, would not necessarily prejudice its authenticity.

In this Christmas season let us believe that the various versions represent a desire to see God daily in our surroundings, and to introduce Him with greater reality into our everyday livings. With that thought, the pictures can become symbolic.

Or like the words of the poem (the title of which we forget and which we probably misquote):

**PHOTOGRAPHIC MYSTERY CREATES SENSATION**—This picture, which appeared in the Ashland (Ky.) Daily Independent, was represented to that newspaper as an actual photograph taken in the sky over Korea. The Independent ran the picture on a Sunday and the entire edition of 14,000 copies was quickly sold out, with people clamoring for more. Two weeks later, also on a Sunday, the paper ran the picture again and again the entire edition was snapped up. Readers sent clippings to friends and the Independent has been receiving hundreds of letters from all over the country. According to the information received by the

paper, an Air Force man from Chicago took pictures of an American and a Communist plane during a combat patrol. He sent the films home to Chicago to be developed. To the amazement of everyone, including the flyer, the image of Christ, supposedly formed by clouds, showed up on one of the photos. A neighbor of the Air Force man's family in Chicago sent a print to his brother in Ashland. Someone there finally mailed it to the Independent. Actual origin of the picture is a mystery so far, because the names of the Air Force man and of the Chicago neighbor family are unknown.

lutionary sequence.

Since intelligence generally springs from a complex organization of cells or components analogous to organic cells, it is not too difficult to imagine sentient galaxies, cosmic dust clouds, nebulae, etc. Such cosmic "master intellects" seem less fantastic when one considers the fact that our own galaxy contains over ten times as many stars as there are cells in the human brain! Cosmic intellects would be the products of the inorganic evolutionary sequence. Intelligent organic life (such as man), would, of course, be the products of the organic evolutionary sequence. The two types of evolution can be more easily understood by expressing them as formulas:

(1) The organic evolutionary sequence:  $A + B = C, C + D = E$

(2) The inorganic evolutionary sequence:  $A + B = E$

Where A = inorganic chemicals and materials, B = special conditions and complexity, C = unintelligent organic life, D = natural evolution, and E = intelligence (Or-

ganic and Inorganic)

From this "jumping off point" we can form a few fundamental concepts and hypotheses about the universe around us.

One of the most perplexing questions facing modern science is the origin and nature of the universe. Is the universe finite and "curved", or is it infinite - without end? Did it ever begin and will it ever end? Is it multi-dimensional or uni-dimensional? Precisely what is this universe and why does it exist at all?

One school of thought contends that the universe is not "self-caused" and hence, is not supernatural in origin. This school of thought believes that there is order in the universe and that there is a cause for every effect. Since time and causes and effects continue throughout infinity the universe had no "beginning". If the universe DID have a "beginning" then our observations are incorrect and the universe does not really have any order (i.e., causes and effects). If the universe had NO beginning, then it will have no end. More simply

stated, we have a universe of infinite time - a universe in which causes and effects continue throughout infinity.

The implications of this theory are fascinating! For if we are given an infinite amount of time and hence, an infinite number of things (events), then, in due time all things become possible! And so we must consider this startling consequence: If all things are eventually possible, then might not the universe expand and contract or "explode" and "implode" simultaneously and thus begin and end simultaneously, actually never having existed at all? If you examine this question closely you will see that time (causes and effects) continue through infinity and thus, that "simultaneous" is a relative term, without meaning in any real sense.

With this theory in mind we can see that the universe is multi-dimensional in nature and contains an endless number of different "realities". Our human "reality", as "real" as it may seem to us, is but one of possible billions.

water.

Also discovered near the Reeves Pioneer Mountain home was a large quantity of aluminum shavings which an analysis showed was composed of magnesium. Taylor suggested that the pilots of the strange craft might be dropping the shavings in an attempt to jam nearby radar tracking stations.

Now the Reeves are gone and so are the lights, the spaceships, and the crawling stump-like creatures. The new owner of the Reeves former home denies seeing anything unusual now, although he had witnessed various phenomena before the Reeves' sudden departure.

Here indeed is a classic case where apparently the operators of the UFOs seen in the Taylor, Oregon, area were keeping watch on a single Earth family, perhaps with the intention of recording their daily activities, much the same as we would do upon the discovery of new life forms whether it be microscopic or higher on the evolutionary scale.

Did the strange phenomena follow the Reeves family, to wherever they had fled? We may never know, for the family informed nobody of their destination.

and green lights on their upper sections". Peering at the objects even closer, they felt that there were searchlights inside that appeared to be scanning the nearby earth, perhaps taking photographs. This light also seemed to change color from red to blue and then to a bright shade of green.

Nor was the Pioneer Mountain area free of what appeared to be physical evidence of these strange visitors. As early as May, 1966, Ed Keenon, a logger, came upon a large

chunk of metal, which under analysis, turned out to be pure sodium. This find was made by Keenon as he walked along a path which passes by a small creek bed on the outskirts of Kernville. To this date no one has been able to locate the source of the sodium or discover what its use might have been. A bomb disposal team from a nearby Army base brought out the fact that the object could not have been in the area very long since sodium is highly explosive when exposed to
