



**SAUCERIAN EXCLUSIVE: INVENTOR CLAIMS TO HAVE CONQUERED GRAVITY!** Pictured above is Otis T. Carr, president of OTC Enterprises, Inc., of Baltimore, Md., holding a "mock-up" model of what might be termed a Flying Saucer. We take this much space for the photo because Mr. Carr told us in a long telephone interview that the picture contains hints as to the actual method of propulsion; then he quoted a Biblical phrase, "He who hath an eye let him see."

Carr told us he had demonstrated a mock-up to "government scientists" in Washington, and that government representatives had also inspected his work at his Baltimore workshop. The scientists, according to Carr, agreed that he was correct in basic theory, and that principles he revealed would allow such a craft to take flight.

We began the interview by saying, "Mr. Carr, being a scientist you probably laugh at what are termed 'Flying Saucers,'" at which point he interrupted in a quite definite manner:

"No, I certainly do not laugh at anyone speaking of ELECTRIFIED FLYING OBJECTS!"

Then I questioned him further about the project. Carr, a 52-year-old native of Elkins,

W. Va., had financed his research with his own modest funds and through private funds supplied by friends. He said he had built many working models. His professional experience, he said, included a dozen different jobs ranging from operating a locomotive to working as a night clerk in a hotel, a job he resigned from two years ago when OTC Enterprises was formed.

The principle of his invention or discovery was, he said, relatively simple, which involved taking electrical power from the air. The same "free energy" which caused the Earth to rotate on its axis and orbit around the sun would turn a machine he described as two cones joined at their circular basis. When the rotation of such a machine reaches a certain velocity relative to the Earth's orbital velocity, Carr said it would take off. From what we could learn from his rather technical language, the machine, in essence, involves a kind of central core which is chemical in nature and functions like a storage battery, only it taps atmospheric electricity. The machine would function both in our atmosphere and in space.

**CARR'S PROPOSITION TO THE GOVERNMENT:** OTC Enterprises would build a working craft, circular in design, and approximately 45 feet in diameter by 15 feet in height, with a crew compartment that would accommodate at least three persons in comfort under conditions encountered to within 1,000 miles from the Earth. The craft would depart from any specified location in the continental United States, orbit one or more times outside the Earth's atmosphere, and land its crew safely within the inner rotunda courtyard of the Pentagon Building in Washington, or at any other location best suited to public observation. The craft would be powered "from natural environmental sources acting in motion-concert with self-contained chemical components of the Utron power-package and needing no additive, servicing, or replacement prior to at least one year of operation in or out of the atmosphere."

Our understanding is that OTC Enterprises would collect no monies until delivery, at which time the firm would be paid \$20,000,000 for the first unit, and could purchase additional identical units at \$4,000,000. Delivery would be approximately 24 months at quoted prices, sooner at more cost.

The Government, according to Carr, was at first enthusiastic, then turned thumbs down, and issued a release discrediting his discovery.

THE BULLETIN is trying to learn more. Meanwhile the Editor is inspecting a large packet of data from OTC, including one beautiful brochure equal to something which General Motors might issue, and which looks as if it would cost a fortune to print. Regardless of whether or not Carr can build a Flying Saucer, there is surely money behind the concern.

Carr is going ahead on his own, has offered his inventions to private industry, and will develop his "Electrified Flying Objects" independent of Uncle Sam. It was rumored that Carr would offer his discovery to the Soviet Government, but there was no mention of this in the interview. Unfortunately space does not permit a more complete article on Carr, but we hope to have more in the next issue. This information reached us just as we were about ready to go to press, and we hurriedly included it (even pushing the rather startling information from George Adamski to the last two pages of this issue).

A few more points about Carr to be elaborated on later: He believes in Flying Saucers as they are sighted today. He feels they may come either from space or some unknown source on the Earth. He offered certain information to the Government in 1949, feels actual development from that information could have been made by Uncle Sam. He also believes some saucers could be "electrical life" created in atomic explosions. But as we say, more later.

CONCERNING OUR NOTE in last issue that it was rumored the book, "THE THIRD EYE," was a hoax, by now most readers will have read the TIME Magazine writeup on alleged Lama, T. Lobsang Rampa, who really wasn't a Lama at all, and who had never even been to Tibet. Private detectives, hired by a Tibetan association, discovered his name was really Cyril Henry Hoskins, a plumber's son. Hoskins now claims his fascinating book (we have it at \$3.50) was written while he was under the possession of the spirit of a real Tibetan monk. Well, this could be, but "Rampa" should have represented it in that way in the first place. Even if fiction, the book contains many truths most people will profit from, and regardless of exposure of the alleged "hoax," the book will always occupy a most prominent position on my own personal book shelf, and no doubt will be re-read many times. Lobsang, we still love you!

The accounts of ACTUAL MEETINGS WITH SPACE PEOPLE keep cropping up. Where there is smoke, there is likely to be fire, but we doubt very much if all of them are true. Edmund Rucker, of El Cajun, Calif., is one of the latest Earthians to be so visited, according to an account he wrote to the San Diego Union on December 6 of last year. Rucker was skeptical of saucers in general, he said, until he had an experience that even made him doubt his own senses.

Rucker thought it was a plane which had awakened him, but it had an unusual sound and aroused his curiosity enough for him to get out of bed. He looked out the window and was amazed to see what looked like a strange kind of helicopter descending into his back yard. The thing had windows, and he saw strange looking heads inside. A side door opened and a little man, followed by others, got out. They were about four feet tall, were green, had large heads "with dome-like foreheads and bulging eyeballs."

Rucker's spacemen didn't have German accents, spoke English distinctly. They told him he shouldn't be skeptical about space people and space craft from other worlds. They were gentle about their reproach, however, and smiled as they talked. The spokesman said he and his crew were from Venus, which had a civilization centuries ahead of Earth. Again he assured Rucker they were friendly and meant no harm.

Then the account took up overtones of the old stories of witches and demons, for as the first cock crowed the little men appeared to get nervous, got back into their machine and soon flew away. Rucker didn't think to awaken his wife, so he was the only witness.

THE BULLETIN received the above account via Norbert Gariety, who runs a very interesting publication, probably better than this one, titled SPACE (267 Alhambra Circle, Coral Gables, Fla. --monthly, \$3.00 per year). One of SPACE's on-the-job correspondents personally drove to El Cajon and interviewed Rucker, who he found to be 50 years old and who lived in an attractive neighborhood. The investigator, Joe Cromwell, told SPACE he was convinced that "Rucker's claim holds a lot of truth." He added that Rucker said he had seen physical beings and that it did not involve a psychic experience.

The current issue of SPACE also notes a very brief account of a truck driver, Malvan Stevens, who claimed to see four  $4\frac{1}{2}$ ' little men near a grounded UFO on a highway near Meridian, Miss, on November 7, 11/8

HERE'S A REPORT FROM OCTOBER of last year which was held up until one of our own investigators could get us a report on it. Then somehow it was crowded out of the last two issues. The sighting involves Mrs. Edward Yeager who lives in a trailer on the Duanesburg-Church road extension near Schenectady, N.Y. Mrs. Yeager reported to deputies and Mariaville Fire Chief Everett Smith that she had seen a spaceship land and little creatures emerge from it. Here is the report from our investigator who prefers not to have her name mentioned:

"I have just finished talking to Mrs. Mabel Yeager who saw a space ship land near her trailer on Duanesburg-Church Road, near Mariaville Lake.

"She is a woman of normal intelligence, good looking and young, probably 25 to 30. She has two small children: a little girl of kindergarten age, and a baby boy 10 months old, bright and active like his older sister. We had a little difficulty getting together as she has no telephone; and my husband made two runs up there before he found her, then gave her a letter from me, after which she contacted me by phone. Then I made arrangements to meet her at her trailer home.

"The sightings took place on October 9 and 10. On Wednesday, the 9th, her neighbor had asked her to look after her children at her trailer until she returned from shopping. She had made cookies and hot chocolate for them and was sitting in front of the picture window in the trailer, waiting for the school bus which would bring the children home. It was a cloudy, cold day, the wind blowing quite hard. Something caught her eye and she thought some of her neighbors' clothes had blown off the line and out toward an open field. On second look, she spotted a round object which reflected light like aluminum. It went down behind the hill, was gone about 2 to 3 minutes, then re-appeared as it ascended.

10/10 "The next day about the same time she was out in her yard to the left of the trailer feeding her chickens and ducks, and was returning when she suddenly heard a noise which was similar to a pinwheel that you might put on your car, but much louder. The poultry began running in all directions, squawking loudly. She noted that even the drake that was formerly apparently afraid of nothing also appeared to be greatly frightened. Then she looked up and saw the same object she had witnessed the previous day, which this time settled to within about six feet of the ground. Two small dark objects got out and hopped into the woods near the trailer. Mrs. Yeager didn't get a clear view of them; she is not sure whether it was because she was frightened or because they were moving so fast they appeared to be a blur.

"The object stayed there about two minutes, then took off in a vertical direction, sucking up leaves, grass, dirt, etc., with it for a short distance, and then the stuff dropped to the ground. The machine made the same whirring noise she had heard before. By this time she was thoroughly frightened. She went into the trailer, grabbed up the baby, then got into the jeep and drove to her friend's house up the road. When she arrived she told them what she had seen and of course they laughed and went to look out the window. The elder of the two ladies looked at her noted she was white and shaking; then they began to believe she really did see something. When the school bus came shortly afterward she asked the driver what she should do, and related her experience. The driver advised her to notify the police, and she called the N.Y. State Police at the barracks in Duansburg. At first the authorities didn't believe her, but when she asked for police protection they finally sent two state troopers to the site of the landing, along with a Deputy Sheriff. The woods were searched, with no success at finding the little man, if that was what it was.

"What wasn't in the papers was the fact that a Lab man who works in a laboratory in a nearby city (and I will eventually have his name and address) was interested enough to go up there, and found some white material on the ground that looked like lime -- although no lime had ever been used there. It was stuck fast to the grass. He took samples of it and is going to give Mrs. Yeager a report on it. The bus driver said he thought he had seen two of the saucers (of the same type) side by side in a field around that same time."

WELL, THAT WAS A WEIRD REPORT, since complicated, we understand through our correspondent, by a visit to Mrs. Yeager by a little black man, but the report is too fragmentary to include. Perhaps we can draw out some more of this from our reporter. We have another weird report, but have to work in here somewhere the information about Van Tassel's annual Spacecraft Convention, which will be held this year on Saturday and Sunday, May 31-June 1. The editor may be able to make the convention, not that he necessarily endorses the claims of Van Tassel, but for the reason of meeting so many other "saucerers" there. Now even if we, ourselves, do not claim to be a supporter of VanTassel, perhaps some of you are interested in learning more about the fellow, who claims contact with space people, mainly through radio and telepathy. With this in mind we are arranging to supply Van Tassel's second book, INTO THIS WORLD AND OUT AGAIN. We have it in stock at \$1.50. It is paper bound.

NOW HOLD ON TO YOUR HATS, for here's a letter from a woman who believes she has seen a couple of dero, people from caverns beneath the earth, as described in the writings of Richard S. Shaver. Incidentally, Mrs. Cosette Weiss, of Las Cruces, N.M., is in the same general business as the editor (she operates a drive-in movie theatre), and she writes as follows:

"This may not mean anything at all, and then again it might, so I'm going to tell you. As I have told you before, we own a theatre at Mesilla Park (a suburb of Las Cruces) and there I have the opportunity of meeting a lot of people. About two months ago a gypsy man and woman moved into Mesilla Park and set up permanent residence here. She tells fortunes, and he has a used car lot. They are quite peculiar people -- not like ordinary gypsies at all. They dress well and they drive a beautiful new car. Last night I decided to put her to a little test while she waited in the lobby of our theatre.

"I casually asked her if she knew anything about the Shaver Mystery. Well it seemed to scare her to death and she said, 'No, I don't know anything about it.' But why would she have been so frightened? Shaver stated that not all gypsies are what they pretend to be. He said some of them come from the caverns. You may think I'm foolish to even wonder about this, but since I've lived in Los Cruces and become interested in UFOs, I have had many strange experiences. Some very frightening things I cannot explain. I shall continue to watch these people."

WELL, OF COURSE MRS. WEISS IS FOOLISH, but aren't we all? And it is often the foolish people, who are looking for unlikely things, who put things together and come up with startling and workable new ideas. Incidentally, Mrs. Weiss received a rather strange letter from an AF man, regarding one of her sightings. The letter itself was not strange; it merely asked for information about a sighting she had experienced. But the letterhead WAS peculiar. It was not printed, but typed -- as follows: Headquarters, Electronics Services Unit 4, REMENIAN PROXIMIAN AERO FORCES (3RD METALUNAN FLEET) Crookston, Minnesota. That's one for the the books! A hoax? maybe.

Dear Mr. Barker:

Although it has been a long time since I have received your bulletins, I know you are kept busy with them and other work. I am sending you this information because I believe you will be interested in it and able to use it well.

As you can see from the date on the envelope, the original letter was mailed on December 16th. I hesitated releasing it because I did not want to cause any trouble for Mr. Straith. Yet the letter was of no value until released. So I investigated in every way possible to be sure of who Mr. Staith was and of whether or not he would be hurt.

The time has now come for the people of our nation to know of the contents of his letter and to act, if they want the truth of our interplanetary visitors, which could also lead into paths of peace and interplanetary scientific development rather than destruction which is now staring us in the face.

Therefore I am asking you and everyone I know to get this information to the people in every way possible and without unnecessary delay.

From unimpeachable sources I have learned that the Air Force is in no position to give such information to the people. It is a subordinate department of service in our government whose leaders are appointed and can be released from duty by orders from one person higher up. Only from Congress can such information come. And from the contents of the accompanying photostat letter we learn that the State Department, through its own researches, does have the facts.

The members of Congress are elected by the people. As their representatives, each such representative owes a responsibility to the people who put him in office. And it is these men alone who are in a position to give this truth to the people of our nation and to the world.

Booklet #2 of Questions and Answers will arrive from the printers next week. In it is a copy of this letter. And with it in mailing will be a letter asking the people to write to Vice President Nixon, their senators and their representatives in the House demanding that they release the facts which they have available to them regarding the space travelers. Since these men look to the votes of the people to keep them in office, I am asking the people to tell their representatives that unless the truth that is so badly wanted and needed is forthcoming within the near future, they need not look for support and reelection in coming elections. Pres. Eisenhower is not eligible for reelection.

As I have been told, the people, according to our Constitution, have it in their hands to be given the truth. They have now been told how to get it. So it is up to them to prove whether or not they are sincerely interested in the matter, sufficiently to act. For if Washington is flooded with letters, telegrams, telephone calls and visitors demanding this one thing, results will be forthcoming quickly.

Mr. Straith experienced quite a battle within himself before writing that letter. He knew what could be its results, and the many possibilities facing himself and many others if the people of our nation were not wholeheartedly sincere in their attempts to have authoritative information revealed. And to have complete success there must be prompt and united effort from every part of our nation.

Photostats have been sent to many nations and the people there are but waiting word from here to give it public release. I am sending it from here to all who have expressed any interest in the matter. And I am asking the support of every group I know to get the word around. I can do no more. But this will prove how well the American people can stand together and work as one toward the accomplishment of a goal vitally important to the entire world, but without monetary recompense, at least at present, to anyone.

YOU HAVE JUST READ A LETTER FROM GEORGE ADAMSKI, on page 5, if you have been reading through THE BULLETIN from the beginning. We wanted to reproduce this letter photographically, so that everyone would know it wasn't made up or misquoted in any way. In publishing this letter, without any investigation, we certainly do not endorse it as fact, because directly and in effect, George Adamski makes a claim even (to us) more startling than his previous accounts of meeting space people and riding in their craft.

MORE IMPORTANT THAN ADAMSKI'S LETTER was another letter (in photostat form) which he enclosed. This photostat was of a letter written on State Dept. stationary, which is almost an endorsement of Adamski's claims, though the writer of the letter is careful to say it is a personal communication, "and is not to be construed as an official communication of the Department."

Such a letter and such an endorsement, even though limited, is almost impossible for us to believe, and we aren't speaking of Adamski's claims, but the fact that a government official would go out on such a limb.

THERE COULD BE A GOOD EXPLANATION other than that Adamski believes. Maybe some official went out on a personal limb, not feeling that Adamski would publicize the letter (which he evidently intends to do through the booklet he mentions). We thoroughly suspect that such an individual is in very hot water, for regardless of whether or not the government, the AF or the Department of State believes that Adamski actually met space people, it would be too much of an about-face to officially endorse saucers from space at this time.

NOW THE BULLETIN tends to be over-skeptical, maybe; but that perhaps is the best policy when trying to publish news in as fair and unbiased a manner as possible. The following does not come to us from Adamski, and it may be incorrect. From other sources we learn that Adamski recently held a press conference in which he stated he confirmed the following with the AF: The period from February 10 to February 20, '58, would be used by the countries of the world to announce simultaneously the reason the Flying Saucers are here. Well, it didn't happen, and maybe Adamski was misquoted. We have asked him to comment on this for our next issue.

WE WISH YOU WOULD WRITE TO ADAMSKI instead of to THE BULLETIN if you have further questions about the letter. This will cut down on the volume of our correspondence, which is a real task to keep up with, and we've told you about all we know on the matter, except for publishing the letter. If we obtain any additional information, it will be in the next BULLETIN, out in another month if we can make the deadline.
