ARE LABOR TROUBLES IN AMERICA ABOUT TO END?

THE student of social conditions in the United States is confronted by the question as to whether or not the very commercial greed which is alleged to have brought on the labor problem will not itself end it.

Writers on the subject find much to say on both sides of the question.

There are those who take a discouraging view of the situation.

One of these, Mr. Ghent, in a recent article in the *Independent*, has outlined his belief of what the near future in America will be. He predicts what he calls a "benevolent feudalism," in which the money barons will be the absolute lords of the country, with their court agents and other dependents, divided into twelve classes, or grades.

His prophecy is that the analogue of the serf, bound to the soil, in ancient feudalism, will be the workman bound to his "job" in this new feudalism.

He foresees less and less opportunity for a man to better his condition, or for his children to rise to anything better than he enjoys.

As his reasons for making this prediction, Mr. Ghent brings forward, among others, the alleged facts that the money barons, by the power of gold, will direct the course of legislation for their own interests, purchasing the voices of political leaders, and the pens of editors to delude the voters into a belief that any change from existing policies would bring on financial panic and ruin; that the concentration of wealth will continue until the man who gives up or loses his job in one establishment will be unable to find one in any other on account of being blacklisted; and that there will be no great danger of a disastrous popular uprising, owing to the fact that the

money barons will continue to control the military power of the nation.

All these arguments, and the deductions therefrom, seem very plausible.

But there are many flaws in Mr. Ghent's logic and in his judgment of humanity and of the elements which enter into the control of human affairs.

It is true that the concentration of wealth and the supposed power which it gives, is becoming more menacing.

It is true that legislation is, all too often, controlled by Mammon.

It is true that labor is being oppressed in many places.

It is also true that labor itself, when organized in the labor unions of the time, is tyrannical and unjust.

It is true that walking delegates get their sustenance by stirring up trouble.

On the other hand, there are many hopeful signs of the times.

Both sides of the capital and labor controversy have found that the attitude of antagonism each to the other has been unprofitable.

The country at large has also found these troubles unprofitable.

Strikes, lockouts, boycotts, and the other methods of warfare between labor and capital have cost the workingmen and their employers in America billions of dollars during the last few years.

They have cost not only money, but thousands of lives.

The blood of those murdered in the strife, and of innocent women and children who died as the result of insufficient food, clothing, and shelter, has been crying out from the ground for vengeance.

Strikes have cost the virtue of wives, mothers, and daughters who have been forced into lives of shame because of poverty resulting from these troubles.

This tremendous loss has been felt, not only by the capitalists and workingmen directly interested, but by the whole commercial, industrial, and financial world.

The business of the entire nation has been crippled for months at a time by the useless strife, causing uncounted indirect losses.

The City of Chicago recently saw a year of business stagnation, when all the rest of the world was prosperous, on account of the Builders' strike.

It is also a notable fact that while these strikes, in the vast majority of cases, have resulted in no gain to the workingmen, they have also resulted in no gain to their employers.

It would seem that after many years of most costly tuition in the School of Experience, both capital and labor, aided by all the commercial and philanthropic forces of the country, would make a most determined effort to settle their differences without resorting to violence.

Pure business sense, entirely apart from all considerations of morality, would demand such a course.

Such an attempt seems to have been honestly made in the organization of the Arbitration Committee of the National Civic Federation, with Senator Marcus A. Hanna as its chairman. This Committee has a sincere appearance, since it is composed of equal numbers of the highest representatives of capital, of labor, and of ecclesiastical, professional, and commercial leaders of the country.

If the reports which have followed the forming of this

Committee are reliable, it has succeeded in settling several strikes to the satisfaction of all concerned, notably the threatened coal miners' strike and the Boston teamsters' strike.

This is a most encouraging outlook, and would seem to indicate that the costly lesson has been learned.

Let Zion hope and pray that it has and that arbitration may everywhere succeed violence.

Another exceedingly encouraging sign of the times is the increasing tendency on the part of capital to divide its profits with the laborers who helped to produce them, pro rata according to their wages.

The great Steel Trust, which is doubtless one of the wealthiest corporations in America, has taken some steps in this direction.

Profit-sharing is the only rational and right solution of the labor problem.

Another encouraging condition is the increase in the number and amount of savings deposits in the savings banks of the country, and of the number of small shareholders in industrial concerns, which shows that the working people are themselves becoming capitalists in a small way and as such are becoming more independent of the great money barons.

This tendency will be very greatly strengthened if the losses caused by strikes and other labor troubles do not occur.

Great money power, or great power of any kind, wrongly used, always has within itself the seeds of its own destruction.

This Mr. Ghent does not take into consideration.

It is too late in the age for Mr. Ghent's "benevolent feudalism."

The general tendency of the race is always upward.

God is now preparing the world for the advent of Christ, His Son, to reign as King.

The signs of the times point unmistakably to great industrial and commercial reforms, which will pave the way for the establishment of the Rule of God in manufacture, transportation, agriculture, the liberal arts, trade and finance, through the agency of Zion.

It is a bold statement.

It is nevertheless true.

Zion has already established the rule of God in her business, and it is the promise of God that "the Little One shall become a thousand, the Small One a Strong Nation." A. W. N.

NEWS OF ZION CITY

ON Tuesday, April 15, the third subdivision of Zion City lots was opened for selection.

This was the Second Series of lots, the first and second subdivisions being opened in the First Series.

For several days before this, Zion City had been thronged with shareholders in Zion Land and Investment Association, looking over the land, and preparing to make their selections.

The lots opened include all those south of Salem Boulevard, east of Gilgal Avenue and north of Thirty-third Street not

Second Series of lots has made it more than ever certain that Zion City will fulfil the rosiest predictions made for her by her most enthusiastic citizens and friends.

Those who came to that city on this beautiful April morning saw on every side the plainest indications of great prosperity, growth, and the brightest of prospects.

A most encouraging incident of the week has been the very brisk demand for stock in the Third Series, the sale of which opened on Wednesday morning, April 16.

The evening before the Second Series

by Zion City Horticulture Department, and many thousands, which have been growing in Zion City Nursery for some time are now ready to be transplanted.

A splendidly equipped nursery is being installed in the southwest corner of Shiloh Park by Mr. E. B. Ellis, Superintendent of the Horticultural Department.

Zion City Engineering Corps is laying a long tile drain for the proper drainage of the ground at this nursery and to carry storm waters from Gabriel Avenue.

Edina Park will be the first park to be improved at Zion City. This is, as it

opened for selection in the First Series.

There are thirty-nine blocks of these lots, containing from sixteen to thirty lots in each block.

So great was the demand for these lots that practically every one of them was applied for by the purchase of stock in Zion Land and Investment Association before the opening day.

The day was marked by perfect spring-time weather, and happy homeseekers flocked into the City on every train, adding to the large numbers who had come during the previous days.

Although a very large force of helpers was on hand at the Zion Land and Investment Association offices, it was with difficulty that all comers were waited upon.

The unprecedented success of this

was closed and the Third put upon the market, there were numbers of applications for this stock, which will be the finest yet offered for sale by the Association.

Not only will this stock entitle the holders to preferential privileges in the selection of lots in one of the most desirable portions of Zion City, but it will pay eight per cent interest and dividends after the first of July.

EXTENSIVE PREPARATIONS are being made for the improvement and beautification of Zion City parks, boulevards, and streets.

Large numbers of hardy and beautiful shade and fruit trees have been ordered

were, the front dooryard of the City, lying immediately east of the residences along Edina Boulevard and west of the Chicago & North-Western Railway tracks at the point where the station is to be built.

In order to make the improvements on this park possible an artesian well will be bored at once. Preparations were begun on Tuesday morning, April 15.

Thousands of trees will also be set out along the streets, avenues, and boulevards, this Spring, by Zion Land and Investment Association. Besides these, hundreds of the residents have fruit and shade trees set out upon their lots.

In a few years, Zion City will be in a great bower of beautiful trees.

PLANS HAVE BEEN made for Zion City Administration Building, and a new and

commodious Zion City Hospice, both of which will be built at once.

The Administration Building will be built on the west side of Elijah Avenue, between Shiloh Boulevard and Twenty-sixth Street.

It will contain the Headquarters Offices of Zion City Bank, Zion Land and Investment Association, and other Zion Institutions and Industries, the office of the General Financial Manager, the General Auditor and Chief Accountant of Zion's Institutions and Industries, and other financial and industrial offices, together with the offices of the Mayor, Clerk, Treasurer, and City Attorney of Zion City and the Council Chamber of Zion City Common Council.

The New Zion City Hospice will be built on the east side of Elijah Avenue, between Shiloh Boulevard and Twenty-sixth Street, and will have about 190 rooms. It will be 450 feet long by thirty-eight feet wide, and three and four stories high.

It will be steam heated and electric lighted.

It is intended to have this Hospice ready for occupancy by July 15.

A LARGE FORCE of workmen is employed in various parts of Zion City Central Electric Power House, hurrying that building to completion.

One gang of men is employed in laying the roof, others are finishing the three outside walls now built, others are putting in the enormous concrete foundation for the engine and generators. The great iron smokestack is ready to be hoisted into position, and preparations are being made to build the north wall of the structure.

At Zion Lace Industries Building, carpenters are putting the roof on the mending building, laying the floors in other parts of the building, and preparing to add the spire to the tower which arises from the west front.

Plumbers are putting in position the water service and sewer pipes for the lavatories, and bleachery and finishing experts are setting up the machines in their respective departments. Both of these are well forward, and it will be but a short time before the beautiful, filmy fabric, which is the product of these Industries, will be ready for the market.

THE OFFICE ANNEX to the Temple Cottage, for the use of the General Overseer and Overseer Jane Dowie and their personal staffs, is now rapidly approaching completion.

The office fixtures and library are being removed from Zion Building, Chicago, and will be placed in the new building within a few days.

THE FINISHING of the interior of Shiloh Tabernacle has been practically accomplished, and on next Tuesday afternoon, April 22, the General Overseer and Overseer Jane Dowie will open the Great Series of Divine Healing Meetings, which will be held every Tuesday and Thursday afternoon in this Tabernacle.

Arrangements are being made for train service between Chicago and Zion City for the purpose of accommodating those who wish to go out to these meetings in the afternoon, and return the same evening.

Thousands are looking forward longingly to these meetings, and great blessings in Salvation, Healing, and Cleansing, will flow, in Streams of Life, from this consecrated building, upon consecrated ground, to all the earth.

ON WEDNESDAY evening, April 23, a Ratification Meeting will be held in Shiloh Tabernacle, at which the platform adopted by the Theocratic Party and the Mayor and Aldermen and other officers of Zion City, elected on that day upon that platform, will be endorsed by a great citizens' gathering.

At this meeting the General Overseer will deliver an address upon the motto of the Theocratic Party, "Where God Rules, Man Prospers."

A special train will leave the Wells Street Chicago & North-Western Depot, Chicago, on that evening, at seven o'clock, and will arrive at Zion City at eight. It will leave Zion City soon after the meeting at the Tabernacle is dismissed, and will make the return trip to Chicago in an hour.

The fare for adults for the round trip will be thirty cents.

ZION CITY POSTOFFICE now receives and sends out mail at the Zion City station, on the Chicago & North-Western Railway, six times each day.

The fixtures have been put in perfect order, and already the postal business is so large that it keeps Postmaster George E. Wiedman and his first assistant, Miss Rose M. Bell, hard at work all through the day and into the evening.

ZION CITY BRANCH of Zion Printing and Publishing House also occupies this building on Elizabeth Avenue and Shiloh Boulevard. Its stock and fixtures are being arranged for business.

A counter for the sale of LEAVES OF HEALING, THE ZION BANNER and all other Zion Literature, also Bibles, hymnbooks, pictures, etc., will very soon be opened at Shiloh Tabernacle, and conducted as a department of the Branch.

THE ARTESIAN WELL in Shiloh Park is now sunk to a depth of 1500 feet. It flows at the rate of 180 gallons per minute. This capacity, with the reservoir equipment, is sufficient for the uses of a residence population of 5000 people. It has been decided, however, to sink the well fifty feet further into the potsham, or water-bearing sandstone, insuring a greater and more surely permanent flow.

Arrangements have been made to sink deep wells upon all sites of schools throughout the City.

It is also the intention of Zion Land and Investment Association to offer residents facilities for the sinking of deep drivewells upon their lots. The use of the shallow surface water wells will be discouraged in all parts of the City, and every effort will be made to cheapen the cost of deep wells, so that there will be no danger of poisoning from impure drinking water.

The Week in Congress

LEGISLATION of the most important character has marked the proceedings of both Houses, and such satisfactory progress has been made that the leaders are now predicting that final adjournment can take place about June 15.

Cuban Reciprocity Bill.

The differences of opinion between the two Houses are so great, regarding this bill, that it has almost become a party issue. The policy of the Republican leaders is not to limit the discussion in any way, and especially not to provoke the beet sugar men.

The ultimate passage of the Payne Bill, providing for a twenty per cent reduction on the products of Cuba after the negotiation of a reciprocity treaty, and the enactment of our immigration laws by the Island Republic is regarded as a foregone conclusion.

Up to the present time, a large majority of the Democrats favor the greatest possible freedom of trade with Cuba, and would vote for a deeper cut than the Ways and Means Bill proposes.

Others are in favor of the immediate annexation of the islands, and quite a number oppose strenuously any tariff concessions whatever.

The general debate will be allowed to exhaust itself. The real fight will then come when the bill is read for amendment. The Democrats will then seek to offer amendments, having for their purpose the opening up of the whole tariff question.

Chinese Exclusion Bill.

The House passed the Chinese Exclusion Bill after incorporating in it several amendments which increased the drastic character of the measure. The principal one not only excludes Chinese by birth and descent, but all Chinese of mixed blood. The chief struggle was over an amendment to prohibit the employment of Chinese sailors on American ships.

An amendment covering this proposition at first was ruled out on a point of order, but subsequently was modified to evade the ruling and was adopted, 100 to 74.

As passed the bill practically reenacts all the existing exclusion laws and incor-

porates with them the existing treaty regulations. It extends these exclusion laws to the Philippines and the other possessions of the United States, and forbids Chinese laborers in colonial possessions coming into this country. The Philippine Commission, by the terms of the bill, is directed to adopt proper measures for the enforcement of the provisions of the bill in the Philippines.

Fowler Banking Bill.

Democratic leaders of the House are fairly hugging themselves with delight

over the action of the House Banking and Currency Committee in agreeing to report favorably what is known as the Fowler Banking Bill. The Democratic leaders make no secret of the fact that they propose to make this bill the one great financial issue of the Congressional campaign this year. This bill provides for the complete retirement of the greenbacks of the country. The Government is required to redeem them all in gold sooner or later, and their place is to be taken absolutely by notes issued by the National banks of the country. These asset notes are not to be guaranteed by the United States at all. The only control the Government will have over them will be by means of a small rate of taxation, and the limit of the asset bank notes is only that of the capital of the National banks which issue them. The Democrats will charge the Republican party with conspiring to retire the greenbacks and put the circulation of the country into the hands of National banks. They will argue that this is part of a scheme on the part of the banks to control absolutely the financial system of the Government. They will assert on the stump that when the United States notes have all been retired and the paper money of the country is absolutely in the hands of the banks, those institutions will then be able by the mere process of inflation or contraction of the currency to make money cheap or dear, and thus to cause it to become a commodity to be controlled ultimately by a great financial trust.

Anti-injunction and Anti-conspiracy Bill.

The House Committee on Judiciary filed its report on the bill popularly known as the Hoar-Grosvenor anti-injunction and anti-conspiracy bill. The measure has attracted much attention in labor and railroad circles. The report summarizes its purposes as follows:

"If this bill becomes a law in all labor disputes between employers and employees the following conditions will exist: It will not

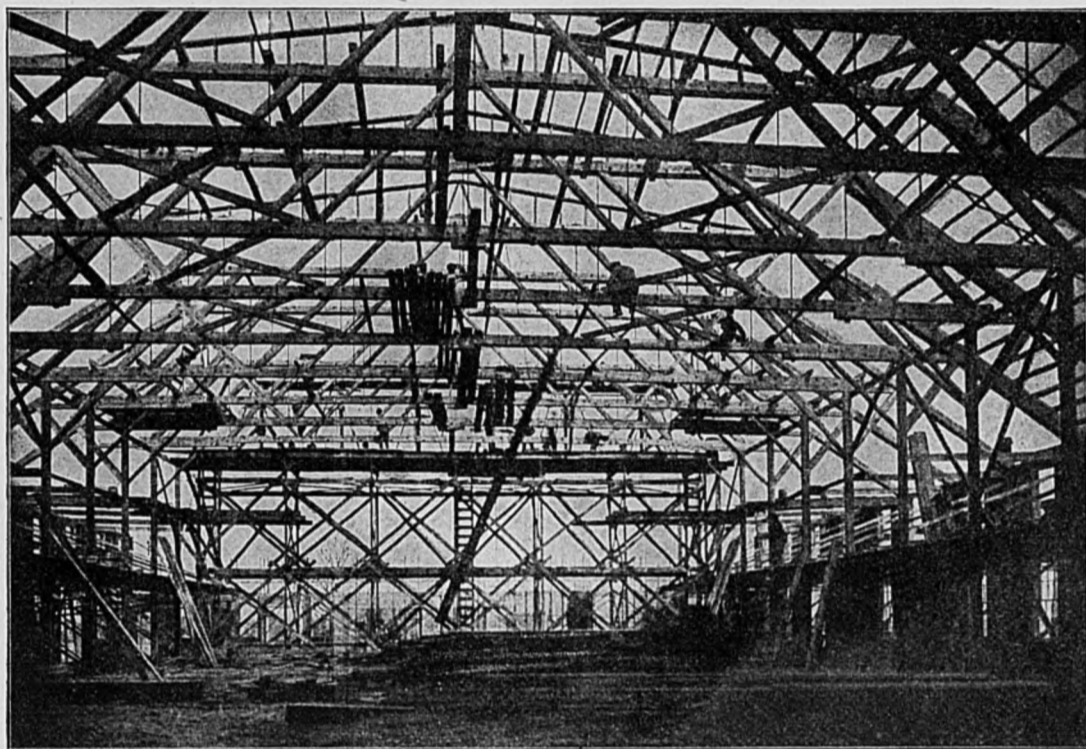
be a crime merely to make a contract, combination, or agreement to do an act which may be in restraint of interstate or foreign commerce, if such act when committed by one person acting alone would not be a crime.

"It will not be a criminal conspiracy for two or more persons merely to contract, combine, or agree to do an act in restraint of interstate or foreign commerce if such acts would not be criminal if actually committed by one person acting alone.

"No injunction or restraining order will lawfully issue if based solely on such contract, combination, or agreement.

"It will be a crime for two or more persons to contract, combine, or agree to do any act in restraint of interstate and foreign commerce which is criminal when committed by one person acting alone.

"It will be a criminal conspiracy to contract, combine, or agree to do any act in

over the action of the House Banking and Currency Committee in agreeing to report favorably what is known as the Fowler Banking Bill. The Democratic leaders make no secret of the fact that they propose to make this bill the one great financial issue of the Congressional campaign this year.

This bill provides for the complete retirement of the greenbacks of the country. The Government is required to redeem them all in gold sooner or later, and their place is to be taken absolutely by notes issued by the National banks of the country.

These asset notes are not to be guaranteed by the United States at all. The only control the Government will have over them will be by means of a small rate of taxation, and the limit of the asset bank notes is only that of the capital of the National banks which issue them.

The Democrats will charge the Repub-

restraint of interstate and foreign commerce if such act would be criminal when actually committed by one person acting alone.

"Nothing in the law will sanction a resort to force or violence or intimidation by a show of force in aid or furtherance of any trade dispute, or make innocent or nonpunishable any act done (aside from the mere making of an agreement or contract), that is otherwise punishable as a crime."

MISCELLANEOUS.

An agreement was reached by the House Committee on Agriculture to adopt all the Senate amendments to the oleomargarine bill with some slight modifications. This means that the House accepts the Senate amendments concerning renovated and process butter. These the House Committee has changed slightly, but not enough to alter materially the purpose of the Senate.

It has finally been decided that Lieutenant General Miles is to be retired at an early date. The troubles which began long ago under the Cleveland administration have finally reached so critical a stage that the compulsory retirement of the General at an early date is an open secret.

A favorable report was made by the House Pension Committee on the bill providing for a pension of \$5,000 for Mrs. McKinley, widow of the late President. This measure has already been adopted by the Senate, and it will soon be passed by the House.

All payments for the construction of the Chicago public building may be stopped by the Secretary of the Treasury on May 1 if Contractor Peirce does not complete the structure so as to turn it over to the interior finishers at that time. Already \$110,000 has been withheld from the payments due the contractor so as to protect the Government against loss, and by May 1 this amount will be increased to approximately \$180,000, or ten per cent of the total contract let to Mr. Peirce.

Senator Hanna has made arrangements for furnishing the bail necessary to secure the temporary release from prison of Major E. G. Rathbone, former Director of Posts of Cuba, who was convicted of complicity in the Cuban postal frauds. The Senator has been advised by Rathbone's counsel that the Court has fixed the bail at \$100,000. Mr. Hanna regards this sum as

unreasonable, and will ascertain if it is possible to have it reduced.

A lively debate between Mr. Depew and Mr. Money, of Mississippi, over the election laws of the Southern States was a feature of one day's session of the Senate. The discussion was the result of remarks made by the New York Senator in talking of the proposed amendment to the Constitution providing for the election of Senators by popular vote. Mr. Money said he could not understand how the sovereignty of a State would be invaded by the adoption of an amendment to the Constitution providing for the election of Senators by the people, but he could see that the efforts of corporations and trusts

office Appropriation Bill, which was adopted by the Senate after thirty-six minutes' consideration. The conferees have agreed to the Senate amendment providing for an appropriation of \$500,000 for pneumatic tube service. The service will be installed in Chicago, St. Louis, and other Western cities, as well as re-established in New York, Boston, Philadelphia, and Brooklyn. The Postmaster General is directed to make contracts for four years after advertising for them.

Appointments, Changes and Resignations.

Henry Watterson has declined the tender of an appointment as a member of the Board of Visitors to the United States Military Academy.

Jacob Riis of New York, says he will decline the position of governor of the Danish West Indies unless President Roosevelt strongly insists upon his acceptance.

Robert J. Wynne, the Washington correspondent of a New York paper, has been offered and has accepted the office of First Assistant Postmaster General.

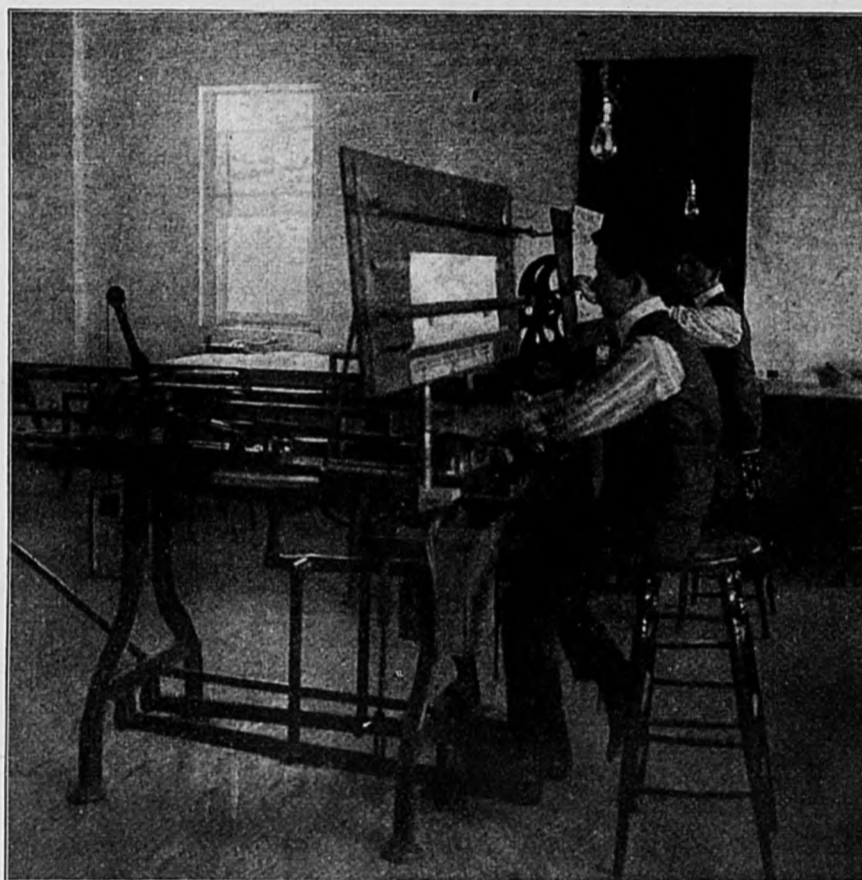

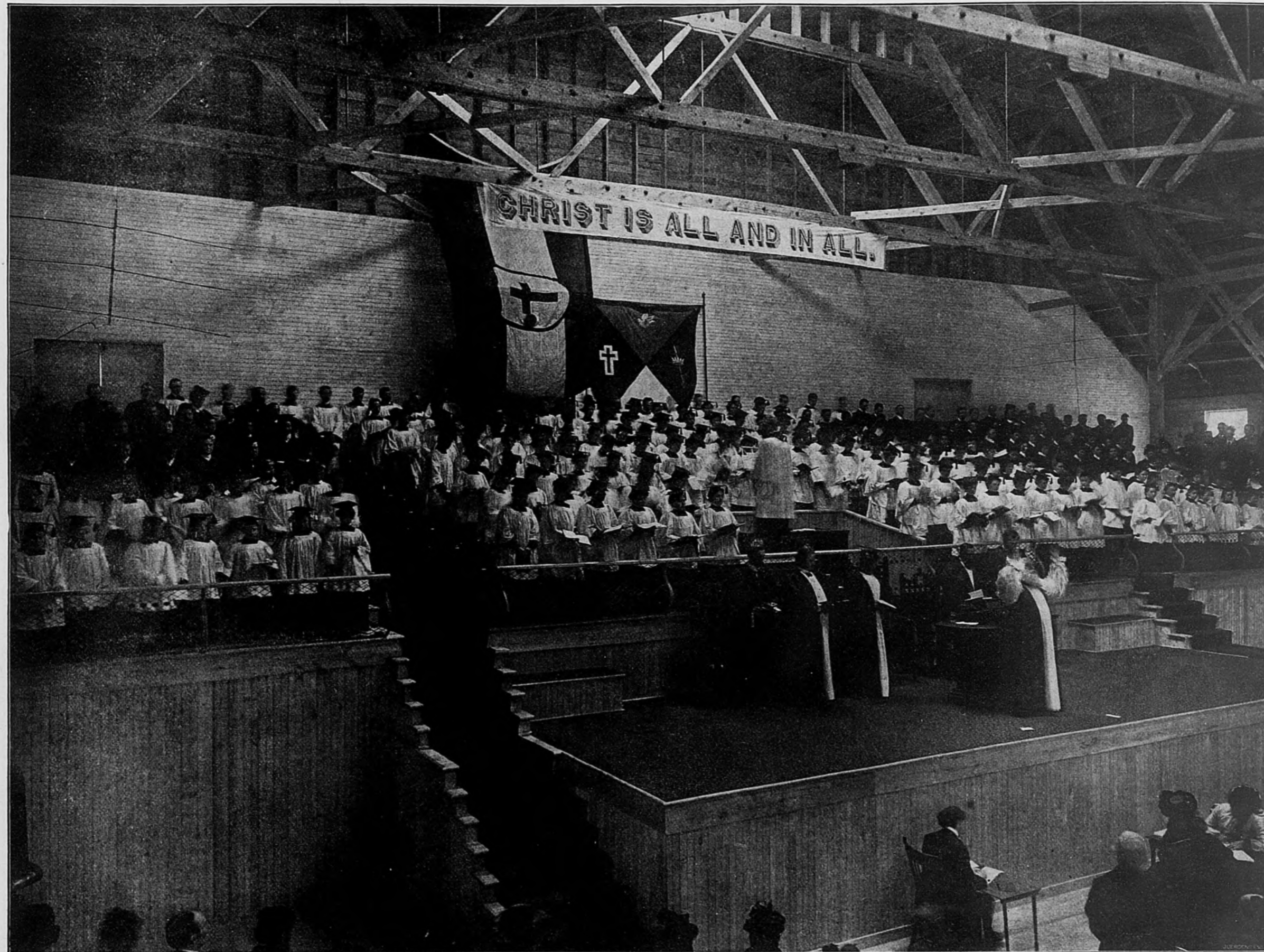

NEWS OF THE WEEK

CHICAGO.

Two men, whose names are unknown to the police, attacked Charles Kinnear and John Sellberg, metal polishers employed at the Stromberg-Carlson manufactory, as they were going home from work one evening last week. The attack was made on the Jackson Boulevard viaduct, just east of Canal Street, as Kinnear and Sellberg were in the act of passing the two strangers. One of them struck Kinnear with a "billy," missing him, and the other fired two shots from a revolver, one shot inflicting a flesh wound in Kinnear's left side. There was a brief struggle between the four men, which ended in the escape of the strangers. Scarcely five minutes after this fight, the Desplaines Street police were notified that Lars Hanson, another metal polisher, who lives in Evanston, had been shot in the right side, and that the shooting took place at the same place on the Jackson Boulevard viaduct. The police say that labor troubles are behind the shooting. There has been a strike among the metal polishers at the Stromberg-Carlson Company's plant, 72 Jackson Boulevard, and considerable bad feeling prevails.

That the Traction Company should run its street cars slowly in the neighborhood of public schools was stated in the verdict of the jury at an inquest over the remains of eight-year-old Sophia Kuhn at the Passavant Hospital. Patrons of the Ogden School, Pearson and State Streets, to which school the Kuhn girl was on her way when struck by a street car, are signing a petition to be presented to the Traction Company, and Coroner Traeger will ask Alderman Minwega to have the matter brought up before the City Council.

Boer sympathizers in Chicago were rejoicing during the week over what they understood to be a change of policy on the part of the United States Government. Their elation was founded on the fact that President Roosevelt had forwarded to

South Africa a check for \$5,000, representing money that had been collected by Governor Yates' Boer Relief Fund Committee to relieve the sufferings of women and children in the British reconcentrado camps.

That Governor Yates used the patronage of his office to secure the retention of A. B. Hostetter as Secretary of the Illinois Farmers' Institute was asserted at a meeting of editors of agricultural papers held at the Palmer House during the week. The matter was precipitated by the

in a general order issued by Chief O'Neill. They were the first three on the civil service eligible list and were notified by Mayor Harrison that they would be selected. 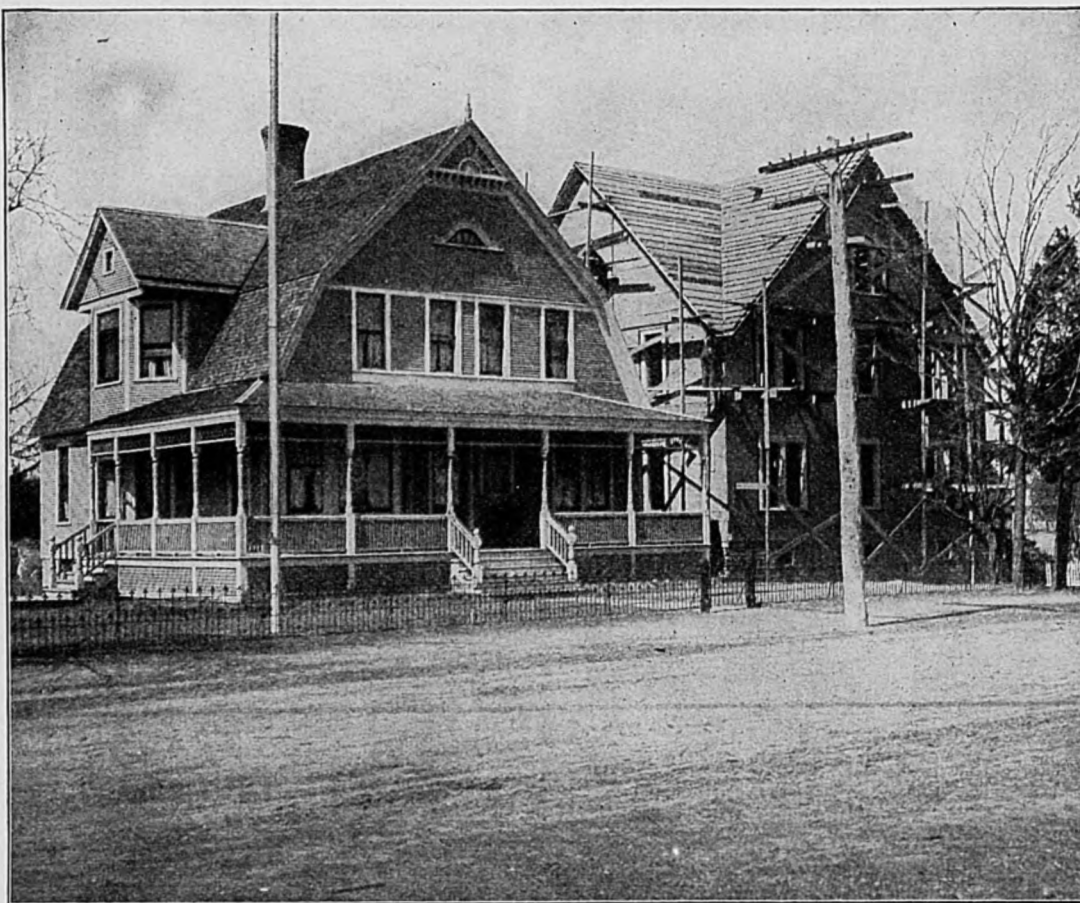

Five undertakers have been called to account by the City Health Department for permitting open

funerals for persons who have died of contagious diseases. The large number of scarlet fever cases reported each week has caused an investigation of the methods of undertakers, and it is believed that many times the disease has been spread by disregard of the city funeral ordinances.

Subcommittees for the ten Congressional Districts in Chicago have been authorized by the Committee on Political Action of the County Democracy. These subcommittees are to organize the Congressional Districts with a view of electing delegates to the State Convention, and thereby securing the election of the organization's candidates as members of the Democratic State Committee.

Captains Patrick J. Lavin, John Wheeler, and Alexander F. Campbell were officially announced as the new Inspectors of Police

and with no argument save force and numbers, the rank and file of the Hod-carriers and Building Laborers' Union, Local No. 4, representing 1600 men, ordered a strike on all the buildings they are helping to construct. The strike will involve over 6000 men.

The Renfost apartment building, Cottage Grove Avenue and Fifty-second Street, which was one of the finest World's Fair hotels, and valued at \$250,000, was destroyed by fire Friday, April 11. One fireman, Patrick McCormick, who sacrificed his regular holiday in his devotion to duty, was caught by the falling walls and crushed to death.

Forty-five manufacturers of and wholesale dealers in sash, doors, and window blinds, representing \$12,000,000 capital, are about to enter into a combination to establish a scale of prices on the products of the factories. The interested firms are situated in the larger cities from Pittsburg to the Rocky mountains.

The Drainage Board held a stormy meeting during the week and Engineer Randolph startled the trustees by his protest against political interference with his department. It is intimated that a reorganization of the department might be the result of the upheaval.

Ex-Judge John Barton Payne qualified himself for the next Democratic nomination for Mayor by joining the County Democracy. Mr. Payne sent in his name and five dollars, and was elected with great enthusiasm.

Della Mathews, a young woman patient at the County Hospital, plunged head-long from a third-story window and died a few hours later. She had escaped from bed while in a delirium, and eluded the nurses who sought to capture her. The accident was the second of a similar nature within a year.

Dime novels are said to have inspired two boys who were arrested last week by the police of the Lawndale Station. The prisoners are charged with numerous highway robberies and one burglary.

One of two men killed by railroad trains last week has not been identified. The body has been taken to Kenny's undertaking rooms at 5438 Halsted Street.

The receipts of the Chicago postoffice last month were \$889,750, an increase of

five per cent compared with March of last year.

UNITED STATES.

A petition with 3,000,000 signatures will be presented to Congress by the whisky interests of Kentucky, demanding a reduction in the tax, which is now \$1.10 a gallon. George C. Buchanan, one of the leaders in the movement, said: "Every branch of the distilled spirits industry has been organized for the avowed purpose of demanding the passage of certain bills now before Congress, including House Bill No. 178 to reduce the tax on distilled spirits."

Letters have been received from County Clerk Peter Valls, Sheriff and Tax Collec-

George T. Buckingham and Benjamin W. Brown, and Warden E. J. Murphy. In a letter sent from Springfield he notifies the Joliet people that he is certain of the absolute honesty of the officials and says he is satisfied they are performing their duties with integrity. He declares also that the Joliet committee evidently permitted itself to be influenced by persons with ulterior motives, in demanding the revocation of the prison labor contract with the Illinois Rattan Company, to make a new one with W. M. Cochrane, a dissatisfied bidder for the prison labor.

R. G. Dunn & Co.'s weekly review of trade for the past week says: "Good news predominates in the business world, notwithstanding two somewhat serious drawbacks. Weather conditions have been unsatisfactory at many points, retarding retail distribution and delaying outdoor work, while excessive rains have put many Southern planters behind with work in the cotton fields. Still more of a handicap is the strife between wage earners and employer. Manufacturing is exceptionally active in lines not disturbed by strikes, and there is a vigorous movement of goods through regular channels."

Authoritative announcement of a consolidation of the great hardware jobbing interests of the country in a combination capitalized at \$120,000,000 will be made by the *Iron Age*, the organ of the industry, in its current issue.

Lieutenant Governor Coates, at the invitation of the ministers of Denver, Colorado, addressed them on the subject, "The Workingman and the Church." The address aroused so great a storm of indignation that the Lieutenant Governor was compelled to leave the platform. The speaker arraigned the Church for what he declared to be its attitude against labor in favor of the rich.

Two secret service agents went to Lathrop, Missouri, and to the farm of Guyton & Harrington, where the horses and mules of the British Remount Commission are kept, and asked many questions. The work of buying mules and horses goes on. Several men are waiting to go with a shipment to New Orleans, and some of them will accompany the animals to South Africa.

By the terms of the will of Colonel John McKee, who died in Philadelphia, Pennsylvania, a few days ago, and was

County Clerk Valls says: "I cannot in words picture the misery, privations, and suffering afflicting our drought-stricken county. To say some families have one scant meal a day is expressing it mildly. While I cannot state positively that any people have actually died of starvation, I can say in all truth, and all the residents here will bear me out, that many have died who were sick who could have been easily saved if nourishment had been at hand."

accounted the richest negro in the United States, an estate valued at \$2,000,000 is left to Archbishop Ryan of the Archdiocese of Philadelphia as trustee. The will directs that the estate shall be used to build a Roman Catholic Church, rectory, and convent in McKee City, New Jersey, and to build and maintain a school for white and colored orphan boys.

Miss Ellen M. Stone, looking none the worse for her long captivity among bandits in Bulgaria, but tired from a week's seasickness, arrived in New York, April 10. "This is the happiest moment of my life," she said, as her brother, Charles A. Stone, greeted her soon after the vessel reached quarantine. Miss Stone will go to Chelsea, Massachusetts, to visit her mother.

Attacks on the jail and the J. I. Case Plow Works by a mob are feared as the result of the shooting of a union molder by a nonunion employee in Racine, Wisconsin, April 11. The shooting was the outcome of the lockout by the Case Company of its union molders, and union men of all trades are aroused over the affair.

Negroes and whites clashed in the tenderloin district in New York City, and in the battle that followed twelve or fifteen of the blacks were badly beaten. The cause of this race riot was the shooting of Holmes Easley, a young negro, by a bicycle policeman.

Flour, sugar, and salt are selling at three dollars a pound in the newly discovered Idaho gold fields of Thunder Mountain. There are now between 800 and 1000 men in the camp, and others are coming in at the rate of fifty per day. Sixty miles of the journey must be made on snow shoes. Snow is from three to fourteen feet deep.

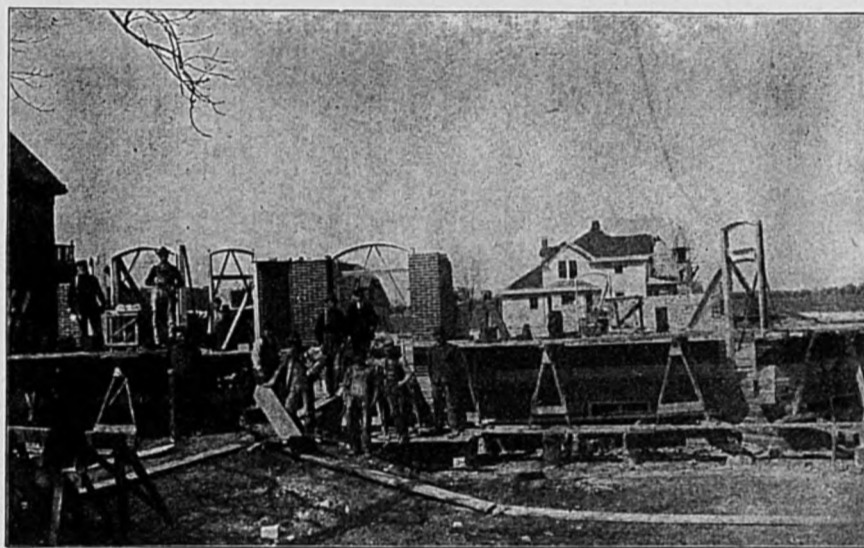
Two men were killed and three injured in a wreck of the Indianapolis special on the Big Four, west of Cleveland, Ohio, last week. The engineer and fireman, who were killed, were crushed under the overturned engine.

EUROPE.

The Boer bureau has issued a report, addressed by General Delarey to Mr. Kruger, alleging numerous atrocities by the British, and supporting the assertions with affidavits. The British are accused of placing Boer women around their camps to protect themselves. It is stated that several women were wantonly killed by the British. General Delarey complains that his own wife, persecuted by

Methuen's orders, has been wandering over the veldt, accompanied by her six children, for six months. Cattle belonging to his mother, who is eighty-three years old, were stolen and her home burned. The report alleges that Commandant Boshoff was fatally stabbed after being wounded. Three Boers who were captured were shot. Mrs. Van der Merwe was shot in the head at Groenfontein, and her house was burned while she lay wounded in an out-house.

Details of the two fights with the Boers on March 31—one at Doornbalt farm and the other near Boschman's Kop—received at Pretoria, proves the desperate valor of the fighting men on both sides. At Doornbalt farm the British had three officers and twenty-four men killed, and sixteen officers and 131 men wounded, while the Boers had 137 men killed or wounded. Two thousand Boers opened a strong attack from different points, with

three guns and a pompom. This attack was made at a moment when the British had left their luggage in a laager in charge of the Canadian contingent and were galloping across the open plain with the intention of capturing a Boer convoy which had been discovered five miles ahead. The British retired steadily, and, having dismounted, opened a return fusillade on the Boers.

Enrico Malatesta, the Italian Anarchist, has been sentenced by a court of justice to five months' imprisonment for contumacy on account of certain articles applauding the murder of President McKinley, which were written for and published in an Anarchist newspaper. Malatesta's friend, Sottovia, arrested on the same charge, was also sentenced to five months' imprisonment. Malatesta is credited with being the world leader of the Anarchists of America and Europe. For the last thirty years he has been concerned in the risings in Spain and Italy

and was active in the Barcelona bread riots, the trouble in Milan, and the peasant revolt in Sicily. He has been expelled from every country in Europe except England, and when he left New York he went to London.

The long drawn out fight at Toronto, Canada, over excluding United States contractors from civil work until the anti-Canadian labor and tariff laws of the States are altered has finally ended in the total defeat of those who supported the acceptance of the lowest tender irrespective of nationality. Stamsen & Blome of Chicago were the lowest tenderers two months ago for big pavement works. The city council by a vote of eighteen to six refused to accept United States tenders, passed a by-law excluding United States contractors and these ordinances were signed by the Mayor and are now law.

The Socialist demonstration against King Leopold at the railway station on April 9 developed into a mob, which held the streets of Brussels until after midnight. In the street fighting a number of rioters and police were shot. The mobs smashed windows, looted shops and cafés, extinguished street lights, and stoned houses. They were finally dispersed after midnight. The riots, the demonstration against the King, and the insistent demands of the Liberals, Radicals, and Socialists for universal suffrage have created so great a feeling of alarm for the safety of the Government that all divisions of the gendarmerie have been in readiness to march wherever they may be needed.

A cablegram from Brussels says that more than thirty persons, including women and children, were wounded in an encounter between rioters and police and that parts of Brussels are in a state of siege, the rioters having erected barricades which they are holding successfully. Over a hundred shots were fired from both sides. Women and children were wounded and they, together with the men injured, were taken into the Maison du Peuple.

The customs officials of Liverpool, acting under instruction from the Government, have visited the bonded warehouses and forbidden further deliveries of sugar, of which there are heavy stocks in store. This action is taken to indicate that there will be an increase in the sugar duties in the budget.

Twenty-one persons are dead as a result of the collapse of a grandstand at

Ibrox Park, Glasgow, during the international football match on Saturday last. Two hundred and fifty more were injured. Of this number 190 are yet in the hospitals. A large proportion of the injured had limbs broken, bodies crushed and mangled, and heads and faces gashed. Several more deaths will undoubtedly result from the most critical cases of fractured skulls.

A report from Copenhagen says the secret session of the Upper House has resulted in three reports. The majority report favored by thirty-five members defers the ratification of the treaty ceding the West Indian Islands to the United States until a vote can be taken on the islands by the qualified electors on property suffrage. These reports will be presented in open session and the two Houses will be forced to effect some compromise. Probably the final result will be the ratification of the treaty with a subsequent popular vote on the islands.

No official explanation has been made of the secret understanding between Lord Kitchener and acting President Schalk-Burger upon which the Boer leaders asked and received a safe conduct and facilities for reaching their companions in arms. The prevailing opinion among the members of Parliament is that a long step has been taken in the direction of peace, but that considerable time may be required for reaching the goal.

Lord Kimberley, the Liberal statesman, who had been ill for some time past, died April 8. He was born in 1826. He had been Minister Plenipotentiary at St. Petersburg, Lord Lieutenant of Ireland, Lord Privy Seal, Chancellor of the Duchy of Lancaster, twice Secretary of State for the Colonies, three times Secretary of State for India and Lord President of the Council, and Secretary of State for Foreign Affairs, 1894-95.

The Belgian Government has decided to proclaim martial law unless order is soon restored in Brussels. The strike is spreading. Over 1500 men are now out. A manifesto signed by the general council of the labor party has been widely posted. It demands a revision of the constitution and universal suffrage. Telegrams from the country districts indicate the widespread character of the movement.

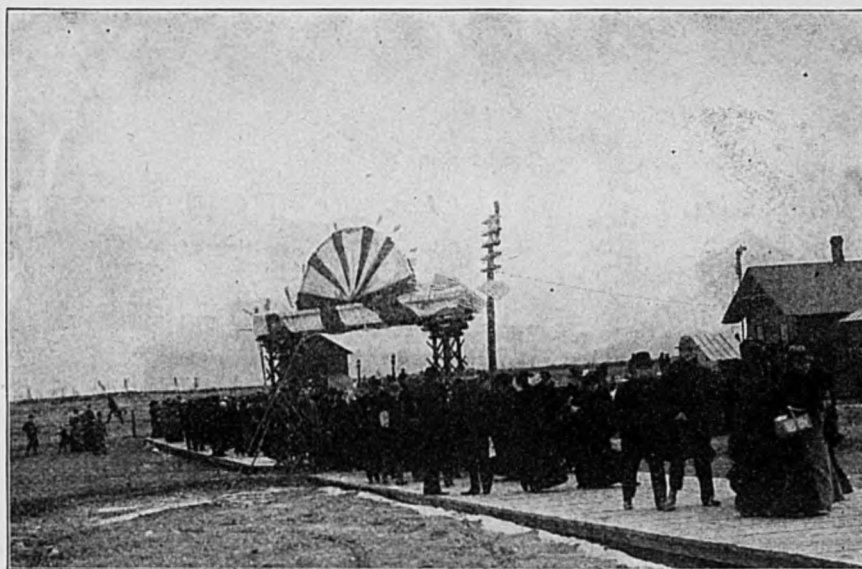
Mr. Balfour announced to the House of Commons last week that the budget for the coming financial year would be de-

layed. Not for a long number of years has the budget been postponed after the date of its introduction had been once fixed. A change in the order of public business is rendered necessary by the postponement of the financial proposals.

While President Loubet was driving to the Elysée Palace the morning of April 6, a man named Sojourne, carrying a revolver, approached his carriage and exclaimed: "I demand justice." Sojourne was immediately arrested. He appeared to be weak-minded.

It is said the Dominican Government has crushed the rebellion which broke out on the south coast recently. Several of the ringleaders escaped to Hayti. Others were made prisoners. The United States gunboat *Machias* has been withdrawn.

Diplomatic relations between Switzerland and Italy have been ruptured. This action arises from the refusal of Switzer-

land to give satisfaction regarding an article published in Geneva insulting the memory of the murdered King Humbert.

Secretary Hay will notify Germany in a few days that the United States looks with favor on its proposal for international control of wireless telegraphy.

The London *Financial News* says the loan of \$5,000,000 to be raised by Corea will be financed in the United States instead of Japan.

PHILIPPINES.

Colonel Espado, who surrendered and took the oath of allegiance in 1901, and later rejoined the insurgents, was recaptured recently. His trial resulted in his conviction, and he was sentenced to death, but his punishment has been commuted to imprisonment for life. This is the first important conviction under the treason law.

Three editors and managers of the *Freedom* newspaper have been arrested on

the charge of publishing a seditious attack on the Civil Government, which in the paper was accused of constituting a protectorate over a set of men who should be in jail or deported. It added that it was notorious that much of the Commission's Government was rotten and corrupt. Numerous other specifications are contained in the charges.

CHINA.

There is a rising threatened against the priests at Flox and Hochinfu, fifty miles from Tien-Tsin and the same distance from the Hunting Park, where the Emperor will shortly review 20,000 troops. The converts are uneasy everywhere. The demolition of the Taku forts will not be finished before June 15, and the restoration of Tien-Tsin is improbable before July.

The Manchurian convention was signed April 8. The ratification will take place three months from date. The Russians undertake to restore the Niu-Chwang and Shan-Hai-Kwan Railroad to the Chinese when the British relinquish control of the railway in Chee-Lee province. Sir Ernest Satow, the British minister, is, however, negotiating to secure a large preponderance of British administrative control in the latter railway after it is handed over to the Chinese.

The son of Yang-Yu, the former Chinese minister to Russia, died at St. Petersburg, April 5, and it is admitted that he committed suicide. The

deceased minister's son came to St. Petersburg to repatriate the body of his father, who died here February 17.

Good Bread.

Mr. Thomas R. Shirley, who for six years has made all the bread for Zion's institutions, has kindly consented to tell THE ZION BANNER readers just how he does it.

Mr. Shirley, who is an Englishman, began learning the art of good bread-making in England, and finished with the French chef, De Rayne.

Mr. Shirley turns out an average of 3000 loaves per week, yet he says it is just as easy to make half a dozen loaves, for a small family, of the same quality. This is the way:

WHOLE WHEAT BREAD.

Dissolve in two quarts of milk and two quarts of water, warm, a penny's worth of yeast, a tablespoonful of salt, one-half cup of sugar, and two table-

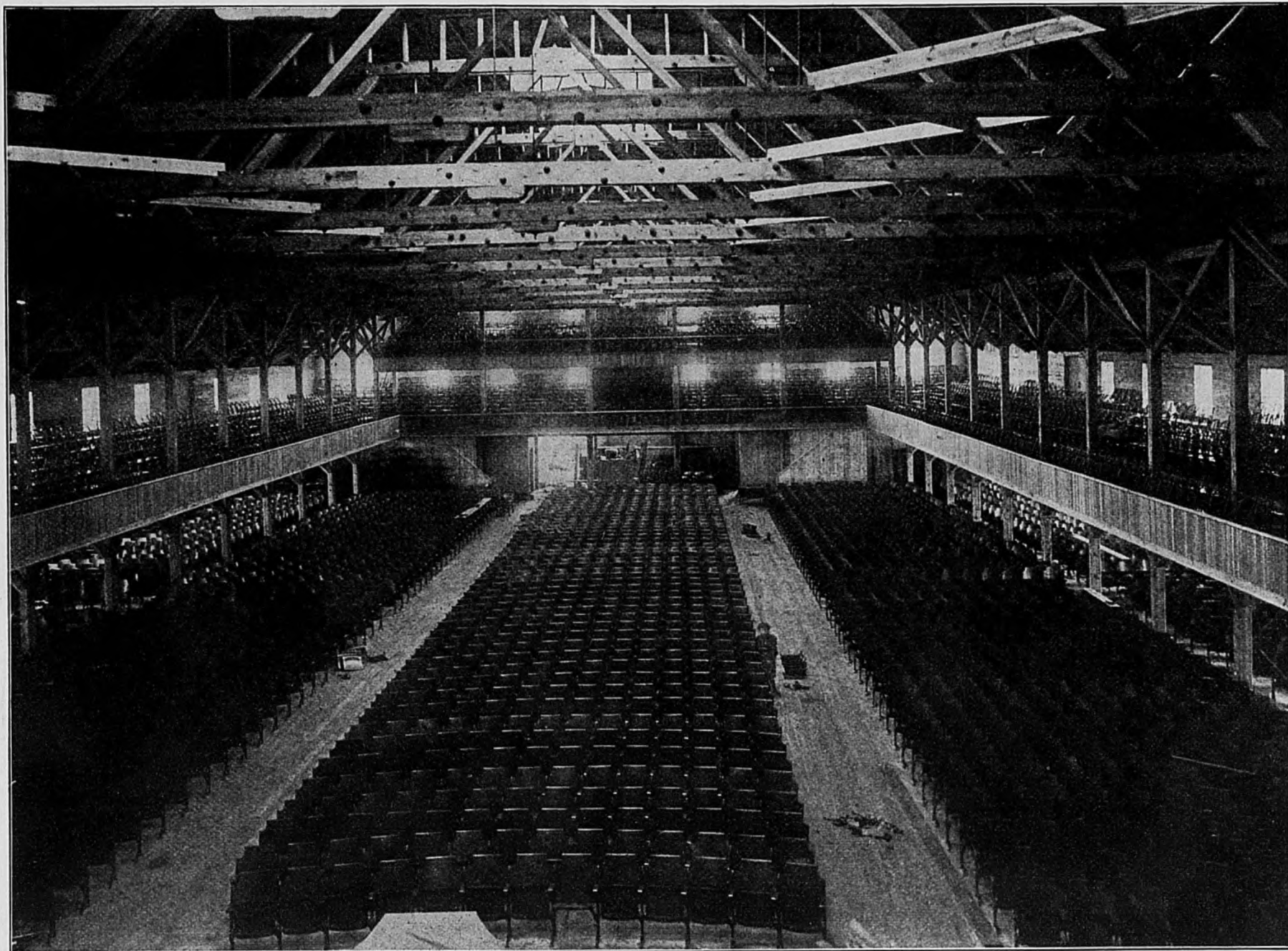
spoonfuls of cotosuet. Add one quart of white and two quarts of whole wheat flour. Break or work this all up with the fingers. Then set in a warm place. When risen, which should be in about two hours, work again, slowly, not mixing in too much flour. Avoid making the dough very stiff. Keep warm, and the second rising will be very quick. "Knock" down again, and mold into loaves, small pans being preferable to large ones. When risen again, bake for half an hour in

To make white bread, proceed in exactly the same manner, using all white flour, instead of the proportion of whole wheat flour.

Graham bread is made the same way, using one-third white and two-thirds Graham flour.

Do not grease the top of the bread, but grease the pans before the bread is put in them. Keep the bread while rising covered with a thick, warm cloth. This is to keep out the air, as a change in tempera-

a well-heated oven. The secret is in having fresh yeast, making the bread in a few hours, instead of letting the dough stand over night, and in keeping it warm. Too much working tends to make sour bread. It should be baked with a good, brown crust on it.

TO MAKE COTOSUET.

The cotosuet used is very simply made, and is the most healthful fat for cooking purposes.

To one quart of rendered beef suet add one pint of cottonseed oil; mix while warm, strain, let it get cold, and it is ready for use.

ture always affects the bread unfavorably.

When the bread is baked, turn out of the pans and stand the loaves on end until quite cool. Then wrap in a clean cloth and keep in a crock or wooden box. If put away while warm, the bread will soon sweat, and become moldy. Kept properly, bread should be moist and good after a week's baking.

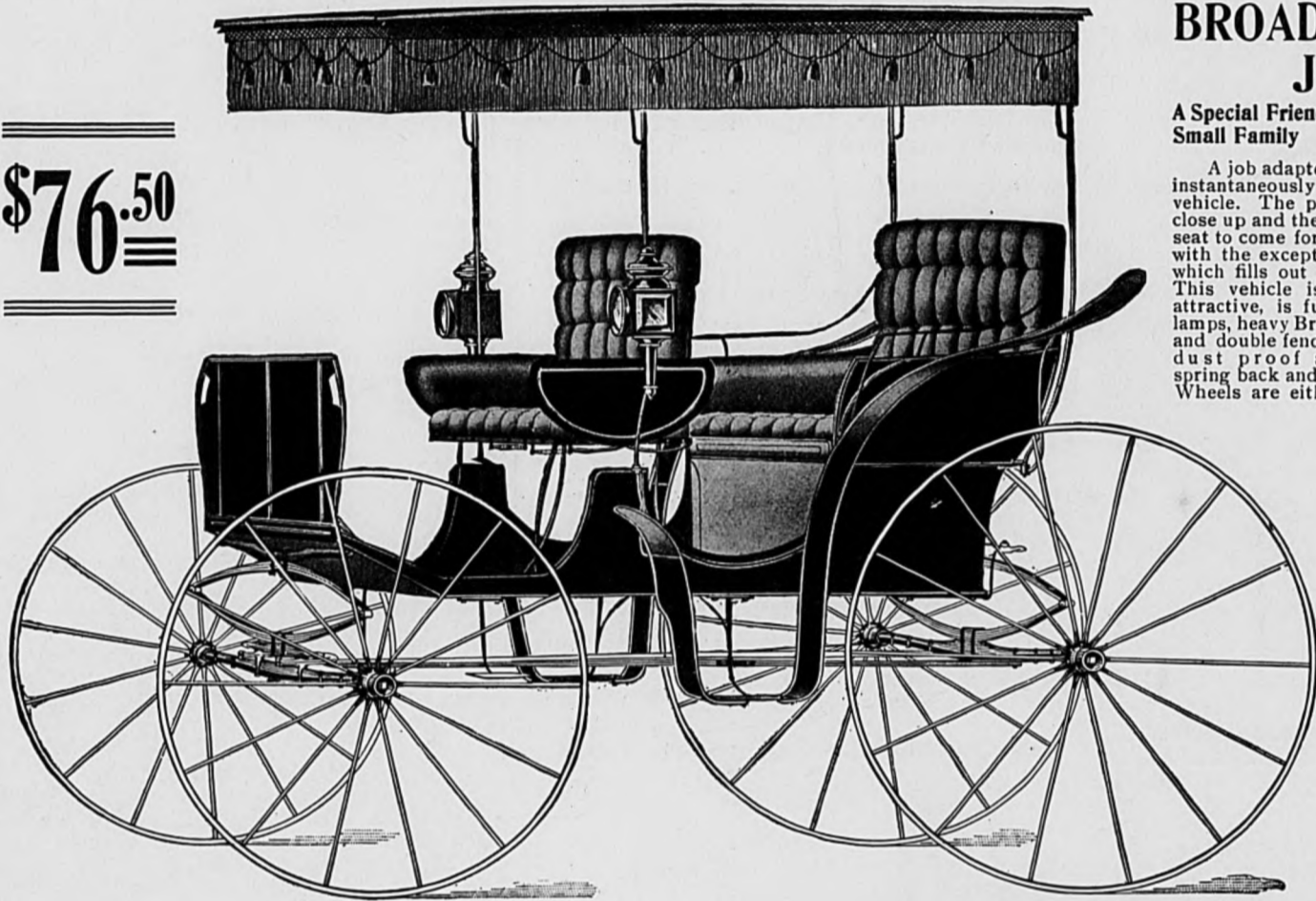
